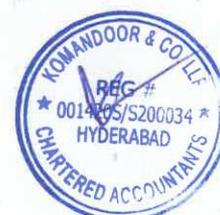

**INDEPENDENT AUDITORS' REVIEW REPORT ON THE STANDALONE UNAUDITED FINANCIAL RESULTS OF
INDIAN OIL CORPORATION LIMITED FOR QUARTER AND NINE MONTHS ENDED 31 DECEMBER 2025**

Review Report to
The Board of Directors
Indian Oil Corporation Limited
New Delhi

1. We have reviewed the accompanying statement of Standalone Unaudited Financial Results of **Indian Oil Corporation Limited** ("the Company") for the quarter and nine months ended 31 December 2025 ("the Statement") attached herewith, prepared by the Company pursuant to the requirements of Regulation 33 and Regulation 52 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended (the "Listing Regulations"), except for the disclosures regarding (i) Physical Performance (in MMT) stated in the Statement and (ii) Average Gross Refinery Margin stated in note no. 3 to the Statement, both of which have been traced from the representation made by the management.
2. This Statement, which is the responsibility of the Company's Management and approved by the Company's Board of Directors in their meeting held on 5 February 2026, has been prepared in accordance with the recognition and measurement principles laid down in Indian Accounting Standard 34 ("Ind AS 34") "Interim Financial Reporting" prescribed under Section 133 of the Companies Act, 2013 as amended, read with relevant rules issued thereunder and other accounting principles generally accepted in India. Our responsibility is to express a conclusion on the Statement based on our review.
3. We conducted our review of the Statement in accordance with the Standard on Review Engagements (SRE) 2410 "Review of Interim Financial Information Performed by the Independent Auditor of the Entity", issued by the Institute of Chartered Accountants of India. This standard requires that we plan and perform the review to obtain moderate assurance as to whether the Statement is free of material misstatement. A review of interim financial information consists of making inquiries, primarily of persons responsible for financial and accounting matters, and applying analytical and other review procedures. A review is substantially less in scope than an audit conducted in accordance with Standards on Auditing specified under Section 143 (10) of the Companies Act, 2013 and consequently does not enable us to obtain assurance that we would become aware of all significant matters that might be identified in an audit. Accordingly, we do not express an audit opinion.



4. Based on our review conducted as above, nothing has come to our attention that causes us to believe that the accompanying Statement prepared in accordance with applicable Indian Accounting Standards (Ind AS) and other recognized accounting practices and policies has not disclosed the information required to be disclosed in terms of the Regulation 33 and 52 of the Listing Regulations, including the manner in which it is to be disclosed, or that it contains any material misstatement.

Other Matters

5. The Statement includes interim financial results/information of 24 joint operations where Company is not an operator (out of which 8 blocks are relinquished), whose results reflect total revenues of ₹ 49.26 crore and ₹ 145.04 crore, total net profit/(loss) before tax of ₹ 38.50 crore and ₹ (332.86) crore for the quarter and nine months ended 31 December 2025 respectively which have not been reviewed by their auditors. These interim financial results / information are considered based on the statement from the Company's management. Our conclusion is solely based on these management certified information. According to the information and explanations given to us, these interim financial results / information are not material to the Company.

Our conclusion on the Statement is not modified in respect of the above matter.

Notes to Standalone Unaudited Financial Results:

- 1) The above results have been reviewed and recommended by the Audit Committee in its meeting held on 4th February 2026 and approved by the Board of Directors in its meeting held on 5th February 2026.
- 2) The Financial Results have been reviewed by the Statutory Auditors as required under Regulation 33 and Regulation 52 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended.
- 3) Average Gross Refining Margin (GRM) for the period April - December 2025 is **\$8.41 per bbl** (April - December 2024: \$3.69 per bbl). The core GRM or the current price GRM for the period April - December 2025 after offsetting inventory loss/ gain comes to **\$9.86 per bbl**.
- 4) For computing Earnings Per Share, shares held under "IOC Shares Trust" of face value ₹349.68 crore has been excluded from Paid-up Equity Share Capital.
- 5) The Ministry of Petroleum and Natural Gas (MoP&NG), vide letter dated 30th April 2020 had conveyed to Oil Marketing Companies (OMCs) that where Market Determined Price (MDP) of LPG cylinders is less than its Effective Cost to Customer, the OMCs will retain the difference in a separate buffer account for future adjustment. However, as on 31st December 2025, the Company had a cumulative net negative buffer of ₹24,318.60 Crore.

MoP&NG, vide letters dated 3rd and 24th October 2025, has conveyed Government's approval for compensation of ₹14,486 crore to the Company, towards under-recoveries incurred on sale of domestic LPG up to 31.03.2025 and likely to be incurred up to 31.03.2026 and it will be disbursed in 12 equal monthly instalments, the accrual of which shall only be on monthly basis starting from November 2025 and thereafter will be disbursed accordingly.

In accordance with the letters, instalment for Nov'25 & Dec'25 aggregating to ₹2,414.34 crore has been recognised as Revenue from Operations in the books of account and the cumulative net negative buffer has been reduced to that extent.

- 6) The Government of India has notified four Labour Codes - namely the Code on Wages, 2019, the Industrial Relations Code, 2020, the Code on Social Security, 2020 and the Occupational Safety, Health and Working Conditions Code, 2020 - with effect from 21st November 2025, which consolidates 29 existing labour laws. The Ministry of Labour & Employment has published draft Central Rules and FAQs on these codes, but the relevant rules are yet to be notified. Based on the available information as at reporting date, no material liability is envisaged in this regard. Financial impact will be reviewed once the relevant rules are notified.
- 7) Consequent to the favourable orders from Hon'ble Supreme Court and Gujarat VAT Tribunal on the subject of VAT Input Tax Credit under Gujarat VAT Act 2005, provision created in earlier years were reversed during the relevant period in the previous year and the same was disclosed as an Exceptional Item.
- 8) Figures relating to the previous periods have been regrouped wherever necessary to conform to the figures of the current period.

We have reviewed the accompanying Statement of Consolidated Unaudited Financial Results of **Indian Oil Corporation Limited** ("the Holding Company"), its Subsidiaries (the Holding Company and its Subsidiaries together referred to as "the Group"), and its share of the net profit / (Loss) after tax and total comprehensive income of its associates and joint ventures for the quarter and nine months ended 31 December 2025 ("the Statement"), prepared by the Holding Company pursuant to the requirement of Regulation 33 and Regulation 52 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended (the "Listing Regulations").
2. This Statement which is the responsibility of the Holding Company's Management and approved by the Holding Company's Board of Directors in their meeting held on 5 February 2026, has been prepared in accordance with the recognition and measurement principles laid down in Indian Accounting Standard 34 ("Ind AS 34") "Interim Financial Reporting" prescribed under Section 133 of the Companies Act, 2013 as amended, read with relevant rules issued thereunder and other accounting principles generally accepted in India. Our responsibility is to express a conclusion on the Statement based on our review.
3. We conducted our review of the Statement in accordance with the Standard on Review Engagements (SRE) 2410 "Review of Interim Financial Information Performed by the Independent Auditor of the Entity", issued by the Institute of Chartered Accountants of India. This standard requires that we plan and perform the review to obtain moderate assurance as to whether the Statement is free of material misstatement. A review of interim financial information consists of making inquiries, primarily of Holding Company's persons responsible for financial and accounting matters, and applying analytical and other review procedures. A review is substantially less in scope than an audit conducted in accordance with Standards on Auditing specified under Section 143 (10) of the Companies Act, 2013 and consequently does not enable us to obtain assurance that we would become aware of all significant matters that might be identified in an audit. Accordingly, we do not express an audit opinion.

We also performed procedures in accordance with the circular issued by the SEBI under Regulation 33 (8) of the Listing Regulations, to the extent applicable.



4. The Statement includes the results of entities listed in Annexure - I.
5. Based on our review conducted and procedures performed as stated in paragraph 3 above and based on the consideration of the reports of other auditors referred to in paragraph 6 below and Management certified Financial Statements referred in Paragraph 7, nothing has come to our attention that causes us to believe that the accompanying Statement, prepared in accordance with the recognition and measurement principles laid down in the applicable Indian Accounting Standards and other accounting principles generally accepted in India, has not disclosed the information required to be disclosed in terms of the Regulation 33 and 52 of the Listing Regulations, including the manner in which it is to be disclosed, or that it contains any material misstatement.

Other Matters

6. We did not review the interim financial results in respect of 1 subsidiary, whose interim financial results reflect total revenue of ₹ 19,467.40 crore and ₹ 58,200.00 crore, total net profit of ₹ 1,001.59 crore and ₹ 1,680.85 crore and total comprehensive income of ₹ 1,005.50 crore and ₹ 1,699.51 crore for the quarter and nine months ended 31 December 2025 respectively, as considered in the Statement. These interim financial results have been audited by other auditors, whose reports have been furnished to us by the Management of the Holding Company.

The Statement also include the Group's share of total net profit of ₹ 285.38 crore and ₹ 611.06 crore, total comprehensive income of ₹ 285.35 crore and ₹ 611.18 crore for the quarter and nine months ended 31 December 2025 respectively in respect of 1 Joint Venture, based on its interim financial results, which have not been reviewed by us. The interim financial results have been reviewed by other auditors, whose reports have been furnished to us by the Management of the Holding Company.

Our conclusion on the Statement, in so far as it relates to the amounts and disclosures included in respect of these Subsidiary and Joint Venture is based solely on the report of the other auditors and the procedures performed by us as stated in paragraph 3 above.

7. The Statement includes the interim financial results / information of 10 Subsidiaries, which have not been reviewed by their auditors, whose interim financial results / information reflect total revenue of ₹ 3,975.41 crore and ₹ 10,588.57 crore, total net profit of ₹ 77.53 crore and ₹ 1,525.13 crore and total comprehensive income of ₹ 485.32 crore and ₹ 2,568.36 crore for the quarter and nine months ended 31 December 2025 respectively. The Statement also include the Group's share of total net profit of ₹ 192.05 crore and ₹ 570.33 crore and total comprehensive income of ₹ 191.05 crore and ₹ 569.85 crore for the quarter and nine months ended 31 December 2025 respectively, in respect of 3 Associates and 26 Joint Ventures, based on their interim financial results / information, which have not been reviewed by their auditors. These interim financial results / information are as certified / provided by the management of the Subsidiaries/ Associates/ Joint Ventures.

Further, the financial results and other financial information of 7 subsidiaries (out of the 10 subsidiaries stated above) located outside India have been prepared according to the accounting principles generally accepted in their respective countries and have been certified by their respective managements. The Holding Company's management has converted these financial results from the local accounting principles



to those generally accepted in India. We have reviewed these conversion adjustments made by the Holding Company's management. Our conclusion, with respect to the balances and operations of these foreign subsidiaries, is based on the certificates provided by their respective managements and the conversion adjustments prepared by the Holding Company's management and reviewed by us.

The Statement also includes Group's proportionate share, in the jointly controlled 24 joint operations where Group is not an operator (out of which 8 blocks are relinquished); whose results reflect total revenues of ₹ 49.26 crore and ₹ 145.04 crore, total net profit / (loss) before tax of ₹ 38.50 crore and ₹ (332.86) crore for the quarter and nine months ended 31 December 2025 respectively which have not been reviewed by their auditors. These interim financial results / information are considered based on the statement from the Holding Company's management.

According to the information and explanations given to us by the Management of the Holding Company, these interim financial results / information are not material to the Group.

Our conclusion on the Statement is not modified in respect of the above matters.

Notes to Consolidated Unaudited Financial Results:

- 1) The above results have been reviewed and recommended by the Audit Committee in its meeting held on 4th February 2026 and approved by the Board of Directors in its meeting held on 5th February 2026.
- 2) The Financial Results have been reviewed by the Statutory Auditors as required under Regulation 33 and Regulation 52 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended.
- 3) For computing Earnings Per Share, shares held under "IOC Shares Trust" of face value ₹349.68 crore has been excluded from Paid-up Equity Share Capital.
- 4) The Ministry of Petroleum and Natural Gas (MoP&NG), vide letter dated 30th April 2020 had conveyed to Oil Marketing Companies (OMCs) that where Market Determined Price (MDP) of LPG cylinders is less than its Effective Cost to Customer, the OMCs will retain the difference in a separate buffer account for future adjustment. However, as on 31st December 2025, the Holding Company had a cumulative net negative buffer of ₹24,318.60 Crore.

MoP&NG, vide letters dated 3rd and 24th October 2025, has conveyed Government's approval for compensation of ₹14,486 crore to the Holding Company, towards under-recoveries incurred on sale of domestic LPG up to 31.03.2025 and likely to be incurred up to 31.03.2026 and it will be disbursed in 12 equal monthly instalments, the accrual of which shall only be on monthly basis starting from November 2025 and thereafter will be disbursed accordingly.

In accordance with the letters, instalment for Nov'25 & Dec'25 aggregating to ₹2,414.34 crore has been recognised as Revenue from Operations in the books of account of Holding Company and the cumulative net negative buffer has been reduced to that extent.

- 5) The Government of India has notified four Labour Codes - namely the Code on Wages, 2019, the Industrial Relations Code, 2020, the Code on Social Security, 2020 and the Occupational Safety, Health and Working Conditions Code, 2020 - with effect from 21st November 2025, which consolidates 29 existing labour laws. The Ministry of Labour & Employment has published draft Central Rules and FAQs on these codes, but the relevant rules are yet to be notified. Based on the available information as at reporting date, no material liability is envisaged in this regard. Financial impact will be reviewed once the relevant rules are notified.
- 6) Consequent to the favourable orders from Hon'ble Supreme Court and Gujarat VAT Tribunal on the subject of VAT Input Tax Credit under Gujarat VAT Act 2005, provision created in earlier years in the books of Holding Company were reversed during the relevant period in previous year and the same was disclosed as an Exceptional Item.
- 7) Figures relating to the previous periods have been regrouped wherever necessary to conform to the figures of the current period.

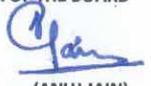
