Mahindra Auto sells 56,331 SUVs, a growth of 8% and total volumes of 94,627, a growth of 14% in April 2026

Mumbai, May 01, 2026: Mahindra & Mahindra Ltd. (M&M Ltd.), one of India’s leading automotive companies, today announced that its overall auto sales for the month of April 2026 stood at **94,627** vehicles, a growth of **14%**, including exports.

In the Utility Vehicles segment, Mahindra sold **56,331** vehicles in the domestic market, a growth of **8%** and overall, **57,833** vehicles, including exports. The domestic sales for Commercial Vehicles stood at **23,427**.

According to **Nalinikanth Gollagunta, CEO, Automotive Division, M&M Ltd.**, “*The year 2027 has begun on a positive note in April by achieving SUV sales of 56331 units, a growth of 8% and total vehicle sales of 94627 units, a 14% growth over the same month last year.*”

Mahindra Farm Equipment Business sells 46,404 Tractors in April 2026 registering a growth of 20%

Mumbai, May 01, 2026: Mahindra & Mahindra Ltd.'s Farm Equipment Business (FEB), part of the Mahindra Group, today announced its tractor sales numbers for April 2026.

Domestic sales in April 2026 were at **46,404** units, as against **38,516** units in April 2025, reflecting a **20%** year-on-year growth.

Total tractor sales (Domestic + Exports) during April 2026 were at **48,411** units, as against **40,054** units for the same period last year. Exports for the month stood at **2,007** units.

Commenting on the performance, **Veejay Nakra, President – Farm Equipment Business, Mahindra & Mahindra Ltd.** said *“We have sold 46,404 tractors in the domestic market during April 2026 registering a growth of 20% over last year. This strong performance was delivered despite the absence of Chaitra Navratri in April this year, unlike last year when April included seven Navratri days. In the export markets, we have sold 2,007 tractors, a growth of 30% over last year.”*

Mumbai, May 1, 2026: Mahindra & Mahindra Ltd. (M&M Ltd.), today announced that its overall sales including exports in the Trucks and Buses business (CV > 3.5T) for the month of April 2026 stood at 3011 vehicles, a y-o-y growth of 11%.

According to **Vinod Sahay, Executive Chairman – SML, President – Aerospace, Advanced Technologies, Trucks, Buses & CE, M&M**, “The CV industry experienced moderation in April due to the fiscal year transition, inflationary pressures, and heightened geo-political uncertainties.
