Mahindra Auto clocks 60,048 SUVs, a growth of 20% and **1,03,860 total vehicle sales**, a growth of 26% in July 2026

Mumbai, August 01, 2026: Mahindra & Mahindra Ltd. (M&M Ltd.), one of India's leading automotive companies, today announced that its overall auto sales for the month of July 2026 stood at **1,03,860** vehicles, a growth of **26%** including exports.

In the Utility Vehicles segment, Mahindra sold **60,048** vehicles in the domestic market, a growth of **20%** and overall, **60,887** vehicles, including exports. The domestic sales for Commercial Vehicles stood at **25,204**, a growth of **23%**.

According to **Nalinikanth Gollagunta, CEO, Automotive Division, M&M Ltd.**, *"In July we achieved SUV sales of 60048 units delivering growth of 20%. The total vehicle sales stood at 103860, a 26% YoY growth reflecting all-round demand traction across the portfolio."*

Mahindra Farm Equipment Business sells 32,643 Tractors in July 2026 registering a growth of 21%

Mumbai, August 01, 2026: Mahindra & Mahindra Ltd.'s Farm Equipment Business, part of the Mahindra Group, today announced its tractor sales numbers for July, 2026.

Domestic sales in July 2026 were at **32,643** units, as against **26,990** units in July 2025, reflecting a **21%** year-on-year growth.

Total tractor sales (Domestic + Exports) during July 2026 were at **34,420** units, as against **28,708** units for the same period last year. Exports for the month stood at **1,777** units.

Commenting on the performance, **Veejay Nakra, President – Farm Equipment Business, Mahindra & Mahindra Ltd.** said *“We have sold 32,643 tractors in the domestic market during July 2026 registering a growth of 21% over last year.
