









Gift of Life from Mother: Saving a Child with Liver Failure – Rainbow Bangalore's First Liver Transplant

- An 11-year-old child was born with biliary atresia, a serious condition in which the bile ducts are absent.
- As an infant, the child underwent a Kasai surgery at another hospital in an attempt to restore bile flow. Although there was an improvement for a few years, the liver continued to fail over time and was referred to Rainbow Children's Hospital, Marathahalli
- The child continued to progress to end stage liver disease where liver transplant is the only option for survival.
- After detailed evaluation, the mother's liver found to be appropriate for liver donation.
- Our liver transplant team performed living related Liver Transplant, using left lobe from the mother.
- The new liver began functioning well, and the child made a steady recovery. Today, the child is stable and thriving, with a second chance at life — **made possible by a mother's sacrifice and the advanced transplant care at Rainbow.**

A Battle Beneath the Surface: Saving a Child from a Recurrent Facial benign Tumor

- An 11-year-old child from Africa came to us with a feeling of heaviness on the right side of the face and a bulging of the right eye. There was no pain, no fever, no redness, and no bleeding from the nose or mouth.
- The child had a history of a similar problem before and had already undergone surgery at the age of 10. Because the swelling came back, two more surgeries had been done within a few months.
- On examination, the right eye was pushed forward and the right side of the face looked swollen. The swelling was firm but not painful. New scans and tests were done, and doctors considered a few possible bone-related tumors of the upper jaw.
- A team of specialists—including pediatric surgeons, dental surgeons, ENT doctors, radiologists, anesthetists, and eye specialists—discussed the case together. They decided that the best treatment was to remove the growth completely through open surgery.
- The surgery was done successfully. The extracted tumor histologically showed benign nature.
- After the operation, the child was kept in the intensive care unit for one day for close monitoring. The next day, the nasal packing was removed. Liquids were started by mouth on the second day, and the child was then shifted to the regular ward.
- Recovery went well, and the child was discharged on the fifth day after surgery, eating normally and in stable condition.



Deciphering Prader-Willi Syndrome - A rare genetic disorder in a neonate

- A 22-day-old newborn, born late preterm, was referred with persistent poor feeding, reduced activity, and excessive sleepiness since birth.
- The baby had a difficult neonatal course with brief breathing problems requiring CPAP support.
- On examination, the infant had generalized hypotonia (a “floppy” baby), along with subtle facial differences and differences in eye pigmentation. Initial brain imaging, including ultrasound and MRI, did not show any structural abnormality, making the cause of the central hypotonia unclear.
- In view of the ongoing feeding difficulty and low muscle tone, a detailed metabolic and genetic evaluation was undertaken. Rapid whole genome sequencing confirmed a **diagnosis of Prader-Willi syndrome, a rare genetic disorder affecting muscle tone, feeding, growth, and later development.**
- The newborn was started on assisted feeding methods, physiotherapy, and oromotor stimulation. Plans have been made for long-term follow-up and early initiation of growth hormone therapy, which can significantly improve muscle strength, growth, and overall outcomes.
- This case highlights the importance of considering **Prader-Willi syndrome in any preterm or term neonate with persistent hypotonia and feeding difficulty**, as early genetic diagnosis allows timely intervention and better long-term prognosis.
