Tata Motors registered 37% growth YoY with total sales of 39,641 commercial vehicle units in July 2026

Mumbai, 1 August 2026: Tata Motors Limited sales in the domestic & international markets for July 2026 stood at 39,641 units, compared to 28,956 units during July 2025, up 37% YoY.
