### CPCL'S FINANCIAL PERFORMANCE FOR THE QUARTER ENDED 31.03.2026

#### SUSTAINED OPERATIONAL EXCELLENCE

CPCL delivered outstanding operational results during Q4 FY2025–26, achieving a crude throughput of 2.93 million metric tonnes (MMT), compared to 2.97 MMT in the corresponding quarter of the previous financial year. This translates to a capacity utilisation of 112%, underscoring efficient plant operations and high reliability.

For the year ended March 31, 2026, crude throughput stood at 11.71 MMT, as against 10.45 MMT in the same period last year, maintaining a capacity utilisation of 112%. The Company continued to maintain its best-ever distillate yield of about 80% achieved during the year, underscoring its operational excellence and sustained focus on energy efficiency.

#### FINANCIAL PERFORMANCE

The Company's financial results for the quarter reflected the robust physical performance and improved refining margins.

For the quarter ended March 31, 2026, Revenue from Operations stood at ₹ 20,455 crore, compared to ₹ 20,581 crore in the corresponding period last year. The Company reported a Profit Before Tax (PBT) of ₹ 1890 crore and a Profit After Tax (PAT) of ₹ 1400 crore, as against a Profit Before Tax of ₹ 582 crore and Profit After Tax of ₹ 450 crore during the same quarter last year.

For the year ended March 31, 2026, Revenue from Operations stood at ₹ 78,611 crore, compared to ₹ 71,050 crore in the previous year. The Company reported a Profit Before Tax of ₹ 4122 crore and a Profit After Tax of ₹ 3062 crore, as against Profit Before Tax of ₹ 208 crore and Profit After Tax of ₹ 174 crore in the corresponding period of the previous financial year.

The Gross Refining Margin (GRM) for the quarter improved to US\$ 13.75 per barrel, as against a US\$ 6.22 per barrel in the same period last year. For the year ended, the GRM stood at US\$ 9.28 per barrel, compared to a US\$ 4.22 per barrel in the previous year.

On a consolidated basis, for the year ended March 31, 2026, CPCL recorded a Profit After Tax of ₹ 3103 crore, and for the quarter ended March 31, 2026, CPCL recorded a Profit After Tax of ₹ 1422 crore.

The board has recommended a final dividend of ₹ 54 per share with face value of ₹ 10 per share in addition to an Interim dividend of ₹ 8 per share declared during the year.
