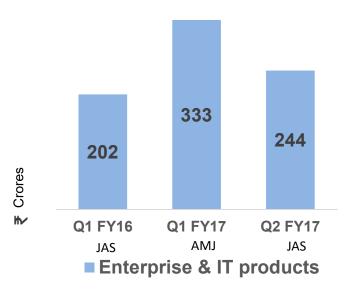

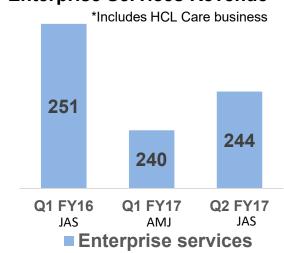

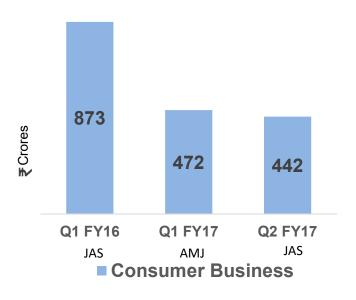

Consumer Business — Consumer Distribution (1/2)

- 6% Q-o-Q revenue decline
 - Feature phones segment witnessed good demand, however was constrained by short supplies and portfolio decisions of Principal
 - Widened distribution reach of Surface products –
 Expanded into General Trade Channel as well
 - Change in Principal Partner Ecosystem made this quarter muted and we expect this to be muted over the next few quarters, until we realign the portfolio

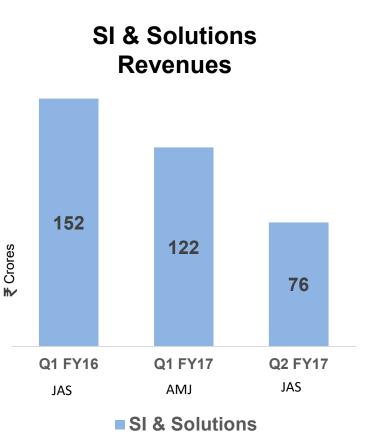
