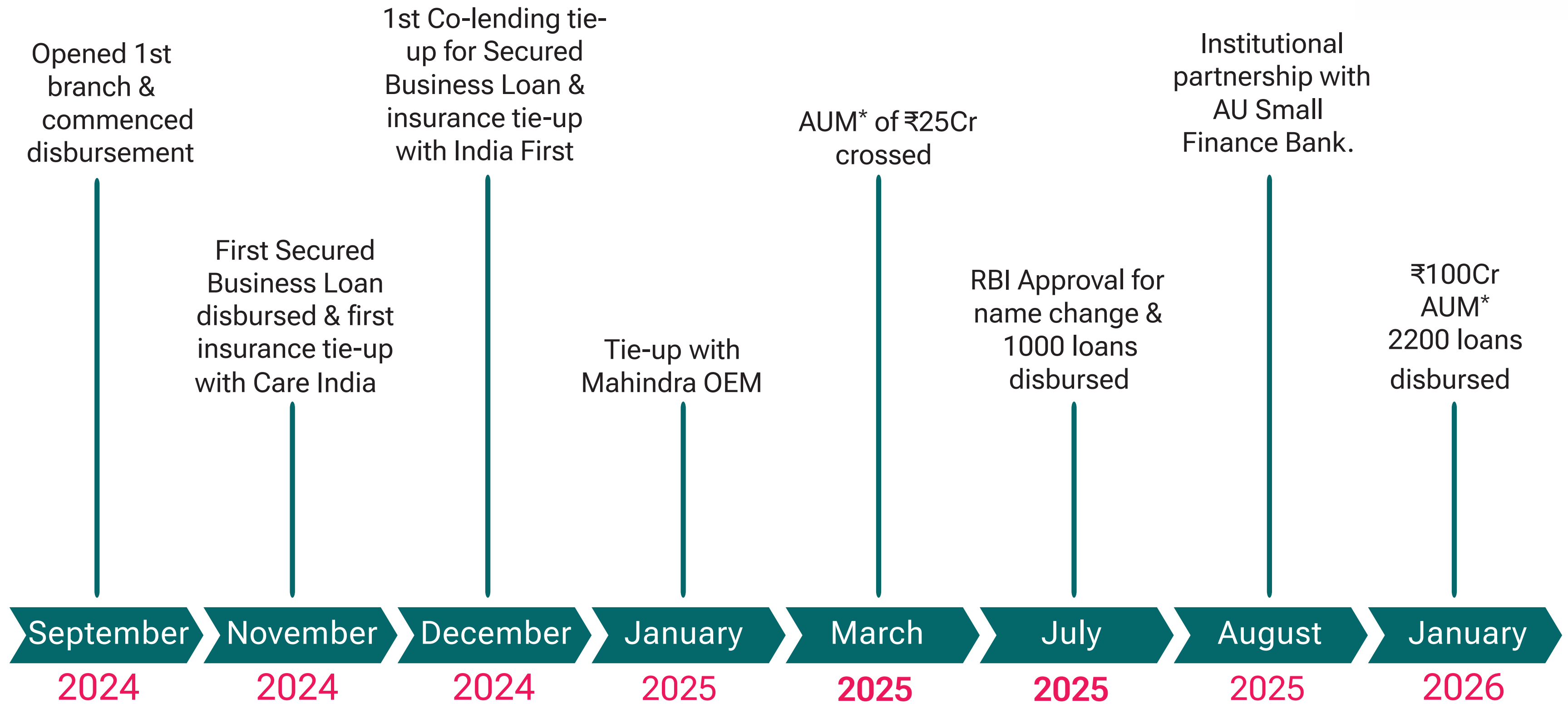

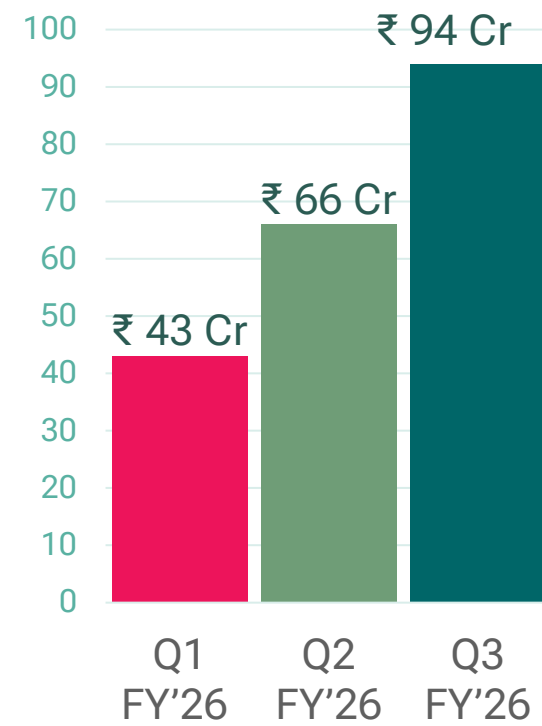

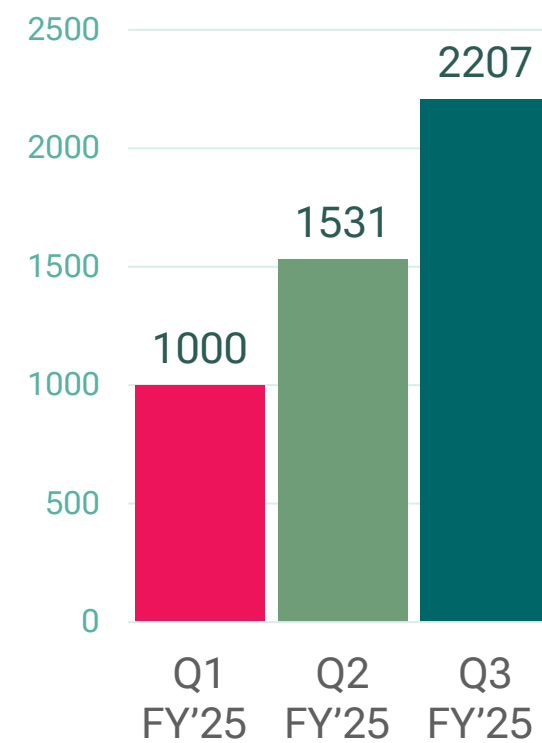

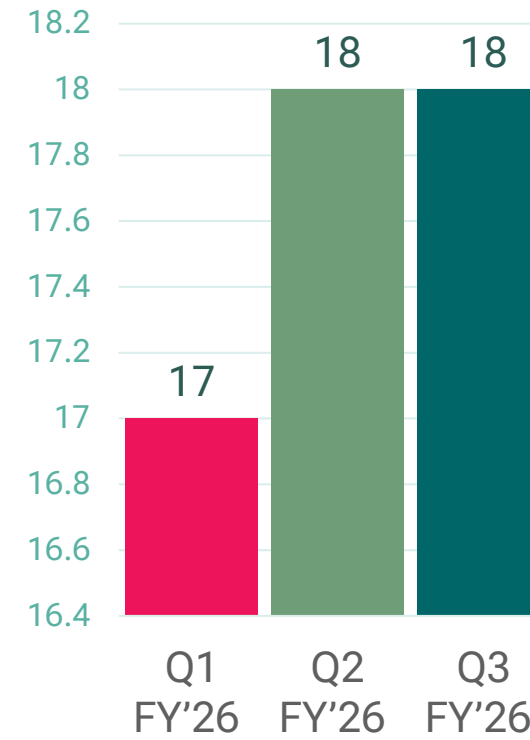
Total AUM* (In Crores)



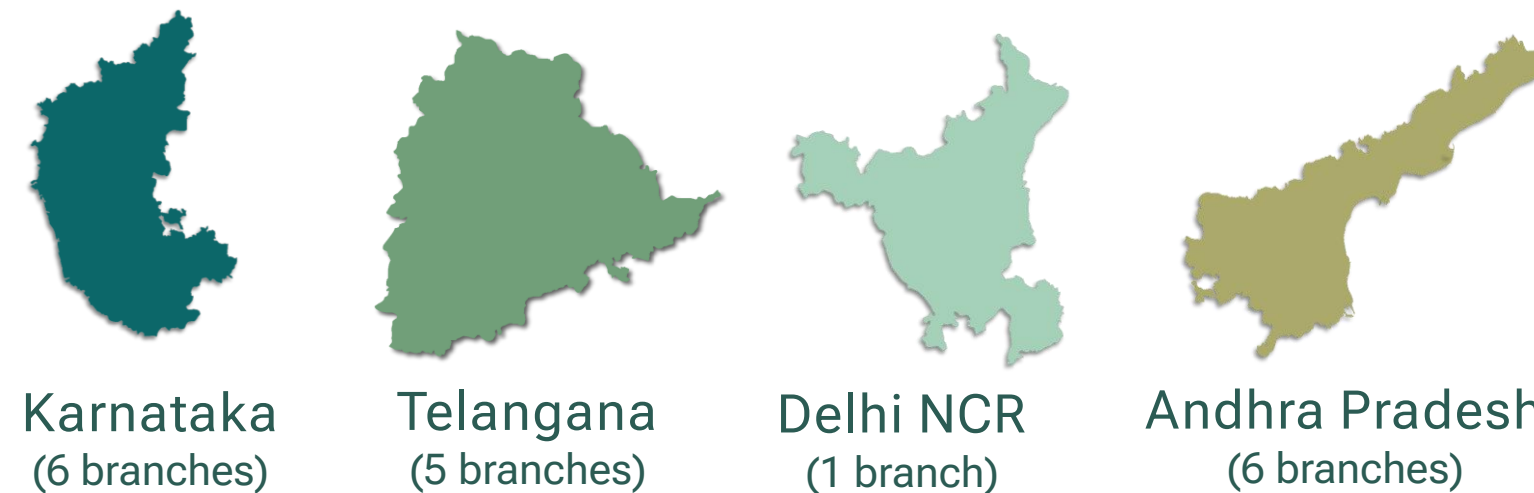

Total branches

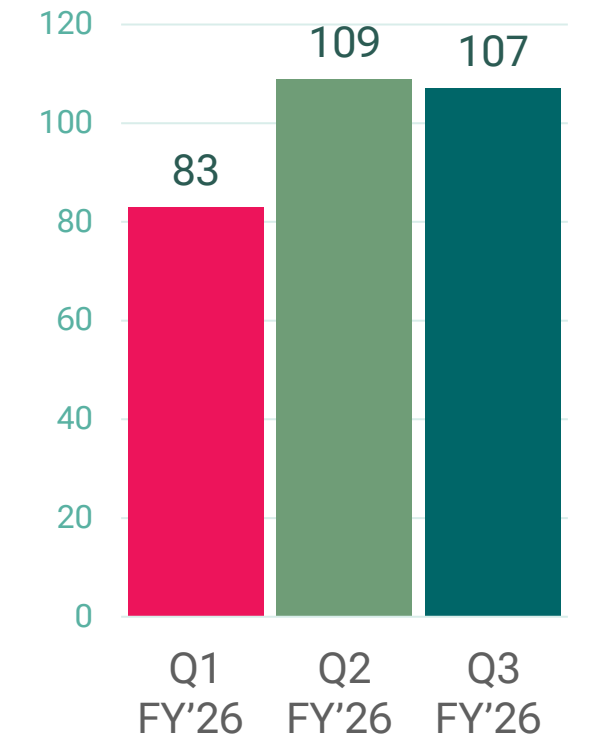


State-wise branch breakup

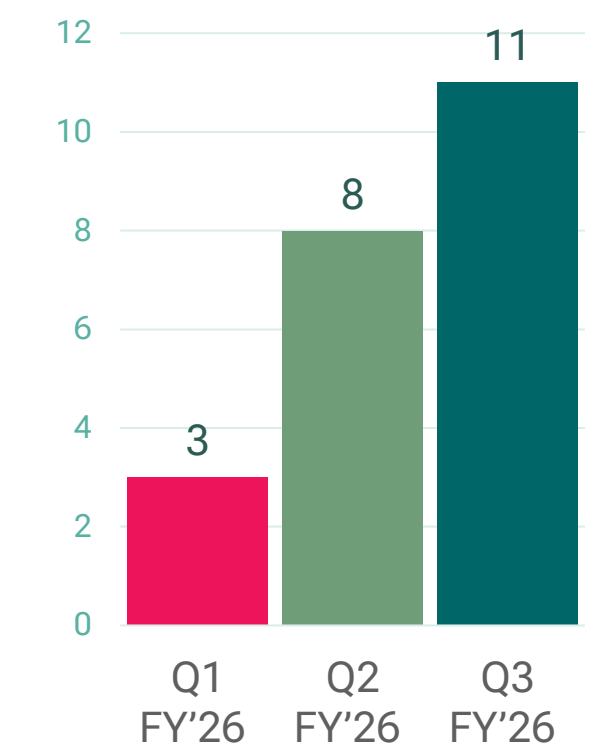
