#### **Updation of KYC:**

This is also a reminder to update KYC details pursuant to SEBI Master Circular No. SEBI/HO/MIRSD/POD-1/P/CIR/2024/37 dated May 7, 2024, and to dematerialise physical securities. The Circular issued by SEBI mandates all the listed companies to record PAN, Address with PIN code, Mobile Number, Bank Account details, Specimen Signature and choice of Nomination of security holders holding securities in physical mode. Moreover, though optional, you are also requested to update your e-mail address at the earliest either through your DPs for electronic holding or send a communication to our RTA on admin@skylinerta.com to facilitate the updation and to continue receiving all important information & documents thereafter and encourage Green Initiative.

The aforesaid SEBI Circular also mandates that security holder(s) whose folios do not have PAN, Choice of Nomination, Contact Details, Bank Account Details and Specimen Signature updated, shall be eligible for any payment including dividend, interest or redemption payment in respect of such folios, only through electronic mode with effect from April 1, 2024.

### Special Window for Re-lodgement of Transfer Requests of Physical Shares:

SEBI has allowed a special window for a period of six months from July 07, 2025 till January 06, 2026, for re-lodgement of transfer deeds of physical shares, which were lodged prior to the deadline of April 01, 2019 but were rejected/returned/not attended due to deficiency in the documents/process/or otherwise. Investor who missed the earlier cut-off are encouraged to utilize this special window and submit the requisite documents to the Company/ RTA i.e. Skyline Financial Services Private Limited.
