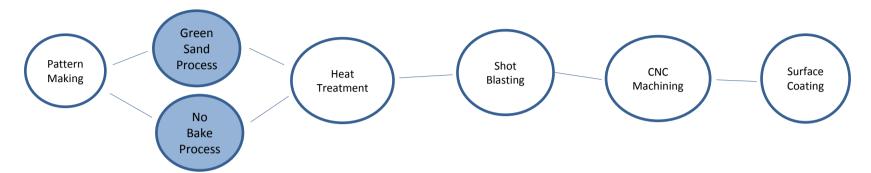

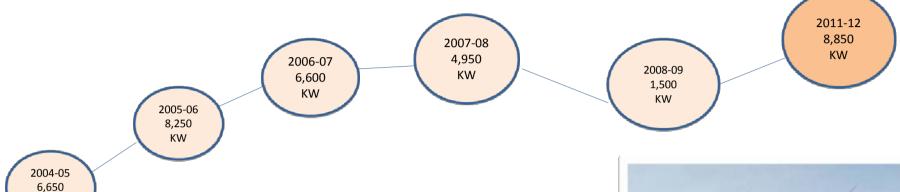

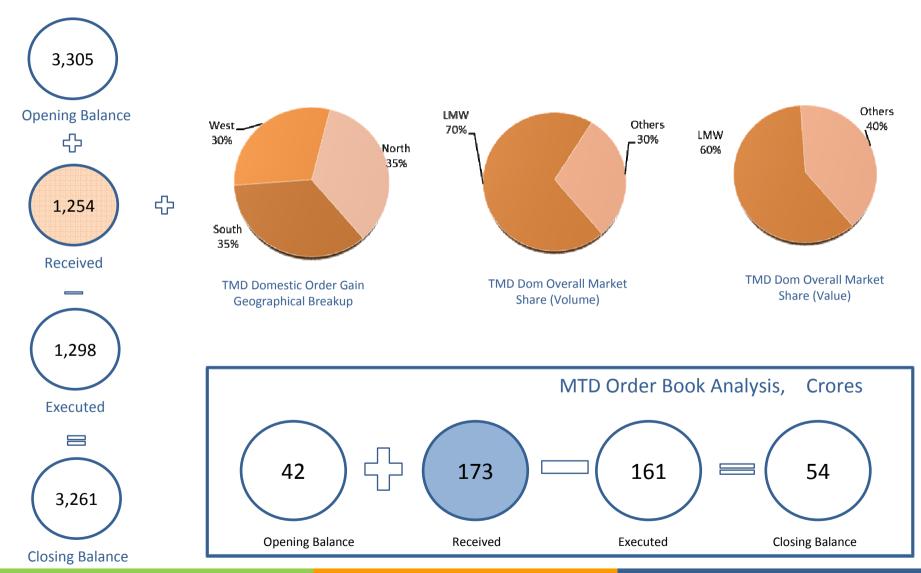




Financials, Domestic Order Book Statistics



TMD Domestic Order Book Analysis, Crores

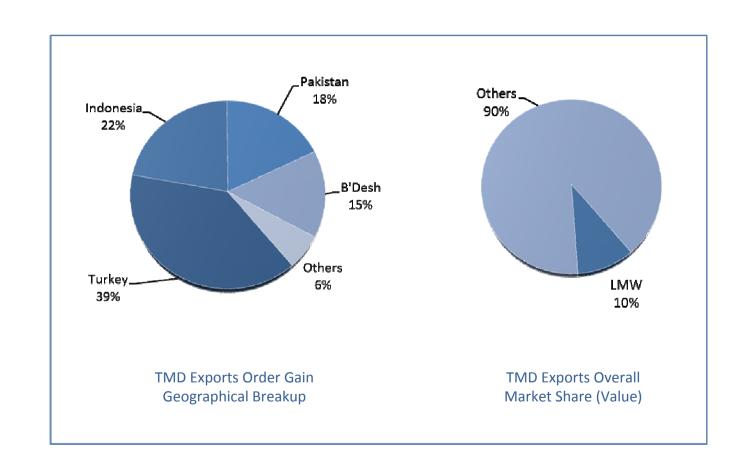


Financials, Export Order Book Statistics

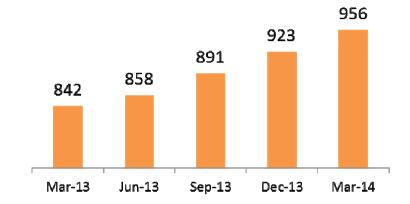

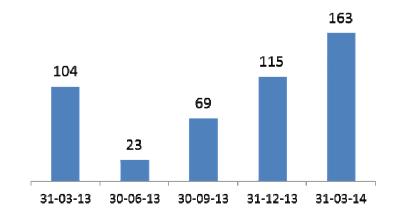

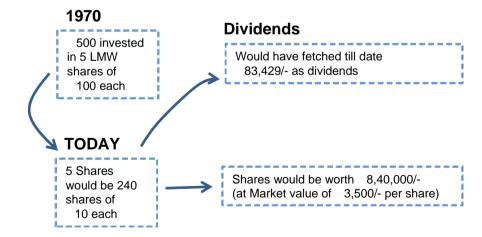
