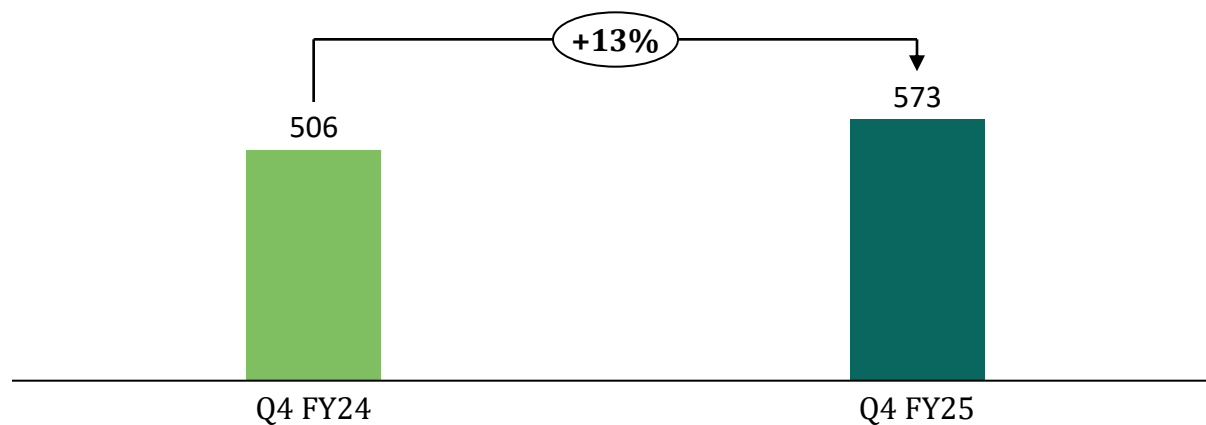
### Operational/Financial Highlights

- The Board of Directors has declared a dividend of ₹4 per equity share for the financial year 2024-25

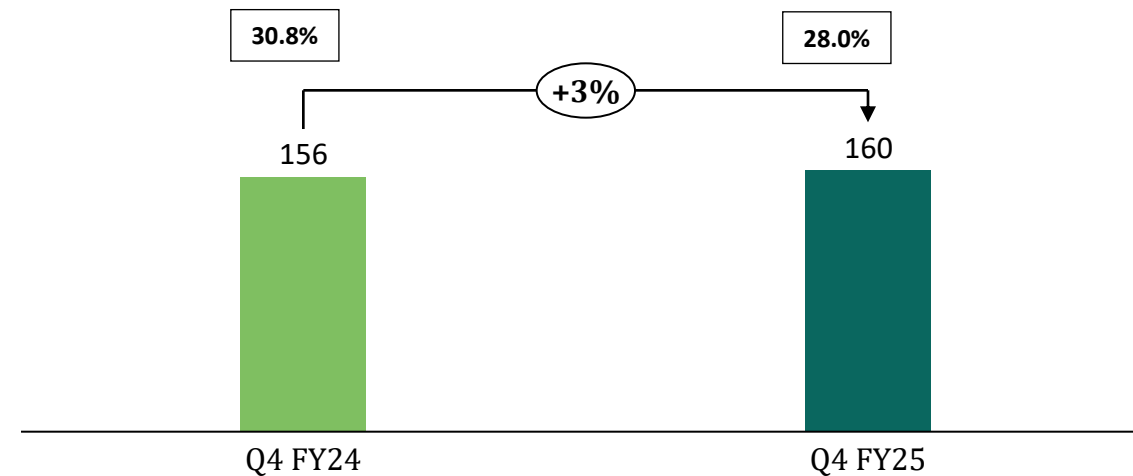

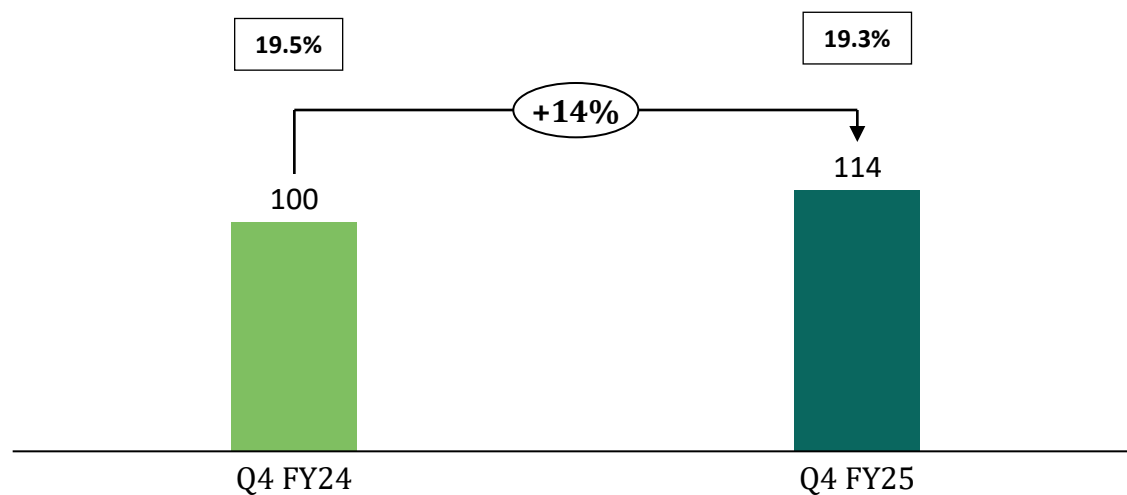
Operating Revenue (Rs. In Mn)

PAT (Rs. In Mn)

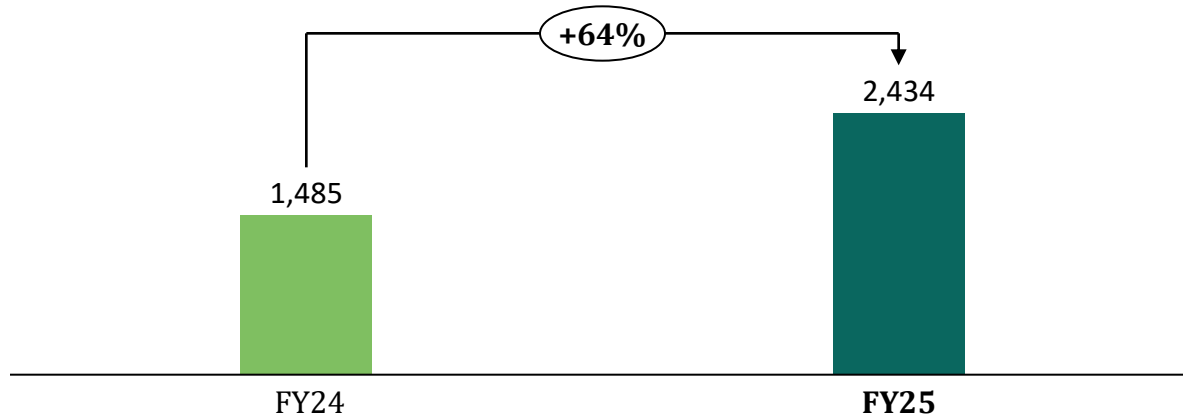


Segment Wise (In Mn)

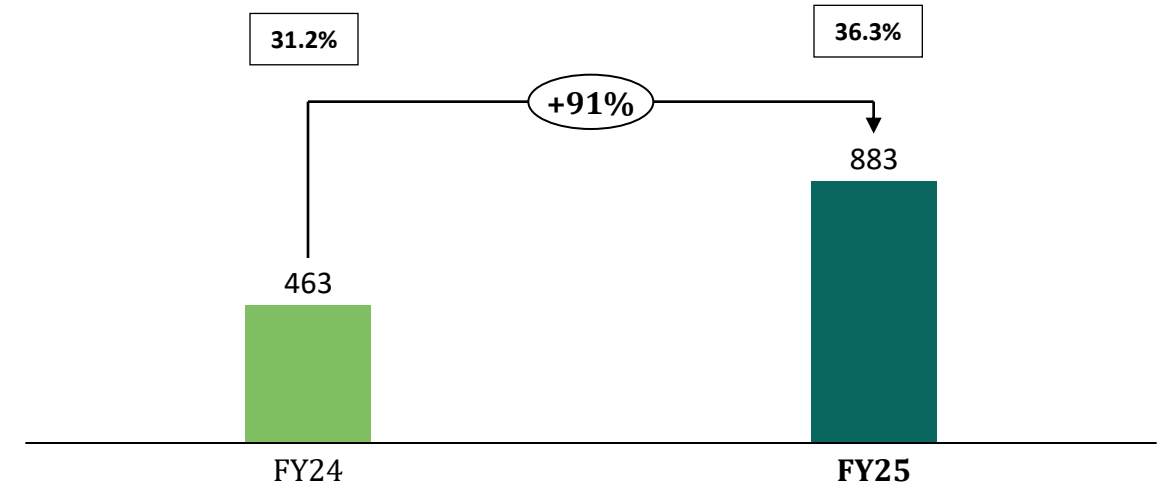

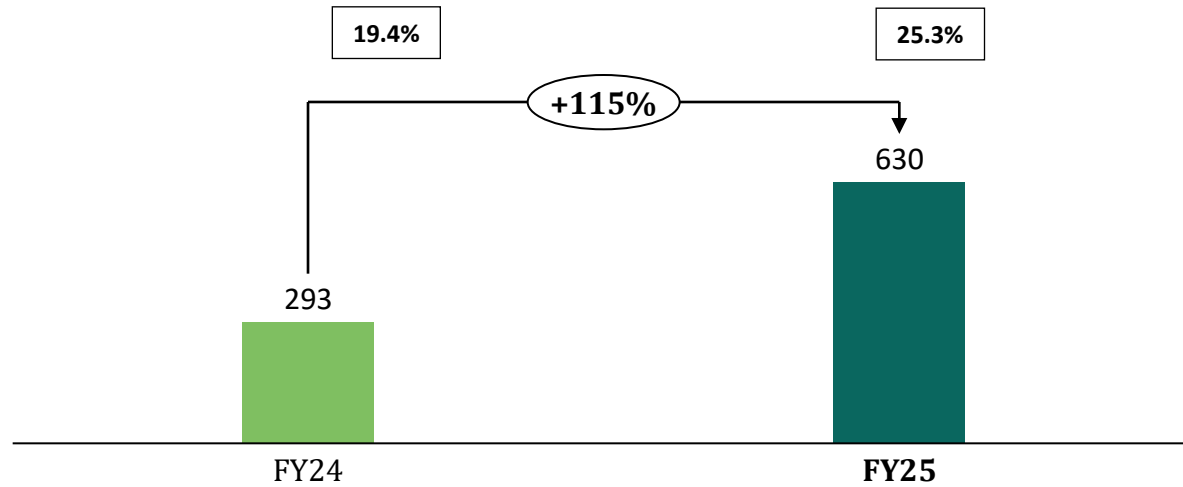

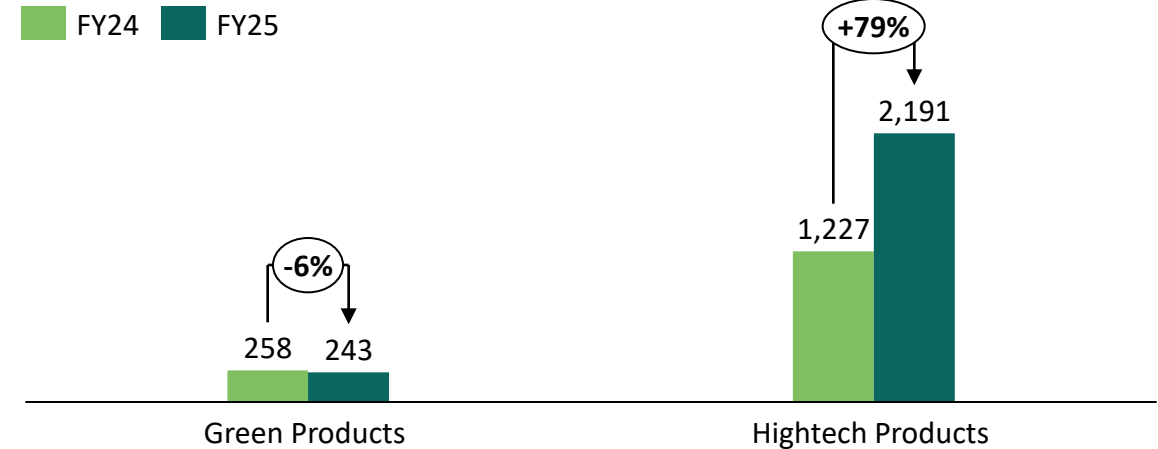

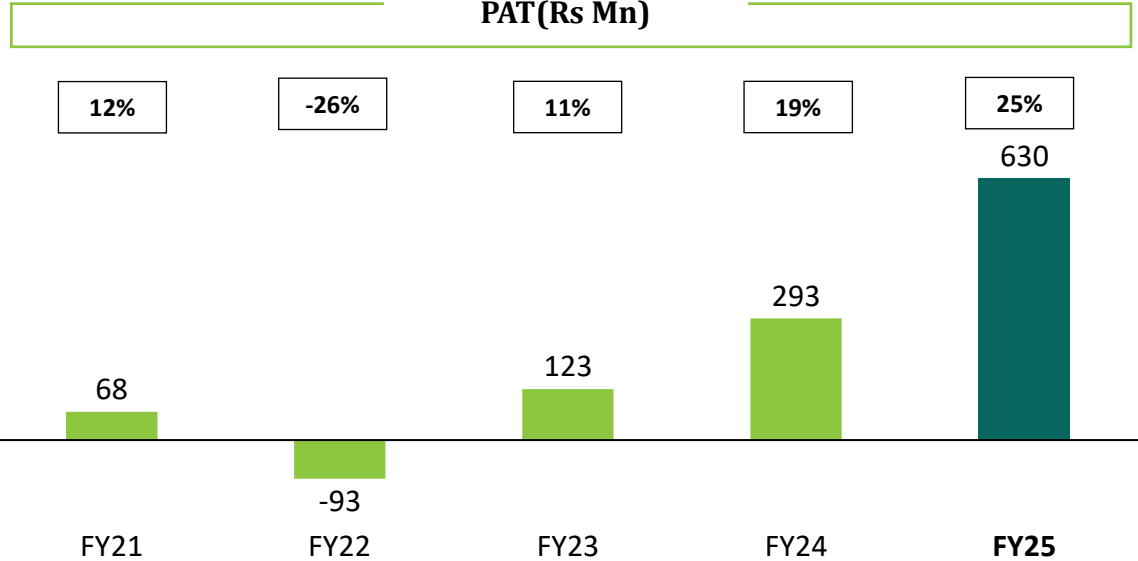
Operating Revenue(Rs Mn)



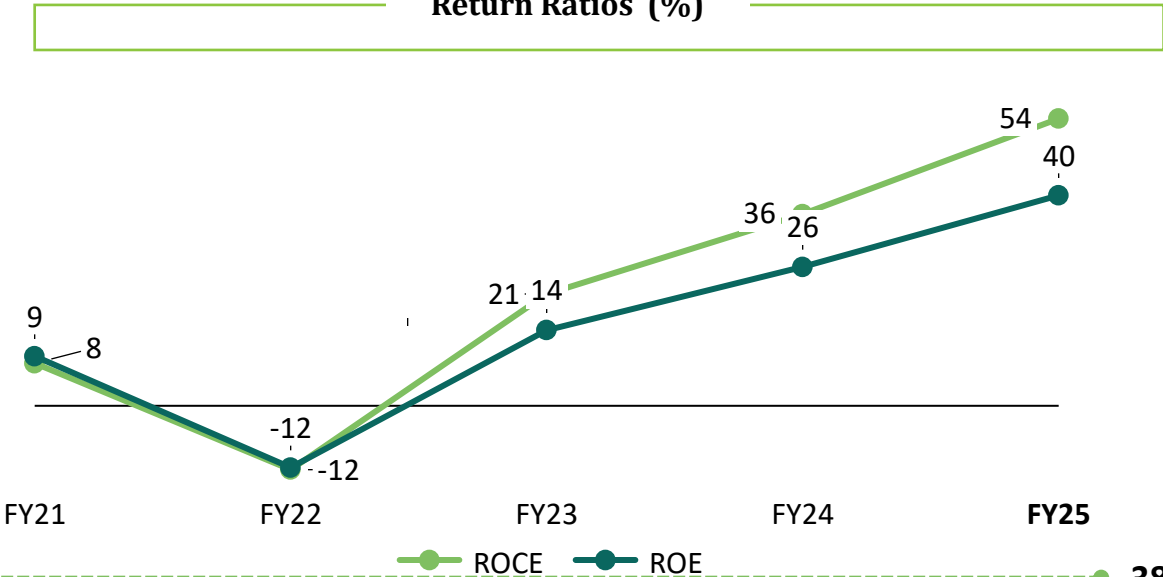
EBITDA(Rs Mn)
