Mumbai – February 13, 2020

Trigyn Technologies Limited for the nine months ended on December 31, 2019 on consolidated basis has achieved growth of **8%** with a revenue of **Rs. 67,494.31 Lacs** as against **Rs. 62,286.71 Lacs** in the previous corresponding period. Total Expenses increased by **8%** during the same period which is **Rs. 60,911.38 Lacs** as against **Rs. 56,323.10 Lacs** in the previous corresponding period. The noteworthy growth of **38%** was recorded in Earnings After Tax for the same period which is **Rs. 4,685.57 Lacs** as against **Rs. 3,397.63 Crores** in the previous corresponding period.

With respect to the third quarter ended on December 31, 2019 on standalone basis has achieved growth of **28%** with a total revenue at **Rs. 2,035.22 Lacs** as against **Rs. 1,588.48 Lacs** in the previous corresponding quarter. Total Expenses increased by **29%** as during the third quarter which is **Rs. 1820.50 Lacs** as against **Rs. 1413.54 Lacs** in the previous corresponding quarter.
