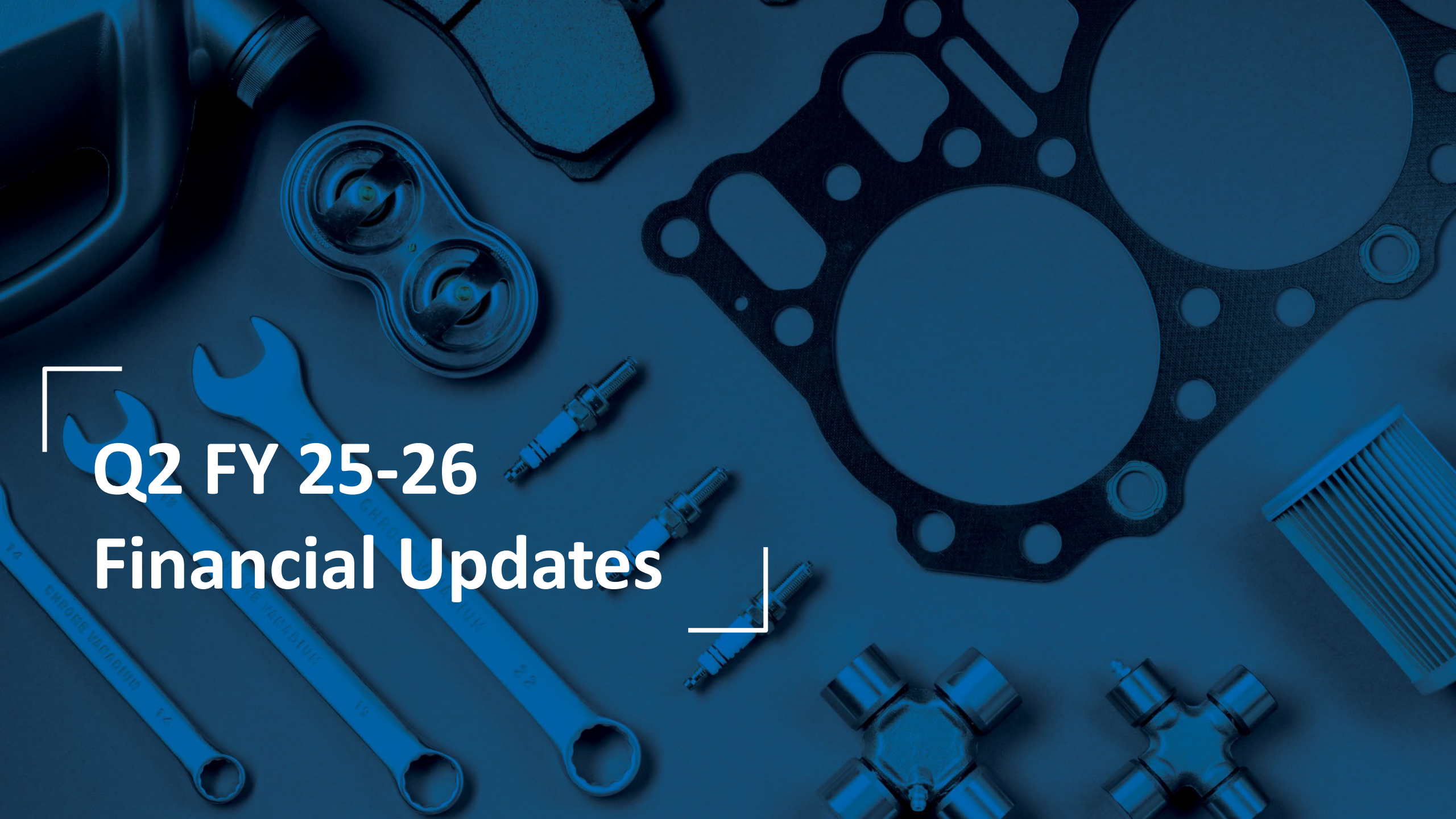

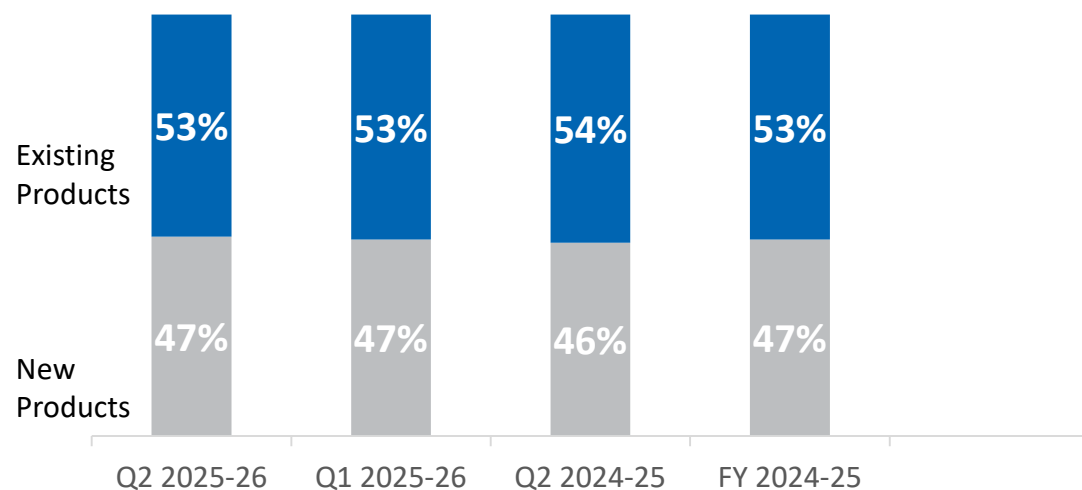

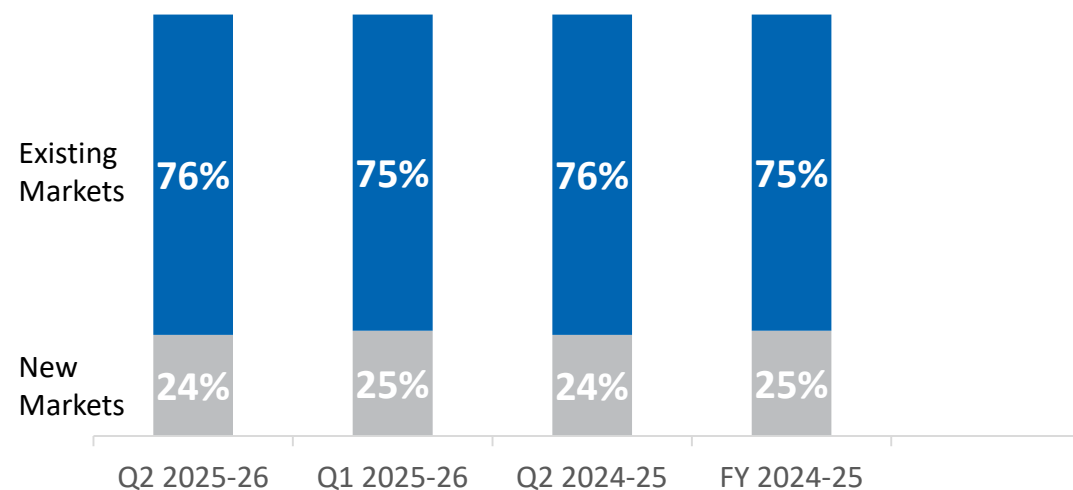
Revenue Mix

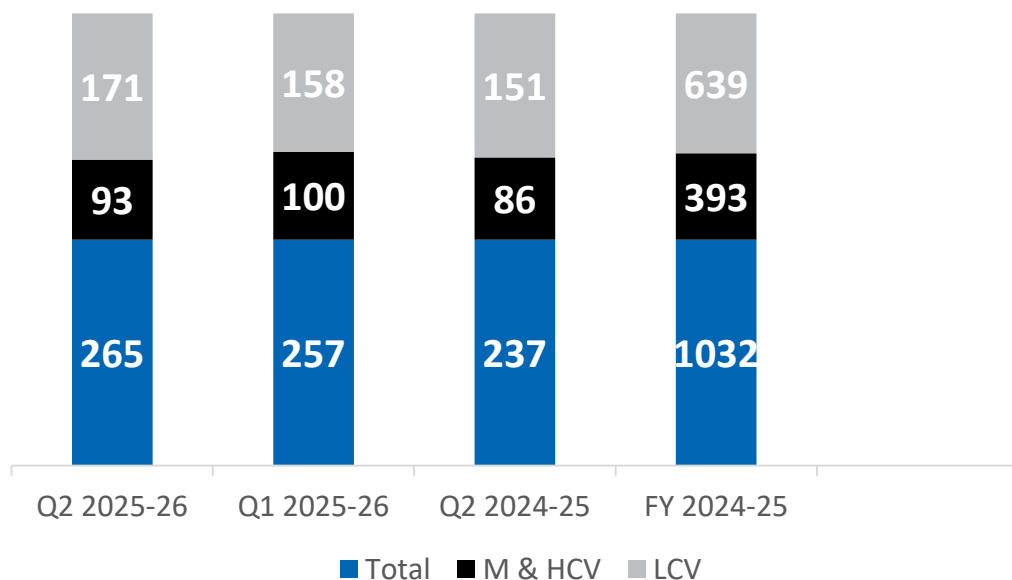

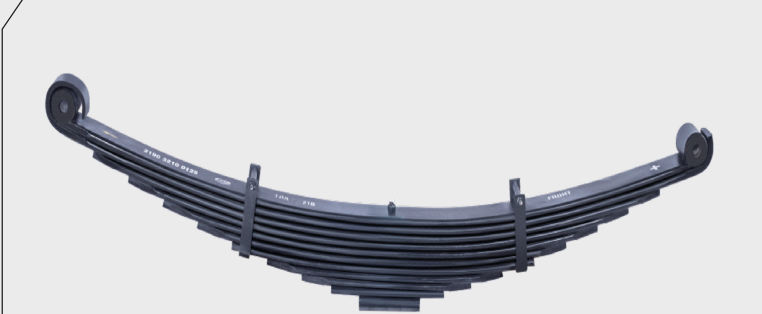

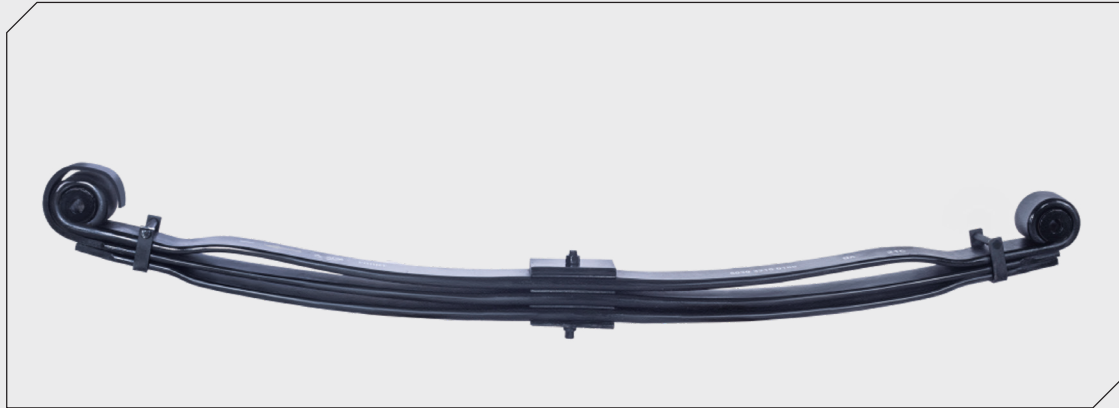
Conventional Leaf Spring

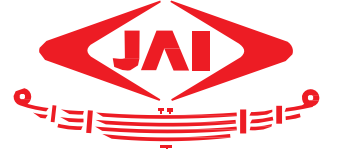


Parabolic Leaf Spring

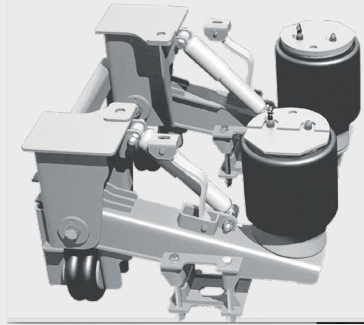

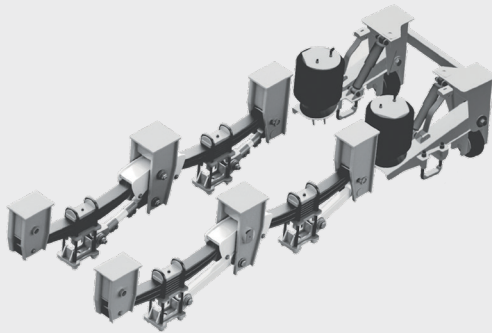

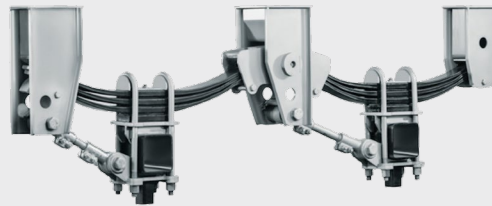

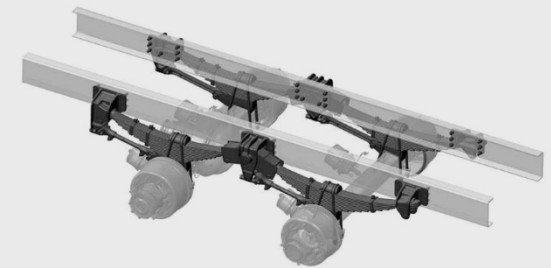

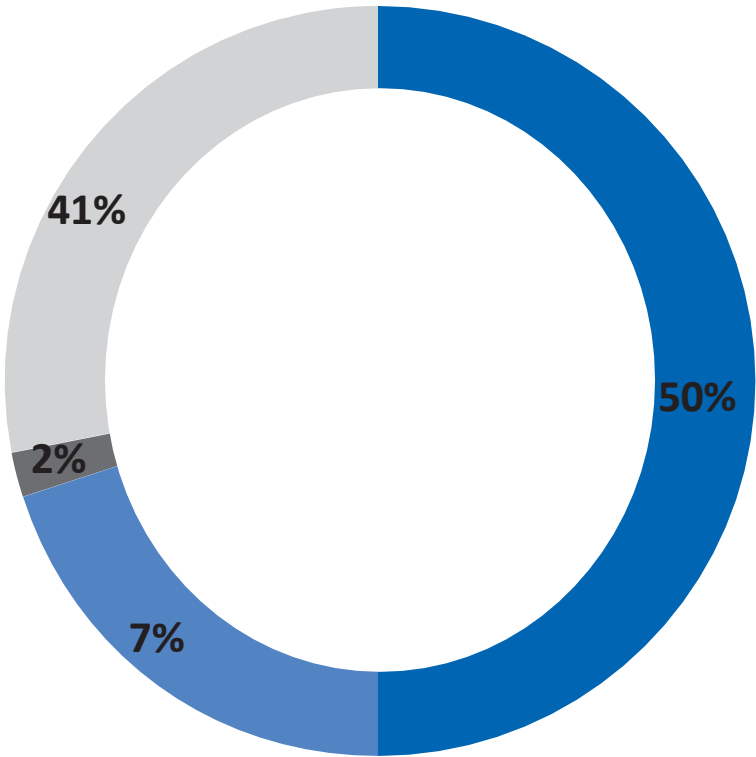
