1. In continuation to this Ministry's General Circular No.20/2020 dated 05.05.2020, No.02/2022 dated 05.05.2022, No.10/2022 dated 28.12.2022, and No.09/2023 dated 25.09.2023, No. 09/2024 dated 19.09.2024, and latest being 03/2025 dated 22nd September, 2025 and the Securities and Exchange Board of India ('SEBI') vide its circular no. SEBI/HO/CFD/CFD-PoD-2/P/CIR/2024/133 dated 3rd October, 2024 and other applicable circulars issued in this regard, (hereinafter collectively referred to as ("the Circulars")), have permitted holding of the Annual General Meeting ("AGM") through Video Conferencing. Hence, the AGM of the Company is being held through VC/OAVM. The deemed venue for the AGM shall be the registered office of the Company, i.e. **2nd Floor, West Wing Electric Mansion Appasaheb Marathe Marg Worli, Mumbai City, Maharashtra, India, 400025**
2. Members attending the AGM through VC or OAVM shall be counted for the purpose of reckoning the quorum under Section 103 of the Act.
3. In terms of the circulars, the requirement of sending proxy forms to the members of the company as per the provisions of section 105 of the act read with regulation 44(4) of the listing regulations, has been dispensed with. therefore, the facility to appoint proxy by the members of the company will not be available and consequently, the proxy form and attendance slip are not annexed to this notice convening the 37th AGM (the "notice").

However, in pursuance of Section 113 of the Act and Rules framed thereunder, the corporate members are entitled to appoint authorized representatives for the purpose of voting through remote e-Voting or for the participation and e-Voting during the AGM, through VC or OAVM. Institutional Shareholders (i.e., other than individuals, HUF, NRI etc.) are required to send scanned copy of the relevant Board Resolution / Power of Attorney / appropriate Authorization Letter together with attested specimen signature(s) of the duly authorized signatory(ies) who are authorized to vote, to the Company Secretary by their registered email address to cs.advancelifestyles@gmail.com

4. Since the 37th AGM will be held through VC or OAVM, no Route Map is being provided with the Notice. The deemed venue for the 37th AGM shall be the Registered Office of the Company.
5. In case of Joint-holders, the Member whose name appears as the first holder in the order of names as per the Register of Members of the Company will be entitled to vote during the AGM.
6. Statement pursuant to Section 102 of the Act and the rules made thereunder setting out the material facts and the reasons for each item of Special Business is annexed hereto. The recommendation of the Board of Directors of the Company (the "Board") in terms of Regulation 17(11) of the Listing Regulations for each item of Special Business, which are

considered unavoidable by the Board, is also provided in the said Statement.

Necessary information of the Directors as required under Regulation 36(3) of the Listing Regulations and the Secretarial Standard on General Meetings (SS-2) issued by the Institute of Company Secretaries of India (ICSI) is also appended to the Notice.

7. The Members, whose names appear in the Register of Members/list of Beneficial Owners as on, Tuesday, 15th September, 2026 (cut-off date), are entitled to vote on the Resolutions set forth in this Notice. The voting rights of Members shall be in proportion to their share in the paid-up equity share capital of the Company as on cut-off date. A person who is not a Member as on the cut-off date should treat this Notice of AGM for information purpose only.
8. The Company is pleased to provide its members the facility to cast their vote by electronic means on all resolutions set forth in the Notice’.
9. Only those Members, who are present in the Meeting through VC/OAVM and have not casted their vote on resolutions through remote e-voting, shall be allowed to vote through e-voting system during the AGM. However, Members who would have cast their votes by remote e-voting may attend the Meeting but shall neither be allowed to change it subsequently nor cast votes again during the Meeting.
10. The Board of Directors of the Company has appointed M/s MSDS & Associates, Practicing Company Secretaries, to act as Scrutinizer to scrutinize the process of remote e-voting and also e-voting during the Meeting in a fair and transparent manner.
11. The Scrutinizer will submit his report to the Chairman of the Company (“the Chairman”) or to any other person authorized by the Chairman after the completion of the scrutiny of the e-voting (votes cast during the AGM and votes cast through remote e-voting), not later than 48 hours from the conclusion of the AGM. The result declared along with the Scrutinizer’s report will be displayed on the Company’s website, <http://advance.net.in/>
12. Subject to receipt of requisite number of votes, the Resolutions shall be deemed to be passed on the date of the Meeting i.e., Tuesday, 22nd September, 2026.
13. In the first instance, the Voting will be held by ‘Show of hands’. However, members having not less than one-tenth of the total voting power or holding shares on which an aggregate sum of not less than five lakh

rupees are entitled to demand a poll and in such a situation, poll will be conducted forthwith.

14. Members are requested to intimate changes, if any, pertaining to their name, postal address, email address, telephone/ mobile numbers, Permanent Account Number (PAN), mandates, nominations, power of attorney, bank details such as, name of the bank and branch details, bank account number, MICR code, IFSC code, etc., to their Depository Participants.
15. The Notice of the AGM along with the Annual Report 2025-26 is being sent only through electronic mode to those Members whose email addresses are registered with the Company / Depositories. 17. The Register of Directors and Key Managerial Personnel and their shareholding, maintained under Section 170 of the Act, and the Register of Contracts or Arrangements in which the directors are interested, maintained under Section 189 of the Act, will be available for inspection by the Members during the AGM.
- 18. THE INSTRUCTIONS OF SHAREHOLDERS FOR REMOTE E-VOTING ARE AS UNDER: (UPDATED TO BE PROVIDED BY BIGSHARE)**
 - i. The voting period begins on Thursday 17th September, 2026 at 9.00 a.m. (IST) and ends on Monday, 21st September, 2026 at 5.00 p.m. (IST). During this period shareholders' of the Company, holding shares either in physical form or in dematerialized form, as on the cut-off date (record date) of Friday 11th September 2026 may cast their vote electronically. The e-voting module shall be disabled by Bigshare for voting thereafter.
 - ii. Shareholders who have already voted prior to the meeting date would not be entitled to vote at the meeting venue.
 - iii. Pursuant to SEBI Circular No. SEBI/HO/CFD/CMD/CIR/P/2020/242 dated 09.12.2020, under Regulation 44 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, listed entities are required to provide remote e-voting facility to its shareholders, in respect of all

shareholders' resolutions. However, it has been observed that the participation by the public non-institutional shareholders/retail shareholders is at a negligible level.

Currently, there are multiple e-voting service providers (ESPs) providing evoting facility to listed entities in India. This necessitates registration on various ESPs and maintenance of multiple user IDs and passwords by the shareholders.

In order to increase the efficiency of the voting process, pursuant to a public consultation, it has been decided to enable e-voting to **all the demat account holders, by way of a single login credential, through their demat accounts/ websites of Depositories/ Depository Participants**. Demat account holders would be able to cast their vote without having to register again with the ESPs, thereby, not only facilitating seamless authentication but also enhancing ease and convenience of participating in e-voting process.

- iv. In terms of SEBI circular no. SEBI/HO/CFD/CMD/CIR/P/2020/242 dated December 9, 2020 on e-Voting facility provided by Listed Companies, Individual shareholders holding securities in demat mode are allowed to vote through their demat account maintained with Depositories and Depository Participants. Shareholders are advised to update their mobile number and email Id in their demat accounts in order to access e-Voting facility.

The observations contained in the Statutory Auditors' Report have been duly considered by the Board. Further, the Statutory Auditors have not reported any fraud under Section 143(12) of the Companies Act, 2013 during the financial year under review.

MANAGEMENT'S EXPLANATION TO THE AUDITORS' QUALIFICATIONS/OBSERVATIONS:

Auditors' Qualifications in the Standalone Auditor's Report Basis of Qualified Opinion:

- a) As stated in Note 15 and Note 16 to the Financial Statements, the Company has obtained unsecured loans amounting to ₹3,51,189.88 Thousands, which, as represented by the Management, are interest-free. Accordingly, no interest expense has been recognized in the Statement of Profit and Loss for the year ended 31 March 2026.

Further, the Company has outstanding liabilities aggregating to ₹75,899.55 Thousands payable to three parties, of which two parties are undergoing Corporate Insolvency Resolution Process ("CIRP") under the Insolvency and Bankruptcy Code, 2016, and one party is presently non-traceable. No interest liability has been recognized on the aforesaid balances as no claim, demand or communication relating to interest has been received from the concerned parties or the Resolution Professionals.

In the absence of sufficient appropriate audit evidence regarding the terms of the aforesaid borrowings and the completeness of any related interest liability on the outstanding balances, we are unable to determine the extent of adjustments, if any, that may be required to the interest expense, liabilities and the accompanying Financial Statements.

- b) As stated in Note 16 to the Financial Statements, the Company has disclosed outstanding balances aggregating to ₹75,899.55 Thousands payable to certain parties as at 31 March 2026. These balances are subject to balance confirmations and supporting reconciliations, which were not made available for our verification. Further, two of the aforesaid parties are undergoing Corporate Insolvency Resolution Process ("CIRP") under the Insolvency and Bankruptcy Code, 2016, and one party is presently non-traceable.

In the absence of sufficient appropriate audit evidence regarding the existence, completeness and valuation of these balances, we are unable to determine the consequential adjustments, if any, required to the accompanying Financial Statements.

- c) As disclosed in the Financial Statements, the Company has granted certain interest-free loans and advances, including loans granted in contravention of the provisions of Section 186(7) of the Companies Act, 2013. The Management has not assessed the consequential financial impact, if any, arising from non-recognition of interest on such loans in accordance with Ind AS 109 - Financial Instruments.

In the absence of sufficient appropriate audit evidence regarding the consequential financial impact of the aforesaid matter, we are unable to determine the extent of adjustments, if any, that may be required to the accompanying Financial Statements.

Management's Explanations to the Auditor's Qualification in the Standalone Auditor's Report

- a) and b): Certain outstanding liabilities pertain to parties undergoing Corporate Insolvency Resolution Process (CIRP) under the Insolvency and Bankruptcy Code, 2016, and the final settlement obligation, if any, is yet to be determined upon completion of such proceedings. Further, one party is presently non-traceable and no balance confirmations or claims have been received from such parties till the date of approval of the financial results. The Company has accordingly not recognised any interest liability in the financial statements,

In the absence of independent balance confirmations, reconciliations, or other supporting documentary evidence, the consequential impact of interest or any other adjustment on such balances cannot presently be determined.

- c) During the financial year 2025-2026, substantial repayments towards the principal amounts of such loans and advances were received from the respective parties. The Management has considered the accounting implications of the aforesaid transactions under the applicable provisions of Ind AS 109. Based on the information presently available and the fact that the substantial principal amounts have been fully repaid during the year, no further adjustment has been recognised in the financial statements in respect of such loans and advances. The Management will appropriately review and account for any consequential impact, if required, in accordance with the applicable provisions of Companies Act, 2013 law and Accounting Standards.

The Board believes that the explanations provided adequately address the observations of the Statutory Auditors.

- **INTERNAL AUDITOR:**

Qualified Opinion

We have audited the accompanying Financial Statements of **Advance Lifestyles Limited** ("the Company"), which comprise the Balance Sheet as at **31st March, 2026**, the Statement of Profit and Loss (including Other Comprehensive Income), the Statement of Changes in Equity and the Statement of Cash Flows for the year ended on that date and notes to the Financial Statements, including a summary of material accounting policies and other explanatory information (hereinafter referred to as "the Financial Statements").

In our opinion and to the best of our information and according to the explanations given to us, except for the effects / possible effects of the matter described in the Basis for Qualified Opinion section of our report, the aforesaid Financial Statements give the information required by the Companies Act, 2013 (hereinafter referred to as "the Act") in the manner so required and give a true and fair view in conformity with the Indian Accounting Standards prescribed under Section 133 of the Act read with the Companies (Indian Accounting Standards) Rules, 2015, as amended (hereinafter referred to as "the Ind AS") and other accounting principles generally accepted in India, of the state of affairs of the Company as at **31st March, 2026**, and its profit, total comprehensive income, changes in equity and its cash flows for the year ended on that date.

Basis of Qualified Opinion

Attention is drawn to:

- a) As stated in Note 15 and Note 16 to the Financial Statements, the Company has obtained unsecured loans amounting to ₹3,51,189.88 Thousands, which, as represented by the Management, are interest-free. Accordingly, no interest expense has been recognized in the Statement of Profit and Loss for the year ended 31 March 2026.

Further, the Company has outstanding liabilities aggregating to ₹75,899.55 Thousands payable to three parties, of which two parties are undergoing Corporate Insolvency Resolution Process ("CIRP") under the Insolvency and Bankruptcy Code, 2016, and one party is presently non-traceable. No interest liability has been recognized on the aforesaid balances as no claim, demand or communication relating to interest has been received from the concerned parties or the Resolution Professionals.

In the absence of sufficient appropriate audit evidence regarding the terms of the aforesaid borrowings and the completeness of any related interest liability on the outstanding balances, we are unable to determine the extent of adjustments, if any, that may be required to the interest expense, liabilities and the accompanying Financial Statements.

- b) As stated in Note 16 to the Financial Statements, the Company has disclosed outstanding balances aggregating to ₹75,899.55 Thousands payable to certain parties as at 31 March 2026. These balances are subject to balance confirmations and supporting reconciliations, which were not made available for our verification. Further, two of the aforesaid parties are undergoing Corporate Insolvency Resolution Process ("CIRP") under the Insolvency and Bankruptcy Code, 2016, and one party is presently non-traceable.

In the absence of sufficient appropriate audit evidence regarding the existence, completeness and valuation of these balances, we are unable to determine the consequential adjustments, if any, required to the accompanying Financial Statements.

- c) As disclosed in the Financial Statements, the Company has granted certain interest-free loans and advances, including loans granted in contravention of the provisions of Section 186(7) of the Companies Act, 2013. The Management has not assessed the consequential financial impact, if any, arising from non-recognition of interest on such loans in accordance with Ind AS 109 - Financial Instruments.

We are independent of the Company in accordance with the Code of Ethics issued by the Institute of Chartered Accountants of India together with ethical requirements that are relevant to our audit of the financial results under the provisions of the Act and Rules thereunder, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the Code of Ethics.

We believe that the audit evidence obtained by us is sufficient and appropriate to provide a basis for our qualified opinion.

Key Audit Matters

Key audit matters are those matters that, in our professional judgment, were of most significance in our audit of the Financial Statements of the current year. These matters were addressed in the context of our audit of the Financial Statements as a whole, and in forming our opinion thereon, and we do not provide separate opinion on these matters. In addition to the matter described in the basis for qualified opinion section, we have determined the matter described below as Key audit matter and our description of how our audit addressed the matter is provided in that context.

1. A CORPORATE INFORMATION:

Advance Lifestyles Limited ('ALL' or 'the Company') having CIN: L45309MH1988PLC268437 is a public limited company domiciled in India, listed on the Bombay Stock Exchange and incorporated under the provisions of the Companies Act, 1956 on August 18th, 1988 having its registered office at 2nd Floor, West Wing Electric Mansion, Appasaheb Marathe Marg, Worli, Mumbai, Maharashtra, India - 400025.

The Company was originally incorporated with the object of carrying on the business of manufacturing and trading textile products. Subsequently, the scope of its activities was expanded to include the acquisition, development and dealing in real estate properties. During the year, the Company further amended its Memorandum of Association to incorporate activities relating to the mining, exploration, extraction, processing and trading of minerals, precious metals, precious and semi-precious stones and other allied activities. As at the reporting date, the Company is actively exploring and pursuing business opportunities in line with its amended objects, including the newly added business segments.

1. B BASIS OF PREPARATION OF FINANCIAL STATEMENTS:

a. STATEMENT OF COMPLIANCE

These Financial Statements have been prepared in accordance with Indian Accounting Standards (Ind AS) as prescribed under section 133 of the Companies Act, 2013 read with Rule 3 of the Companies (Indian Accounting Standards) Rules, 2015 as amended by Companies (Indian Accounting Standards) Amendment Rules, 2016.

The financial statements of the Company for the year ended 31 March, 2026 were authorized for issue by the Company's Board of Directors on 27 May, 2026.

b. BASIS OF MEASUREMENT

The Financial Statements have been prepared on the historical cost convention on accrual basis except for certain financial assets and liabilities that are measured at fair value, amortised cost or present value, as disclosed in accounting policies.

c. ACCOUNTING ESTIMATES AND ASSUMPTIONS

The preparation of the financial statements in conformity with Ind AS requires management to make estimates, judgments and assumptions. These estimates, judgments and assumptions affect the application of accounting policies and the reported amounts of assets and liabilities, the disclosures of contingent assets and liabilities at the date of the financial statements and reported amounts of revenues and expenses during the period. Management believes that estimates used in the preparation of the financial statements are prudent and reasonable.

Accounting estimates could change from period to period. Actual results could differ from those estimates. Appropriate changes in estimates are made as management becomes aware of changes in circumstances surrounding the estimates. Changes in estimates are reflected in the financial statements in the period in which changes are made and, if material, their effects are disclosed in the notes to the financial statements.

d. FUNCTIONAL AND PRESENTATION CURRENCY

The financial statements are presented in Indian National Rupee ('INR'), which is the Company's functional and presentation currency. All amounts have been rounded to two decimal points of Thousands, unless otherwise indicated. Wherever the amount represents '₹ 0' (zero) construes value less than Rupee One thousands, Adding the individual figures may therefore not always results in exact total given.

e. CURRENT OR NON CURRENT CLASSIFICATION

As the Company does not have regular operating activities involving a clearly identifiable cycle of purchase, production, sale and realization of cash, its operating cycle cannot be determined in the normal course of business. Accordingly, for the purpose of classification of assets and liabilities, the operating cycle has been assumed to be twelve months. Based on this assumption and the criteria prescribed under Ind AS 1 - 'Presentation of Financial Statements' and Schedule III to the Companies Act, 2013, assets and liabilities have been classified as current and non-current.

1. C MATERIAL ACCOUNTING POLICY

1 Property, Plant & Equipment (PPE)

i) Property, Plant and Equipment are stated at original cost (net of tax/duty credit availed) less accumulated depreciation and impairment losses. Cost includes cost of acquisition, construction and installation, taxes, duties, freight, other incidental expenses related to the acquisition, and pre-operative expenses including attributable borrowing costs incurred during pre-operational period.

ii) Subsequent costs are included in the assets' carrying amount or recognized as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the company and the cost of the item can be measured reliably. The carrying amount of any component as a separate asset is derecognized when replaced. All other repairs and maintenance are charged to statement of profit and loss during the reporting period in which they are incurred.

a) Land and buildings held for use in the production or supply of goods or services, or for administrative purposes, are stated in the balance sheet at deemed cost less and accumulated depreciation. Freehold land is not depreciated.

b) Properties in the course of construction for production, supply or administrative purposes are carried at cost, less any recognised impairment loss. Cost includes professional fees and, for qualifying assets, borrowing costs capitalised in accordance with the Company's accounting policy. Such properties are classified to the appropriate categories of property, plant and equipment when completed and ready for intended use. Depreciation of these assets, on the same basis as other property assets, commences when the assets are ready for their intended use.

c) Fixtures and equipment are stated at cost less accumulated depreciation and accumulated impairment losses.

d) An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on the disposal or retirement of an item of property, plant and equipment is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in profit or loss.

e) Subsequent expenditures related to an item of Tangible Asset are added to its book value only if they increase the future benefits from the existing asset beyond its previously assessed standard of performance.

f) Assets which are not ready for their intended use on reporting date are carried as capital work-in-progress at cost, comprising direct cost and related incidental expenses.

2 Intangible Assets

i). Intangible assets acquired by payment (e.g. Computer Software or any such assets) is disclosed at cost less amortisation on a straight-line basis over its estimated useful life.

ii). Intangible assets are carried at cost, net of accumulated amortisation and impairment loss, if any.

3 Capital work in progress

Expenditure related to and incurred during the implementation of the projects is included under Capital Work-in-Progress and the same are capitalized under the appropriate heads on completion of the projects, if any.

4 Depreciation & Amortization

Depreciation for the year has been provided on the basis of useful life of assets as prescribed in schedule II to the Companies Act, 2013. The carrying amount has been depreciated over the balance useful life of asset.

Depreciation on additions to the assets and the assets sold or disposed off, during the year is provided on prorata basis, at their respective useful life or rate of depreciation as prescribed with reference to the date of acquisition / installation or date of sale / disposal.

Intangible assets are amortised on Straight Line Method from the date they are available for use, over the useful lives of the assets as estimated by the Management

5 Revenue Recognition

Revenue is primarily derived from sale of finished goods to the customers. Revenue is recognized only when risks and rewards incidental to ownership are transferred to the customer, it can be reliably measured and it is reasonable to expect ultimate collection. Revenue from operations includes sale of goods. Interest income is recognized on a time proportion basis taking into account the amount outstanding and the interest rate applicable, if any. Discount claims, rebates and retirement benefits which cannot be determined with certainty during the year, are recognized on receipt basis.

6 Investment property

Property that is held for long-term rental yields or for capital appreciation or both is classified as investment property. Investment property is measured initially at its cost, including related transaction costs and borrowing costs where applicable. Subsequent expenditure is capitalised to the asset's carrying amount only when it is probable that future economic benefits associated with the expenditure will flow to the Company and the cost of the item can be measured reliably. Investment properties are depreciated over their estimated useful lives.

The cost of inventories have been computed to include all cost of purchases, cost of conversion and other related costs incurred in bringing the inventories to their present location and condition. The costs of Raw Materials, Stores and spare parts etc., consumed consist of purchase price including duties and taxes (other than those subsequently recoverable by the enterprise from the taxing authorities), freight inwards and other expenditure directly attributable to the procurement.

ii). Stock of Raw Materials are valued at cost and of those in transit related to these items are valued at cost to date. Goods and materials in transit are valued at actual cost incurred up to the date of balance sheet. Material and supplies held for use in the production of inventories are not written down if the finished products in which they will be used are expected to be sold at or above cost. Goods-in-process and Stock of Finished goods is valued at lower of cost or net realisable value. Inventories are taken as valued and certified by the management of the company.

8 Exceptional items

An ordinary item of income or expense which by its size, nature, occurrence or incidence requires a disclosure in order to improve understanding of the performance of the Company is treated as an exceptional item in the Statement of Profit and Loss account.

9 Foreign Exchange Gain / Loss

Transactions in currencies other than the Company's functional currency (foreign currencies) are recognized at the rates of exchange prevailing at the dates of the transactions. At the end of each reporting period, monetary items denominated in foreign currencies are translated using exchange rate prevailing on the last day of the reporting period. Non monetary items which are carried in terms of historical cost denominated in a foreign currency are reported using the exchange rate at the date of transaction. Exchange differences on monetary items are recognized in the Statement of Profit and Loss in the period in which they arise.

10 Borrowing Cost

Borrowing costs include interest, amortization of ancillary costs incurred. Costs in connection with the borrowing of funds to the extent not directly related to the acquisition of qualifying assets are charged to the Statement of Profit and Loss over the tenure of the loan. Borrowing costs, allocated to and utilized for qualifying assets, pertaining to the period from commencement of activities relating to construction/ development of the qualifying asset upto the date of capitalization of such asset is added to the cost of the assets. Capitalization of borrowing costs is suspended and charged to the Statement of Profit and Loss during extended periods when active development activity on the qualifying assets is interrupted.

11 Cash Flow Statement

Cash flows are reported using the indirect method, whereby profit before tax is adjusted for the effects of transactions of a non-cash nature, any deferrals or accruals of past or future operating cash receipts or payments and item of income or expenses associated with investing or financing cash flows. The cash flows are segregated into operating, investing and financing activities.

12 Provisions, Contingent Liabilities and Contingent Assets

Provision is recognized in the accounts when there is a present obligation as a result of past event(s) and it is probable that an outflow of resources will be required to settle the obligation and a reliable estimate can be made. Provisions are not discounted to their present value and are determined based on the best estimate required to settle the obligation at the reporting date. These estimates are reviewed at each reporting date and adjusted to reflect the current best estimates. Contingent liabilities are disclosed unless the possibility of outflow of resources is remote, if any. Contingent assets are neither recognized nor disclosed in the financial statements.

13 Accounting for Taxes on Income

i). Tax expenses comprise of current tax and deferred tax including applicable surcharge and cess.

ii). Current Income tax is computed using the tax effect accounting method, where taxes are accrued in the same period in which the related revenue and expenses arise. A provision is made for income tax annually, based on the tax liability computed, after considering tax allowances and exemptions. Provisions are recorded when it is estimated that a liability due to disallowances or other matters is probable.

iii). Deferred tax is provided using the balance sheet approach on temporary differences at the reporting date between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes at the reporting date. Deferred tax liabilities are recognized for all taxable temporary differences. Deferred tax assets are recognised for all deductible temporary differences, the carry forward of unused tax credits and any un used tax losses. Deferred tax assets are recognized to the extent that it is probable that taxable profits against which the deductible temporary differences, and the carry forward unused tax credits and unused tax losses can be utilized.

iv). The carrying amount of deferred tax assets is reviewed at each reporting date and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred tax assets to be utilised. Unrecognised deferred tax assets are reassessed at each reporting date and are recognised to the extent that it is become probable that future taxable profits will allow the deferred tax asset to be recovered. Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the year when the asset is realised or the liability is settled, based on the tax rates and tax laws that have been enacted or substantively enacted at the reporting date.

v). Deferred tax is recognised in the statement of profit and loss, except to the extent that it relates to items recognised in other comprehensive income. As such, deferred tax is also recognised in other comprehensive income.

vi) Deferred Tax Assets and Deferred Tax Liabilities are offset, if a legally enforceable right exists to set off current tax assets against current tax liabilities and the Deferred Tax Assets and Deferred Tax Liabilities relate to taxes on income levied by same governing taxation laws.

14 Impairment of Assets

At each reporting date, the Company assesses whether there is any indication that an asset or cash-generating unit (CGU) may be impaired. If any such indication exists, the recoverable amount of the asset or CGU is estimated. An impairment loss is recognized in the Statement of Profit and Loss whenever the carrying amount of an asset or CGU exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less costs of disposal and its value in use. Value in use is determined by discounting the estimated future cash flows expected to arise from the continuing use of the asset or CGU to their present value using an appropriate discount rate. At each reporting date, the Company also assesses whether there is any indication that an impairment loss recognized in prior periods may no longer exist or may have decreased. If such indication exists, the recoverable amount is re-estimated and the impairment loss is reversed to the extent permitted under the applicable accounting standards. Such reversal is recognized in the Statement of Profit and Loss, except in respect of revalued assets, for which the reversal is treated in accordance with the relevant accounting standard.

15 Earning Per Share

i). Basic earnings per share are calculated by dividing the net profit or loss for the period attributable to equity shareholders by the weighted average number of equity shares outstanding during the period.

ii). For the purpose of calculating diluted earnings per share, the net profit or loss for the period attributable to equity shareholders and the weighted average number of shares outstanding during the period are adjusted for the effects of all dilutive potential equity shares.

16 Segment Reporting

Operating Segments are reported in a manner consistent with the internal reporting provided to the chief operating decision maker (CODM). The CODM assesses the financial performance and position of the company, and makes strategic decisions. The CODM consists of managing Director and Chief Financial Officer.

The Company identifies its reportable segments based on the nature of products and services, risks and returns, and the internal management reporting structure. The reportable business segments of the Company comprise: (a) Mining and Trading of Bullion & Precious Metals; (b) Real Estate & Infrastructure Development and Unallocated.

Segment revenue includes revenue directly attributable to a segment and the relevant portion of revenue that can be allocated on a reasonable basis. Segment results represent the operating profit or loss of each segment before finance costs, exceptional items and income tax, after considering directly attributable expenses and those allocated on a reasonable basis. Finance costs, income tax expense, deferred tax, exceptional items and other corporate income or expenditure that cannot be directly attributed to any operating segment are disclosed separately as unallocated items unless specifically attributable to a reportable segment.

Segment assets comprise those assets that are directly attributable to a segment or can be allocated to a segment on a reasonable basis. Segment assets exclude income tax assets and other corporate assets that are managed at the enterprise level unless specifically identified with a reportable segment. Segment liabilities comprise those liabilities that are directly attributable to a segment or can be allocated on a reasonable basis. Segment liabilities exclude income tax liabilities and other corporate liabilities that are managed centrally unless specifically attributable to a reportable segment.

Where a business segment has not commenced commercial operations or has insignificant operating activity during the reporting period, revenue and operating results may be reported as Nil. However, assets and liabilities relating to such segment continue to be disclosed where separately identifiable and monitored by the CODM.

17 Government Grants

i). Grants are accounted for where it is reasonably certain that the ultimate collection will be made. Grants relating to PPE in the nature of Project Capital Subsidy are credited to that particular PPE and others are credited to Statement of Profit and Loss, if any.

18 Employee Benefits

i). Short Term Employee Benefits:

Short-term employee benefits expected to be paid in exchange for the services rendered by employees are recognized undiscounted during the period employee renders services. These benefits include salaries, wages, bonus, performance incentives, etc..

ii). Defined Contribution Plans:

These are plans in which the company pays pre-defined amounts to separate funds and does not have any legal or informal obligations to pay additional sums. These comprise of contributions to Employees Provident Fund. The Company's payment to the defined contributions plans are reported as expenses during the period in which the employees perform the services that the payment covers.

19 Critical Accounting Judgments, Assumptions and Key Sources of Estimation Uncertainty

The preparation of the Financial Statements requires management to make judgements, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities, and the accompanying disclosures, and the disclosure of contingent liabilities at the date of the financial statements. Estimates and assumptions are continuously evaluated and are based on management's experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances. Uncertainty about these assumptions and estimates could result in outcomes that require a material adjustment to the carrying amount of assets or liabilities affected in future periods.

i) Judgements

In the process of applying the Company's accounting policies, management has made the following judgements, which have the most significant effect on the amounts recognised in the financial statements.

a) Evaluation of Indicators for Impairment of Property, Plant and Equipment

The evaluation of applicability of indicators of impairment of assets requires assessment of external factors (significant decline asset's value, significant changes in the technological, market, economic or legal environment, market interest rates etc.) and internal factors (obsolescence or physical damage of an asset, poor economic performance of the asset etc.) which could result in significant change in recoverable amount of the Property, Plant and Equipment.

ii) Assumptions and Estimation Uncertainties

Information about estimates and assumptions that have the significant effect on recognition and measurement of assets, liabilities, income and expenses is provided below. Actual results may differ from these estimates.

a) Useful lives of Property, Plant and Equipment/Intangible Assets

Property, Plant and Equipment/ Intangible Assets are depreciated/amortised over their estimated useful lives, after taking into account estimated residual value. The useful lives and residual values are based on the Company's historical experience with similar assets and taking into account anticipated technological changes or commercial obsolescence. Management reviews the estimated useful lives and residual values of the assets annually in order to determine the amount of depreciation/amortisation to be recorded during any reporting period. The depreciation/amortisation for future periods is revised, if there are significant changes from previous estimates and accordingly, the unamortised/depreciable amount is charged over the remaining useful life of the assets.

b) Contingent Liabilities

In the normal course of business, Contingent Liabilities may arise from litigation and other claims against the Group. Potential liabilities that are possible but not probable of crystallising or are very difficult to quantify reliably are treated as contingent liabilities. Such liabilities are disclosed in the Notes but are not recognised. Potential liabilities that are remote are neither recognised nor disclosed as contingent liability. The management decides whether the matters need to be classified as 'remote', 'possible' or 'probable' based on expert advice, past judgements, experiences etc.

c) Evaluation of Indicators for Impairment of Property, Plant and Equipment

The evaluation of applicability of indicators of impairment of assets requires assessment of external factors (significant decline in asset's value, economic or legal environment, market interest rates etc.) and internal factors (obsolescence or physical damage of an asset, poor economic performance of the idle assets etc.) which could result in significant change in recoverable amount of the Property, Plant and Equipment and such assessment is based on estimates, future plans as envisaged by the Company.

d) Provisions

Provisions and liabilities are recognised in the period when it becomes probable that there will be a future outflow of funds resulting from past operations or events and the amount of cash outflow can be reliably estimated. The timing of recognition and quantification of the liability requires the application of judgement to existing facts and circumstances, which can be subject to change. The carrying amounts of provisions and liabilities are reviewed regularly and revised to take account of changing facts and circumstances.

Subsequently, within a sixty-day period, the Mill Management will provide the agreed-upon compensation to the respective employee as per the terms of the settlement.

- 31** The Company had suspended its operations at Ahmedabad since March 13, 1995 due to financial constraints and labour unrest. The Company was declared as a Sick Unit within the meaning of Section 3(1)(o) of the Sick Industrial (Special Provisions) Act, 1985 (SICA). The Board for Industrial and Financial Reconstruction (BIFR) vide its Order dated August 22, 2006 has discharged the Company from the purview of SICA. The net worth of the Company has been represented by positive signs and recovered from the huge erosion as compared to past years financial results.
- 32** The company had vide its letter dated September 19, 2005 applied to the Income tax Department for granting relief and concessions in accordance with the sanctioned Revival Scheme of BIFR vide their Order dated January 23, 2004. Further, the BIFR vide its discharge Order dated August 22, 2006, issued directives to the Income tax department to exempt the Company from payment of capital gain tax and permit the Company to set off the capital gains, if any, against accumulated losses of the Company. However, the Income tax department filed an appeal before the Appellate Authority for Industrial and Financial Reconstruction (AAIFR) against the said directives of BIFR which was rejected by AAIFR vide its order dated 10th June 2008. In the financial year 2006-07 relevant to A.Y. 2007-08 the Assessing Officer has interpreted the order of BIFR and AAIFR that set-off of accumulated business loss against the Capital Gain beyond 8 years is not allowable and accordingly the demand was raised by the Income Tax Department. The said demand was challenged by the company by filing an appeal before the CIT (Appeal). The CIT(Appeal) has decided the appeal in favour of the company. The Income Tax Department preferred an appeal before the ITAT and the ITAT has given the judgment in favour of the company.
- 33** The Company and the Textile Labour Union arrived at a settlement in respect of employees' dues on February 11, 2008 and the same has been modified by the Honorable High Court of Gujarat on February 15, 2008 as a result of which the Company is liable to pay in respect of such settlement, an amount aggregating Rs. 15 crores (approx.) to 848 employees on the condition precedent, that the payment will be made to the concerned employee within sixty days after his resignation is received and in respect of the employees concerned having hut/chhapra/room/quarter in the mill premises and he is a beneficiary of the settlement/ order, he shall have to first vacate the hut/chhapra/room/quarter occupied by him in the mill premises and shall have to first handover possession thereof to the Mill Management and thereafter, within sixty days period, the Mill Management will pay the amount to the concerned employee as per the consent terms.
