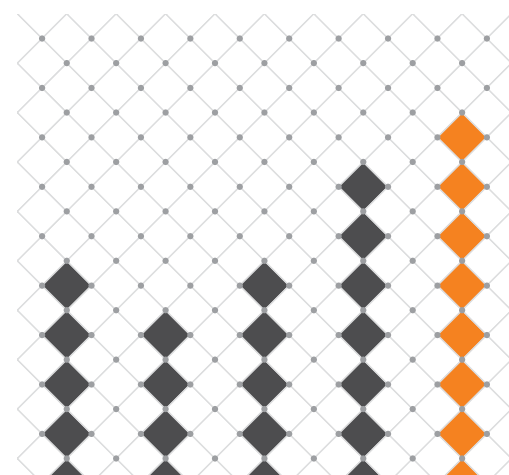

Letter from the Managing Director

Resilient By Design, Growing By Intent

Dear Investors,

Anantapur in Andhra Pradesh is among India's driest and hottest districts. Yet, despite its arid landscape and seasonal rivers, it anchors a substantial part of the country's agricultural economy. The semi-arid region is among India's largest horticulture belts. Last year alone, it produced nearly a quarter of India's bananas, mangoes, pomegranates, guavas and sapotas. That abundance has made it an export hub in its own right, with nearly 80% of its produce reaching Latin America and Southeast Asia.

Technical textiles are helping farmers to adapt to the region's harsh climate. Engineered fabrics lock soil moisture through mulch films and protect crops from intense sunlight using shade nets, enabling farmers to create and regulate microclimates. Similar materials line farm ponds, preventing harvested rainwater from seeping into the district's porous soil. Together, these innovations now cover nearly 950 acres across Anantapur, demonstrating how technical textiles can transform a semi-arid landscape into a productive agricultural ecosystem.

What Anantapur proves in agriculture holds true, in principle, across every sector we serve. Technical textiles are not materials at the margins of an economy; they are active infrastructure, quietly solving real problems and building resilience where it is needed most. That is why the sector is emerging as a critical enabler of India's next phase of growth, strengthening investor confidence while helping build the **Bharat of Tomorrow**.

This conviction is not incidental to our strategy at Rishi Techtex. It shapes our long-term direction. Our products help improve agricultural productivity, support industrial continuity and enhance resource efficiency. As businesses navigate an increasingly uncertain world, we remain focused on delivering reliable, innovative and sustainable solutions that create long-term value for our customers and stakeholders.

FY26 Performance Review

FY26 tested the resilience of many businesses. Rishi Techtex delivered a strong performance, anchored in our strategic focus on high-impact industries. Revenue from operations grew ~17% year-on-year to ₹14,695.28 lakh, while operating profit (EBITDA) expanded ~12% to ₹994.58 lakh (vs. ₹888.72 lakh in FY25). Bottom-line growth remained strong, with Profit Before Tax (PBT) rising ~20% to ₹406.38 lakh and Profit After Tax (PAT) advancing ~9% to ₹249.55 lakh, underscoring the strength of our business model.

Growth alone, however, is not the full story. Equally important was the financial discipline that underpinned it. In an environment marked by raw material volatility and geopolitical uncertainty, we continued to invest selectively in capacity and capability enhancement while maintaining a prudent approach to cost. This discipline strengthened our balance sheet, with net worth rising to ₹3,663.6 lakh in FY26, reflecting improved profitability and a stronger financial position to navigate uncertainty.

Our performance reflects a broader trend shaping India's growth story. Despite disrupted supply chains and volatile commodity markets, India continued to demonstrate strong economic resilience. Rising disposable incomes, rapid urbanization and housing demand supported robust domestic consumption and strengthened business confidence. Collectively, all these factors gave businesses greater impetus to invest, expand, and innovate.

Resilience Results in Growth

For Rishi Techtex, this resilience translated into tangible opportunities. Despite ongoing uncertainty in several export-oriented markets, business was favored by domestic demand across agriculture, manufacturing, and industrial sectors.



Over 70% of our shade net revenues came from the domestic market during the year, with agricultural applications contributing about 75% of segment revenues. As India continues to invest in improving farm productivity and strengthening agricultural resilience, we believe demand for advanced agricultural textiles will also continue to grow. This aligns our growth directly to the long-term modernization of Indian agriculture and the accelerating adoption of technology-driven farming practices.



In our Packtech business, which is entirely focused on the domestic market, we serve category-leading companies such as Asian Paints. During the year under review, we also commenced supplies to new market entrants, including Birla Opus, Pidilite Industries and Kajaria Ceramics. While these companies compete for market share, the expansion of the overall market creates opportunities across the value chain. As their supplier, Rishi Techtex is well positioned to participate in this growth.



India's sustained investment in infrastructure, urban development and industrial expansion presents long-term opportunities for our Buildtech segment. As quality and safety standards gain wider acceptance across the construction ecosystem, we expect demand for our specialized technical textile solutions to strengthen and become more sustained.



In the Protech segment, we manufacture specialized products, including fire-retardant and safety netting solutions. While domestic demand remained limited during FY26, growing awareness of workplace safety, ESG considerations and evolving regulatory standards are expected to create new opportunities over time.



We are pursuing growth beyond traditional sales channels by making technical textile solutions easier for retail consumers to adopt. As we build a tailored D2C offering of ready-to-use products in standardized sizes on retail e-commerce sites like Amazon, we are also strengthening our brand presence. This approach marks a significant step towards democratizing access to technical textile solutions for a wider customer base that is largely untapped and has considerable growth potential.



In an environment marked by raw material volatility and geopolitical uncertainty, we continued to invest selectively in capacity and capability enhancement while maintaining a prudent approach to cost.

Together, these trends affirm our conviction that India's growth story is increasingly being driven by domestic strengths across the segments we serve, rather than external demand alone. This shift continues to shape our focus on the most sustainable avenues for growth.

Automation, Technology, and Future Capability

Over the years, Rishi Techtex has earned a reputation for quality, reliability and product performance. In FY26, we continued to invest in automation and technology to strengthen our competitive advantages. Greater operational efficiency has increased capacity, improved overall productivity and kept per-unit costs under control, while reducing the need for a corresponding increase in workforce. These strengths, combined with our service capabilities, have positioned Rishi Techtex as a preferred partner for leading manufacturing companies.

In this context, robotics can play an exciting role in the future of manufacturing, with the potential to optimize resource utilization, improve process consistency and help us move closer to zero-defect manufacturing. We are still early in this journey but we are actively

evaluating opportunities to deploy application-specific robotics and intelligent automation across our operations in the near future.

Further, during FY26, we continued to strengthen the foundation of our organization—our talent—through targeted development programmes and selective hiring in key functions. While maintaining a lean and agile structure, we remain committed to nurturing future-ready talent and building a high-performance workforce aligned with the Company's long-term growth ambitions.

Path Forward

As we look ahead, our objective remains clear: to create products that are not only technically superior, but also relevant, accessible and impactful. By combining innovation, operational excellence, and a deep understanding of our customers, we are building a business well positioned to contribute to India's next phase of growth while creating enduring value for all our stakeholders.

None of this would have been possible without the trust and commitment of our Board, employees, customers, partners, bankers and shareholders. On behalf of the entire Rishi Techtex family, I extend my sincere gratitude to each one of you.

We enter the next phase of our journey with confidence, humility and a shared sense of purpose. Together, we will continue to innovate, create meaningful impact and build a stronger, more resilient future.

The Directors have furnished the requisite declaration and consent for their appointment / re-appointment.
5. Pursuant to the provisions of the Act, a Member entitled to attend and vote at the AGM is entitled to appoint a proxy to attend and vote on his/her behalf and the proxy need not be a Member of the Company. However, since this AGM is being held pursuant to the MCA Circulars through VC / OAVM, physical attendance of Members has been dispensed with. Accordingly, the facility for appointment of proxies by the Members will not be available for the AGM and hence the Proxy Form and Attendance Slip are not annexed to this Notice.
6. Pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 (as amended) and Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (as amended), and MCA Circulars dated April 08, 2020, April 13, 2020 and May 05, 2020 the Company is providing facility of remote e-voting to its Members in respect of the business to be transacted at the 42nd AGM. For this purpose, the Company has entered into an agreement with Central Depository Services (India) Limited (CDSL) for facilitating voting through electronic means, as the authorized e-Voting agency. The facility of casting votes by a member using remote e-voting as well as the e-voting system on the date of the AGM will be provided by CDSL.
7. The attendance of the Members attending the AGM through VC/OAVM will be counted for the purpose of reckoning the quorum under Section 103 of the Act.
8. The Members can join the AGM in the VC/OAVM mode 15 minutes before and after the scheduled time of the commencement of the Meeting by following the procedure mentioned in the Notice. The facility of participation at the AGM through VC/OAVM will be made available to at least 1000 members on first come first served basis. This will not include large Shareholders (Shareholders holding 2% or more shareholding), Promoters, Institutional Investors, Directors, Key Managerial Personnel, the Chairpersons of the Audit Committee, Nomination and Remuneration Committee and Stakeholders Relationship Committee, Auditors etc. who are allowed to attend the AGM without restriction on account of first come first served basis.
9. 10. In case of the Joint holders attending the 42nd AGM, only such joint holder who is higher in the order of names will be entitled to vote.
11. As per Regulation 40 of SEBI Listing Regulations, as amended, securities of listed companies can be transferred only in dematerialized form with effect from, April 1, 2019, except in case of request received for transmission or transposition of securities. In view of this and to eliminate all risks associated with physical shares and also for ease of portfolio management, members holding shares in physical form are requested to consider converting their holdings to dematerialized form. Members can contact the Company or Company's Registrars and Transfer Agents, Adroit Corporate Services Private Limited for assistance in this regard.
12. Updation of PAN and other details

SEBI has mandated the submission of PAN, KYC details and nomination by holders of physical securities before October 1, 2023, and linking PAN with Aadhaar by June 30, 2023 or any other date as may be specified by the Central Board of Direct Taxes ("CBDT") vide its circular dated March 16, 2023.

Members may note that as per SEBI Master Circular No. SEBI/HO/MIRSD/POD-1/P/CIR/ 2024/37 dated May 7, 2024, it is mandatory for all holders of physical securities in listed entities to update their KYC and choice of Nomination with the Registrar and Share Transfer Agent ('RTA'), in case they have not updated the same. As per the SEBI Circular, effective from April 1, 2024, RTA will attend to all service requests of the shareholders with respect to transmission, dividend, etc., only after updating the above details in the records.

Shareholders are requested to submit their PAN, KYC and nomination details to the Company's RTA. The forms for updating the same are available at www.rishitechtext.com. In case a holder of physical securities fails to furnish PAN and KYC details by October 1, 2023 or link their PAN with Aadhaar before June 30, 2023 or any other date as may be specified by the CBDT, in accordance with the SEBI circular dated March 16, 2023, Company / RTA will be obligated to freeze such folios. 14. Special Window for lodgement of physical share transfer requests:
A special window, as per mandate of SEBI, is available till February 4, 2027, to facilitate lodgement of transfer requests executed before April 1, 2019 but were either not lodged for transfer or were lodged and subsequently rejected, returned or not attended due to deficiency in the documents. Eligible shareholders are requested to submit the requisite documents before February 4, 2027 to Company/RTA. Securities transferred through this mechanism shall be credited only in dematerialized form and will remain under a one year lock in, during which they cannot be transferred, lien marked, or pledged. [SEBI Master Circular No. HO/38/13/(4)2026-MIRSD-POD/ 1/4298/2026 dated February 6, 2026] The Company has communicated the opening of this special window through newspaper advertisements to the Shareholders.
15. SEBI has introduced DigiLocker as a Digital Public Infrastructure to reduce unclaimed securities in the Indian Securities Market. DigiLocker is digital documents wallet of Government of India facilitating investors to securely store and access Issued Documents, demat holdings etc., along with a facility to appoint a nominee to their DigiLocker account. In the event of the investor's demise, such nominee(s) will be provided access to the digital information of the deceased investor to initiate the process of transmission of deceased investor's financial assets or to pass the information to surviving joint holder or to legal heirs. [SEBI Circular No. SEBI/HO/OIAE/OIAE_IAD-3/ P/CIR/2025/32 dated March 19, 2025]
16. To support the 'Green Initiative', Members who have not yet registered their email addresses are requested to register the same with their DPs in case the shares are held by them in electronic form and with Adroit Corporate Services Private Limited in case the shares are held by them in physical form.
17. Members may please note that SEBI vide its Circular No. SEBI/HO/MIRSD/MIRSD_RTAMB/P/CIR/2022/8 dated 25th January, 2022 has mandated Listed Companies to issue securities in demat form only while processing service requests viz. Issue of duplicate securities certificate, claim from Unclaimed Suspense Account, Renewal/ Exchange of securities certificate, Endorsement, Sub-division/ splitting of securities certificate, Consolidation of securities certificates/folios, Transmission and Transposition. 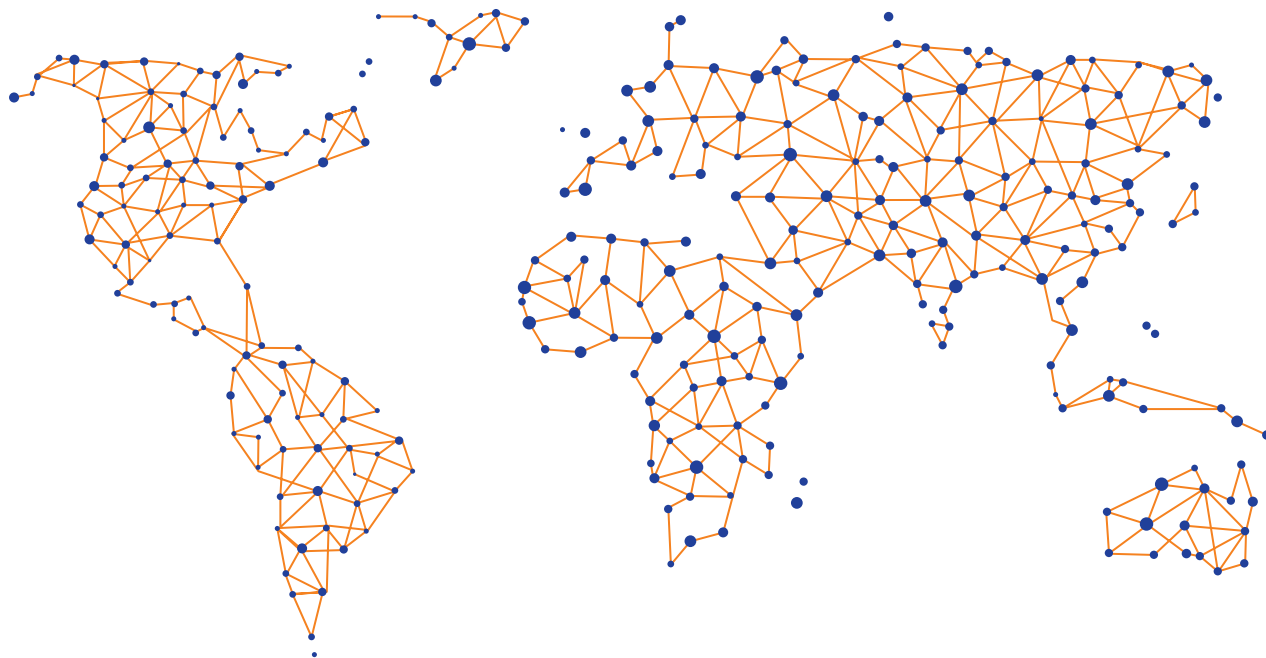

MANAGEMENT DISCUSSION & ANALYSIS

Global Economic Outlook



FY26 was a year of interrupted stabilization. It began as a period filled with the promise of steady global growth, soft inflation and easier financial conditions. But it quickly progressed into a period full of geopolitical uncertainties, shifting dynamics in global supply chains and contraction driven economic growth patterns.

As the fiscal ended, risks remain skewed to the downside. These include escalating military hostilities, further commodity market disruptions, and additional geopolitical strains (refer Chart I: Global GDP Growth). According to the June 2026 edition of the World Bank's Global Economic Prospects report, global growth moderated to 2.5% in 2026 following a period of relative stabilization despite ongoing trade pressures. The slowdown was also attributed to the sharp energy price increases driven by the Middle East conflict.

Emerging market and developing economies (EMDEs) grew by 3.6%. This reflects a moderation in economic activity and persistent inflationary pressures.

These challenges were exacerbated by escalating foreign barriers, and continued policy uncertainty that led to subdued foreign direct investment in these economies. On the other hand, advanced economies

grew at 1.5%, marking a distinct deceleration due to tightening monetary policies and cooling domestic demand. Advanced economies managed to buffer their slow growth with steady financial markets and early-mover advantages in high-value tech sectors like artificial intelligence (AI) and advanced manufacturing. EMDEs however, struggled under a heavier burden.

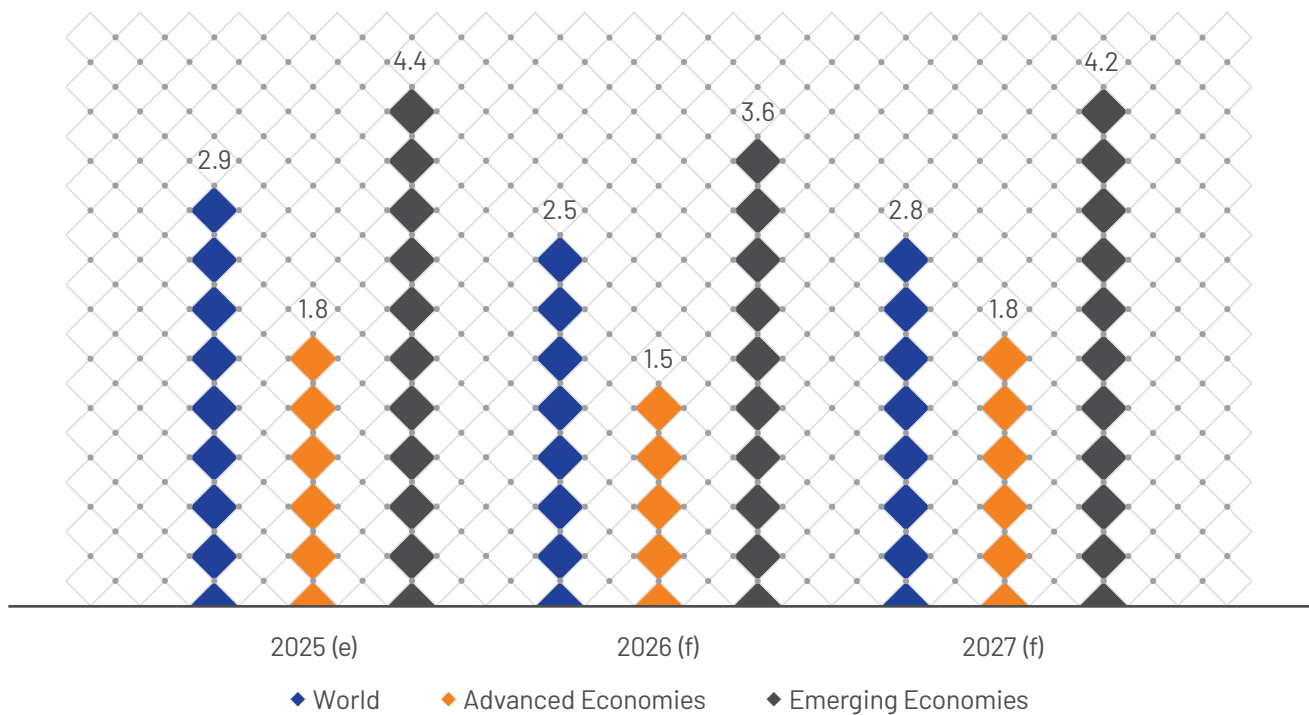
Global trade reflected the consequences of the rapidly changing macroeconomic dynamics mentioned above. The landscape witnessed a tactical shift during different parts of the year.

Demand Distortion Cycle:

During the first half of the year, global corporations aggressively pulled their import schedules forward. This was in response to the anticipated severe new tariff hikes, trade wars (particularly involving the US and China), and rising protectionist barriers.

In the latter part of the year, this artificial demand evaporated as new tariff regimes gradually settled. For exporters, navigating this period required significant agility in production scheduling, capacity utilization, and working capital management to avoid inventory overhangs.



Input Cost Volatility and Energy Squeezes:

Technical textiles rely heavily on synthetic polymers, specialized chemicals, and high-performance fibers. Thus, the sector is intrinsically tied to downstream petrochemical and energy markets.

The sharp escalation in crude oil prices due to the Hormuz embargo toward the end of the fiscal year, triggered by the USA-Iran conflict, compressed manufacturing margins across the value chain. Companies operating without diversified sourcing footprints faced severe margin pressures.



The Onset of the 'Next Normal':

In FY26, businesses around the world increasingly operated in an environment characterized by higher volatility. This required greater agility in sourcing, production planning and risk management.

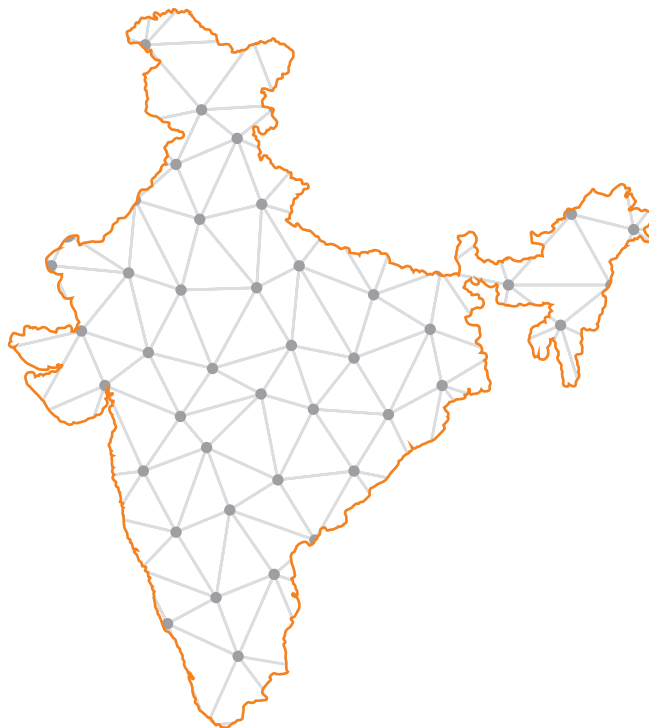
The near-term environment marked by continued energy-driven inflation, shifting geopolitical alignments, and varying regional growth velocities continues to face persistent headwinds. At the same time, it also presents distinct opportunities for organizations equipped with agile decision-making structures and diversified footprints.

Simply put, even as the global economy transitions past the complexities of the previous fiscal, the macroeconomic landscape remains anchored in a state of watchful calibration.

India Economic Performance

India continued to demonstrate resilience and growth amid an uncertain global environment. In FY26, the real GDP registered a robust growth of 7.4%, supported by the double engine of consumption and investment.

The June 2026 edition of the World Bank's Global Economic Prospects notes that India's, 'private consumption, particularly in rural areas, has been strong, with urban demand recovering. Collections of taxes from domestic sales have also increased steadily. To mitigate the price pressures arising from higher energy costs, as well as shortages of agricultural products, especially fertilizers, several measures have been implemented, including a reduction in fuel taxes.'



Broad-based Consumption Demand:

This strength in consumption reflects a supportive macroeconomic environment. Low inflation, stable employment conditions, and rising real purchasing power continue to underpin consumer spending.

Together, these trends suggest that the momentum in consumption demand is broad-based.



Investment-led Growth Momentum:

The second crucial driver of India's economic outperformance has been a sustained investment cycle. This momentum is anchored by the central government's continued capital expenditure on core infrastructure —spanning logistics, digital public infrastructure, and industrial corridors.

Crucially, this public spending has effectively driven private capital expenditure, prompting domestic enterprises to scale up capacity utilization and invest in advanced manufacturing.



A Stable Policy Environment:

India continued to benefit from policy continuity and long-term economic reforms. These measures provided businesses with greater visibility on infrastructure development, manufacturing incentives, and investment planning.

A consistent policy environment also helped the country capitalize on evolving global supply chain dynamics while protecting domestic businesses against external shocks.

In the ensuing fiscal (FY27), the World Bank expects India's growth to moderate to -6.6%. However, ongoing trade agreements and structural reforms aimed at improving the business environment are expected to support foreign direct investment inflows and sustain economic momentum.

Industry Update

Technical textiles represent a high-value segment of the textile industry, comprising products developed for their functional and performance characteristics rather than decorative or apparel applications. These engineered materials are used across diverse sectors such as agriculture, industrial packaging & manufacturing, defense, environmental protection, construction and transportation.

With their ability to improve safety, productivity, durability, and sustainability, technical textiles have evolved from a niche category into a vital enabler of innovation and growth across the global economy.

Global Update

The global technical textiles market continued its strong growth trajectory in FY26. Estimated at approximately US\$255 billion in 2025, it is projected to expand to US\$272 billion in 2026 and reach nearly US\$481 billion by 2035, reflecting a CAGR of about 6.6%. Growth is being driven by rising demand from infrastructure, healthcare, mobility, industrial manufacturing, defense, and sustainability-focused applications.

Unlike traditional textiles, where growth is often volume-led, the technical textiles sector is increasingly characterized by demand for high-value, application-specific, and performance-engineered premium materials. This trend underscores the sector's transformation from a niche segment within the broader textiles industry into a critical enabler of modern industrial and infrastructure development. Consequently, the industry is also witnessing evolving industrial requirements, increasingly demanding regulatory standards, and a growing emphasis on sustainability across sectors.

Domestic Update

The Indian technical textiles industry continued its strong growth trajectory in FY26, supported by favorable policy measures, increasing investments, and expanding export opportunities. In 2026, the Indian technical textiles market size was approximately US\$45 billion, making it the fifth largest in the world. The sector is projected to reach US\$123 billion by 2035, and US\$ 309 billion by 2047 growing at an estimated CAGR of around 8%.

During the year, the Government of India further reinforced its commitment to the technical textile sector through a series of initiatives. In the Union Budget 2026-27, the government allocated ₹256 crore to the National Technical Textiles Mission (NTTM) to promote innovation, research, and indigenous product development. Additionally, ₹405 crore was earmarked under the Production Linked Incentive (PLI) Scheme to encourage large-scale manufacturing and strengthen India's export competitiveness in Man-Made Fiber (MMF) and technical textile products.

Further, the technical textile industry's export outlook also received a significant boost from the India-UK Comprehensive Economic and Trade Agreement (CETA). With duty-free access to the UK market, India's exports to the country are expected to increase from approximately US\$240 million currently to US\$1 billion by 2030, creating new growth opportunities for domestic manufacturers and exporters.

Performance Analysis

In FY26, despite macro-economic challenges, Rishi Techtex registered ~17% year-on-year growth in revenue, which increased to ₹14,695.28 lakhs from ₹12,562.23 lakhs in FY25. This growth was driven by strong volume expansion in the woven division, supported by rising domestic demand across key end-use sectors.

During the year the company invested in fixed assets and also saw stronger revenue growth, improved profitability and a significant expansion of your Company's manufacturing asset base.

Your Company's balance sheet continued to strengthen during FY26, with net worth increasing by 7.3% to ₹3,663.6 lakhs from ₹3,414.5 lakhs in FY25. This growth was supported by sustained profitability and internal accruals. Operating profit (EBITDA) increased by ~12%, from ₹888.72 lakhs in FY25 to ₹994.58 lakhs in FY26. Profit Before Tax (PBT) rose by ~20%, from ₹337.66 lakhs to ₹406.38 lakhs, while Profit After Tax (PAT) grew by ~9%, from ₹229.94 lakhs to ₹249.55 lakhs.

Profitability growth moderated towards the end of the year due to a sharp increase in raw material prices. It rose by as much as 45% over a short period following supply chain disruptions arising from geopolitical developments in the Middle East.

Although inventory turnover moderated to 18.19x in FY26 from 19.69x in FY25, the movement was in line with your Company's strategy of maintaining adequate inventory levels to support higher production volumes and mitigate supply chain uncertainties amid volatile raw material markets. It is pertinent to note that, despite this moderation, inventory growth remained significantly lower than revenue growth during the year, reflecting continued discipline in inventory management.

Overall, FY26 was a year of healthy growth, improved profitability and strategic capacity creation for Rishi Techtex. Through continued investment in its manufacturing infrastructure, expansion of its asset base and enhancement of operational capabilities, your Company has further strengthened its platform for long-term growth and is well positioned to capitalize on emerging opportunities across its target markets.

Key Performance Drivers and Challenges

In FY26, several external factors constrained the pace of growth and created pressure on margins.

- ◆ **Sharp Increase in Raw Material Prices:**
Towards the end of the year, key polymer raw material prices increased by nearly 45% within a short period following disruptions in global supply chains. This impacted profitability, particularly in businesses where price revisions could not be implemented immediately.
- ◆ **Geopolitical and Logistics Disruptions:**
The conflict in the Middle East affected global shipping routes, resulting in higher freight and insurance costs. These disruptions impacted exports and increased overall supply chain uncertainty.
- ◆ **Subdued Export Demand:**
Export markets, particularly in the Middle East, continued to face logistical challenges and elevated transportation costs. As a result, exports remained below pre-pandemic levels, limiting growth opportunities in the Knitted Solutions business.
- ◆ **Slow Adoption of Advanced Agricultural Products:**
Despite increasing awareness of climate-related challenges, adoption of higher-value agricultural solutions such as reflective and climate-management nets remained gradual, particularly among price-sensitive farming communities.
- ◆ **Regulatory Gaps in Emerging Applications:**
Demand in segments such as construction safety and fire-retardant nets continued to be subdued due to the absence of stronger regulatory standards and compliance, limiting the pace of growth.

Overall, the year under review witnessed frequent shifts in demand patterns, uncertainty surrounding global trade flows and fluctuating input costs. A culmination of these factors required greater planning agility and working capital discipline throughout the year.

FY26 Performance Highlights

FY26 was a year of strong growth for the Woven Division, driven by robust domestic demand, superior customer service, and deeper engagement with large industrial customers. The division emerged as the primary growth engine for your Company, recording an increase of approximately 1,000 tons in bag sales compared to the previous year.

The division benefited from strong customer retention and increasing demand from large organized players that value consistent quality, dependable deliveries, product customization, and supply-chain reliability. Its predominantly domestic customer base also provided resilience against export market disruptions and geopolitical uncertainties, enabling stable business growth throughout the year.

Operational Update:

To support growing demand and strengthen its competitive position, your Company continued to invest in capacity enhancement and process optimization initiatives during the year.

Key developments included:

- ◆ Commissioning of a second state-of-the-art automated lamination plant, enabling complete in-house lamination and eliminating dependence on outsourced processing.
- ◆ Addition of finishing equipment to improve throughput, reduce manual labor and manufacturing flexibility.
- ◆ Expansion of monthly production capacity from approximately 55 lakh bags to 65-67 lakh bags.
- ◆ Continued benefits from automation and process mechanization initiatives implemented over the past few years.

These investments enabled the division to significantly increase output without a corresponding increase in manpower, resulting in enhanced productivity, lower per-unit operating costs, and improved operating efficiencies.

Business Update:

The Woven Division continued to strengthen its relationships with leading industrial customers by delivering consistent product quality, responsive service, and reliable supply.

During the year, your Company expanded engagement with both existing and new customers, including:

- ◆ Progress in onboarding emerging industry players and expanding its customer portfolio.
- ◆ Initial supplies to Birla Opus (Aditya Birla Group) and Kajaria Ceramics with opportunities expected to scale alongside the customer's capacity expansion plans.
- ◆ Enhancement of supplies to Pidilite Industries as part of efforts to integrate into the customer's supply chain.
- ◆ Continued strengthening of long-standing relationships with major customers such as Asian Paints.

Your Company's ability to support customers with multiple product variants, short lead times, and dependable deliveries continues to differentiate it in a highly competitive industry and positions it favorably for long-term growth.

Segment Review: Knitted Solutions

Knitted fabrics are widely used in technical textile applications owing to their flexibility, durability, excellent bonding properties, and resistance to heat, chemicals, and corrosion. These fabrics can be produced from a single material or engineered using a combination of materials such as metals, plastics, monofilaments, and fibers, enabling a high degree of customization. Additionally, their lightweight structure enhances functional performance while minimizing the overall weight of the finished product.

Rishi Techtex is among India's established manufacturers of knitted technical textile solutions, serving the evolving needs of the agriculture, horticulture, infrastructure, and industrial sectors. We specialize in high-performance knitted fabrics engineered to enhance productivity, improve environmental protection, and support sustainable resource utilization.

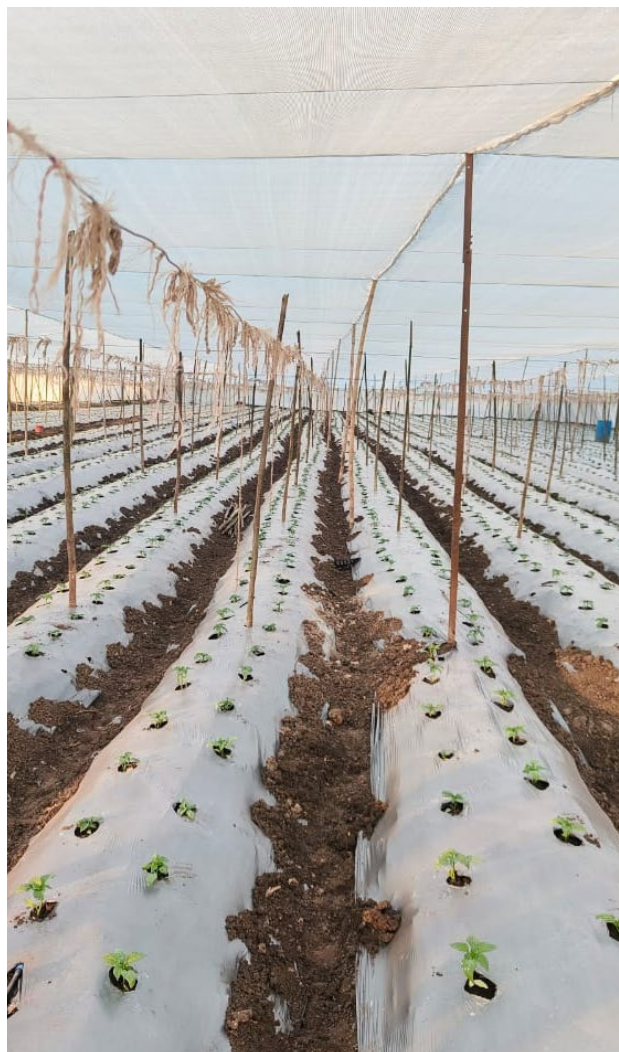

FY26 Performance Highlights

In FY26, the Knitted Division demonstrated resilience and strategic discipline amid a challenging operating environment marked by geopolitical uncertainties, elevated logistics costs, and subdued export demand. A key highlight of the year was the growing traction of high-value knitted solutions, particularly metallized reflective nets, whose sales nearly doubled during the year and contributed to a richer product mix.

During the year, your Company also strengthened its foundation for future growth through retail channel development, enhanced product offerings, and continued efforts to align its products with global quality benchmarks.

Operational Update

In FY26, your Company strengthened the quality and durability of its knitted product portfolio through continued investments in research and development. As a result, several products now meet global performance benchmarks and offer enhanced service life. The Company also advanced the development of specialized agricultural solutions tailored to evolving climate-resilience and crop-protection needs, reinforcing its leadership in the segment.

Key highlights:

- ◆ Revenue contribution of the Knitted Division moderated from approximately 38% to 31.5% of total revenue as the woven bags business witnessed significantly faster growth during the year.
- ◆ However, the Division continued to maintain a strong domestic orientation and largely unaffected by export headwinds:
 - Over 70% of sales derived from the domestic market
 - Approximately 75% of revenue generated from agricultural applications
- ◆ Export performance remained subdued due to the continued disruptions in key Middle Eastern markets, elevated freight rates and geopolitical uncertainties. Thus, exports contributed approximately 25% of business revenues.

The Knitted Division is increasingly evolving into a value-focused, margin-led business, prioritizing specialized solutions and product differentiation over volume expansion.

Business Update:

In FY26, your Company continued to strengthen its value-added product portfolio, with premium solutions contributing to an improved product mix and supporting a margin-led growth strategy.

- ◆ Sales of premium metallized (silver) reflective nets increased from approximately 15 tons in FY25 to 28 tons in FY26, reflecting growing customer acceptance of advanced climate-control and management solutions.
- ◆ Demand for specialized knitted products was supported by large greenhouse operators and quality-focused agricultural producers seeking improved temperature control, crop protection and productivity enhancement.
- ◆ Discussions with international players in Israel and Australia for third-party manufacturing opportunities highlighted the growing acceptance of the Company's products and capabilities in global markets.
- ◆ To expand market reach, the Company progressed initiatives aimed at strengthening its omnichannel presence through B2B platforms and direct-to-customer (B2C) retail offerings, creating new avenues for future growth.

Overall, during the year under review, the Knitted Division leveraged product innovation, import substitution opportunities and premium product offerings to drive sustainable growth.

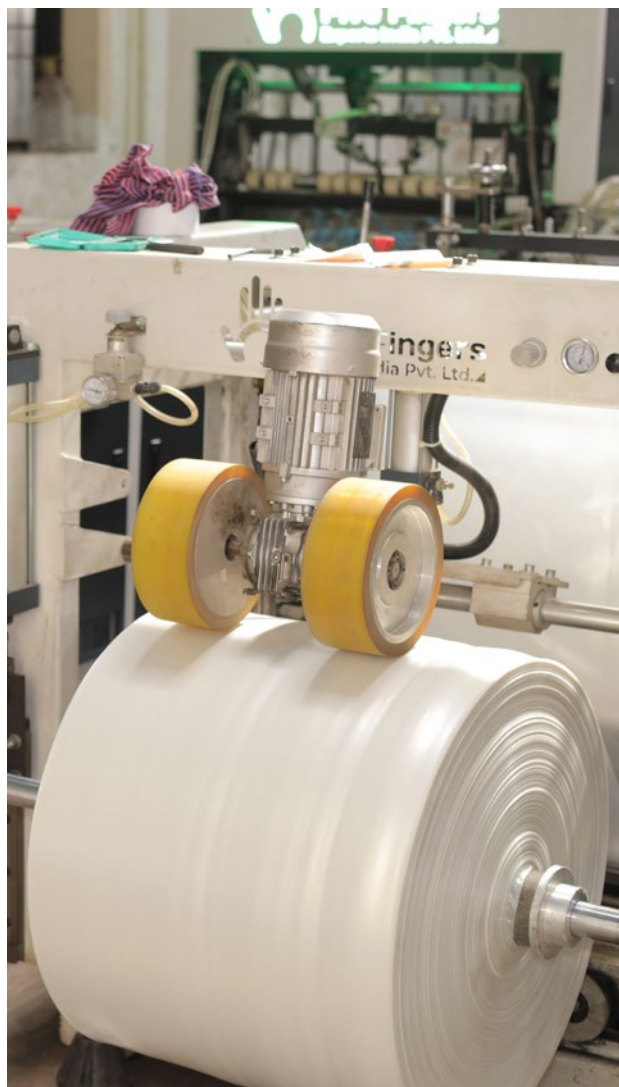

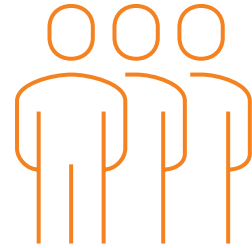

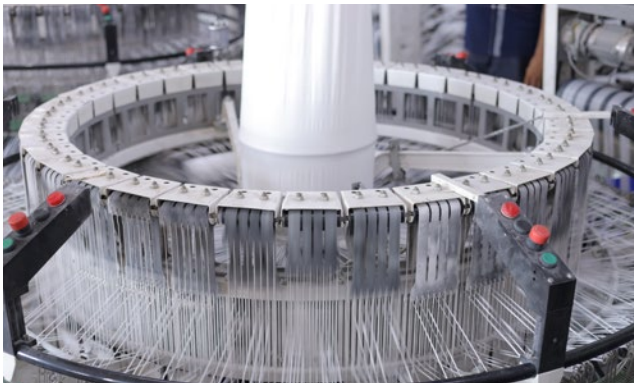

BOARD OF DIRECTORS (as on 31.03.2026):

As on the date of Balance sheet; the Board of Directors of the Company consisted of Four Directors. The Chairman and Managing Director of the Company, an Executive Director is a promoter of the Company, Two are independent Directors within the meaning of the Companies Act 2013 ("the Act") and one is Non-Executive Non-Independent Promoter Director. Except Mr. Abhishek Patel and Mrs. Aakanksha Mikhail Verma; no other directors are inter se related to each other. The Company has complied with the requirement of having atleast half of the Board comprising of Independent Directors as the Chairman of the Board is an Executive Director. The composition of the Board is in conformity with Regulation 17 of the SEBI Listing Regulations read with Section 149 of the Act.

As required under Regulation 17A & 26(1) of SEBI Listing Regulations and as confirmed by directors, none of the Directors on the Board of Company was a Director (including holding any alternate directorships) in more than 10 public limited companies (as specified in Section 165 of the Act) and Director in more than 7 equity listed entities or acted as an Independent Director in more than 7 equity listed entities. Further, as on March 31, 2026, none of the Directors on the Board was a Member of more than 10 Committees across all the Indian public limited companies in which he/she was a Director. As on the date of Balance sheet; there is no Nominee Director on the Board of the Company.

A certificate from M/s. Sudhanwa S. Kalamkar & Associates, Company Secretary in practice, pursuant to Regulation 34(3) and Schedule V Para C clause (10) (i) of the SEBI Listing Regulations, stating that none of the directors on the Board of the Company have been debarred or disqualified from being appointed or continuing as directors of companies by SEBI/ Ministry of Corporate Affairs or any other statutory authority is annexed to this report.

The appointment of Independent Directors is carried out in a structured manner in accordance with the provisions of the Act and the SEBI Listing Regulations. The Nomination & Remuneration Committee identifies candidates based on laid down criteria and takes into consideration the balance of skills, knowledge and experience in addition to the need for diversity of the Board and accordingly makes its recommendations to the Board.

Independent Directors are non-executive directors as defined under Regulation 16(1)(b) of the SEBI Listing Regulations read with Section 149(6) of the Act along with rules framed thereunder. All the Independent Directors have confirmed that they meet the criteria as mentioned in Regulation 16(1)(b) of the SEBI Listing Regulations and Section 149(6) of the Act. The Independent Directors provide an annual confirmation that they meet the criteria of independence. Based on the confirmations/ disclosures received from the Independent Directors, the Board is of the opinion that the Independent Directors fulfil the conditions specified in the Act and the SEBI Listing Regulations and are Independent of the Management.

We recognize the importance of having a Board comprising of Directors who have a range of experiences, capabilities and diverse point of view which helps in creating an effective and well-rounded Board. The Board has identified the following skills / expertise / competencies fundamental for the effective functioning of the Company which are currently available with the Board:

Strategy and Planning - Appreciation of long-term trends, strategic choices and experience in guiding and leading management teams to make decisions in uncertain environments.

- Reviewing policies in relation to the implementation of the Prevention of Insider Trading Code to note the dealings by Designated Persons in securities of the Company and to provide directions on any penal action to be initiated, in case of any violation of the said code.

HRK & Co., Chartered Accountants, Vapi, Gujarat (FRN : 146985W), the Statutory Auditors of the Company, appointed by the shareholders at its 39th AGM held on 15th September, 2023 for a term of 5 financial years is responsible for performing Independent Audit of the Financial Statements and expressing an opinion on the conformity of those Financial Statements with the Accounting Principles generally accepted in India.

The Audit committee annually reviews the confirmation of Independence made by the Auditors and on a quarterly basis and also approves of the fees paid to the Auditors by the Company.

Nomination & Remuneration Committee:

In terms of Regulation 19 of the SEBI Listing Regulations and Section 178 of the Act, the Nomination and Remuneration Committee, as on March 31, 2026, comprised of 3 (Three) Directors. The Nomination & Remuneration committee consists of three Directors, Mr. Kunal Rastogi, Mr. Pranab Chatterjee and Mrs. Aakanksha Mikhail Verma. Mr. Kunal Rastogi is chairman of the Committee.

The Board has on the recommendation of the Nomination & Remuneration Committee framed a Policy for selection and appointment of Directors, Senior Management and their remuneration. The same is posted on the website of the Company viz. www.rishitechtext.com. Remuneration Committee approves the remuneration payable to the Managing Director and senior executives.

The salient features of the said policy are as under:

POLICY FOR APPOINTMENT AND REMOVAL OF DIRECTOR, KMP AND SENIOR MANAGEMENT

1. Appointment Criteria and Qualifications

- a) The Committee shall identify and ascertain the integrity, qualification, expertise and experience of the person for appointment as Director, KMP or at Senior Management level and recommend to the Board his / her appointment.
- b) A person should possess adequate qualification, expertise and experience for the position he / she is considered for appointment. The Committee has discretion to decide whether qualification, expertise and experience possessed by a person is sufficient / satisfactory for the concerned position.
- c) The Company shall not appoint or continue the employment of any person as Whole-time Director who has attained the age of seventy years. Provided that the term of the person holding this position may be extended beyond the age of seventy years with the approval of shareholders by passing a special resolution based on the explanatory statement annexed to the notice for such motion indicating the justification for extension of appointment beyond seventy years.

2. Term / Tenure

- a) Managing Director/Whole-time Director: The Company shall appoint or re-appoint any person as its Executive Chairman, Managing Director or Executive Director for a term not exceeding five years at a time. No re-appointment shall be made earlier than one year before the expiry of term.
- b) Independent Director: An Independent Director shall hold office for a term up to five years on the Board of the Company and will be eligible for re-appointment on passing of a special resolution by the Company and disclosure of such appointment in the Board's report. No Independent Director shall hold office for more than two consecutive terms of upto maximum of 5 years each, but such Independent Director shall be eligible for appointment after expiry of three years of ceasing to become an Independent Director.

Provided that an Independent Director shall not, during the said period of three years, be appointed in or be associated with the Company in any other capacity, either directly or indirectly. At the time of appointment of Independent Director it should be ensured that number of Boards on which such Independent Director serves is restricted to seven listed companies as an Independent Director and three listed companies as an Independent Director in case such person is serving as a Whole-time Director of a listed company or such other number as may be prescribed under the Act.

3. Evaluation

The Committee shall carry out evaluation of performance of every Director, KMP and Senior Management Personnel at regular interval (yearly).

4. Removal

Due to reasons for any disqualification mentioned in the Act or under any other applicable Act, rules and regulations thereunder, the Committee may recommend to the Board with reasons to be recorded in writing, removal of a Director, KMP or Senior Management Personnel subject to the provisions and compliance of the said Act, rules and regulations.

5. Retirement

The Director, KMP and Senior Management Personnel shall retire as per the applicable provisions of the Act and the prevailing policy of the Company. The Board will have the discretion to retain the Director, KMP, Senior Management Personnel in the same position/ remuneration or otherwise even after attaining the retirement age, for the benefit of the Company.

POLICY FOR REMUNERATION TO DIRECTORS/KMP/SENIOR MANAGEMENT PERSONNEL

1. Remuneration to Managing/Whole-time / Executive / Managing Director, KMP and Senior Management Personnel: The Remuneration/ Compensation/ Commission etc. to be paid to Director / Managing Director etc. shall be governed as per provisions of the Companies Act, 2013 and rules made thereunder or any other enactment for the time being in force.
2. Remuneration to Non-Executive / Independent Director: The Non-Executive Independent Director may receive remuneration / compensation / commission as per the provisions of Companies Act, 2013. The amount of sitting fees shall be subject to ceiling/ limits as provided under Companies Act, 2013 and rules made thereunder or any other enactment for the time being in force.

The terms of reference to the Committee broadly are as under:

The Board has framed the Nomination and Remuneration Committee Charter which ensure effective Compliance of Section 178 of the Act and Regulation 19 of SEBI Listing Regulations, which are as follows:

- Reviewing the overall compensation policy, service agreements and other employment conditions of Managing/Whole-time Director(s) and Senior Management (one level below the Board);
- to help in determining the appropriate size, diversity and composition of the Board;
- to recommend to the Board appointment/reappointment and removal of Directors;
- to frame criteria for determining qualifications, positive attributes and independence of Directors;
- to recommend to the Board remuneration payable to the Directors (while fixing the remuneration to Executive Directors the restrictions contained in the Companies Act, 2013 are to be considered);
- to create an evaluation framework for Independent Directors and the Board;
- to provide necessary reports to the Chairman after the evaluation process is completed by the Directors;
- to assist in developing a succession plan for the Board;

- to assist the Board in fulfilling responsibilities entrusted from time-to-time;
- delegation of any of its powers to any Member of the Committee or the Compliance Officer.

Notes to the IndAS Financial statements as at and for the year ended 31st March, 2026

1. General information:

Rishi Techtex Limited is a public company incorporated and domiciled in India. Its shares are listed on the recognized stock exchange, namely BSE Limited, in India. The registered office of the Company is located at 612, V. K. Industrial Estate, 10-14, Pais Street, Byculla (West), Mumbai 400011.

The Company is engaged in manufacturing of Shade nets and Plastic Woven Sacks and supplying to fertilizer and cement industry. Company has consistently developed number of products to cater to a wide spectrum of industries such as cement, fertilizer, chemical Petrochemical, etc.

These financial statements were authorized for issue by the Board of Directors on May 29, 2026.

2. Summary of Material Accounting Policies

This note provides a list of the Material accounting policies adopted in the preparation of these financial statements. These policies have been consistently applied to all the years presented, unless otherwise stated.

i. Basis of Preparation

a) Statement of Compliance

The financial Statements comply in all material respects with Indian Accounting Standards (Ind AS) notified under Section 133 of the Companies Act, 2013 ("the Act") [Companies (Indian Accounting Standards) Rules, 2015] and other relevant provisions of the Act.

b) Historical cost convention

The financial statements have been prepared on a historical cost convention and on an accrual basis, except for certain items that are measured at fair value as required by relevant Ind AS:

- Financial assets and financial liabilities measured initially at fair value (refer accounting policy on financial Instruments);
- Defined benefit and other long-term employee benefits.
- The financial statements are presented in INR and all values are rounded to the nearest lakhs, except when otherwise indicated.

ii. Use of estimates

The preparation of the financial statements in conformity with Indian GAAP requires the Management to make estimates and assumptions considered in the reported amounts of assets and the liabilities (including contingent liabilities) and the reported income and expenses during the year. The management believes that the estimates used in preparation of the financial statements are prudent and reasonable. Future results could differ due to these estimates and the differences between the actual results and the estimates are recognized in the periods in which the results are known or materialized.

iii. Revenue recognition

The Company's contracts with customers could include promises to transfer multiple products and/or services to a customer. The Company assesses the products / services promised in a contract and identify distinct performance obligations in the contract. Identification of distinct performance obligation involves judgement to determine the deliverables and the ability of the customer to benefit independently from such deliverables. For determining the transaction price for the contract and to ascribe the transaction price to each distinct performance obligation, judgment is required. The transaction price could be either a fixed amount of customer consideration or variable consideration with elements such as volume discounts, service level credits, performance bonuses, price concessions and incentives. The transaction price is also adjusted to the transaction price unless it is a payment for a distinct product or service from the customer. The estimated amount of variable consideration is adjusted in the transaction price only to the extent that it is highly probable that a significant reversal in the amount of cumulative revenue recognised will not occur and is reassessed at the end of each reporting period. The Company exercises judgement in determining whether the performance obligation is satisfied at a point in time or over a period of time. The Company considers indicators such as how customer consumes benefits as services are rendered or who controls the asset as it is being created or existence of enforceable right to payment for performance to date and alternate use of such product or service, transfer of significant risks and rewards to the customer, acceptance of delivery by the customer. Revenue for fixed-price contract is recognised using percentage-of-completion method. The Company uses judgement to estimate the future cost-to-completion of the contracts which is used to determine the degree of completion of the performance obligation.

iv. Foreign Currency Transaction

Foreign currency transactions are translated into the functional currency using the exchange rates at the dates of the transactions. Monetary items denominated in foreign currencies at the year-end are restated at closing rates.

Non-monetary items which are carried in terms of historical cost denominated in foreign currency are reported using the exchange rate at the date of the transaction. Non-monetary items that are measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was determined. Translation differences on assets and liabilities carried at fair value are reported as part of the fair value gain/ (loss).

Foreign exchange gain/(loss) resulting from the settlement of such transactions and from the translation of monetary assets and liabilities denominated in foreign currencies at year end exchange rates are generally recognized in profit or loss.

Foreign exchange differences regarded as an adjustment to borrowing costs are presented in the Statement of Profit and Loss, within finance costs. All other foreign exchange gain / (loss) are presented in the Statement of Profit and Loss on a net basis within other income/ (expense).

v. Property, Plant and Equipment

Freehold Land is carried at historical cost. All other items of Property Plant & Equipment are stated at cost of acquisition, less accumulated depreciation and accumulated impairment losses, if any. Direct costs are capitalised until the assets are ready for use and includes freight, duties, taxes and expenses incidental to acquisition and installation. The carrying amount of any component accounted for as a separate asset is derecognised when replaced. All other repairs and maintenance are charged to the statement of profit and loss during the reporting year in which they are incurred. Subsequent expenditures related to an item of Property, Plant & Equipment are added to its carrying value only when it is probable that the future economic benefits from the asset will flow to the Company and cost can be reliably measured. Losses arising from the retirement of, and gains or losses arising from disposal of Property, Plant and Equipment are recognised in the Statement of Profit and Loss.

Depreciation

Depreciation is provided at written down value method according to useful lives of the Assets at the rate specified in Schedule II of the Companies Act, 2013. Depreciation on additions/deletions is provided on pro-rata basis to the months of additions/deletions. The estimated useful life of the Property, Plant and Equipment is as below:

vi. Intangible assets

Intangible assets are stated at acquisition cost, net of accumulated amortisation and accumulated impairment losses, if any. Gains or losses arising from the retirement or disposal of an intangible asset are determined as the difference between the disposal proceeds and the carrying amount of the asset and are recognised as income or expense in the Statement of Profit and Loss.

Intangible Assets with finite useful lives are amortized on a straight line basis over the following period:

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting period.

vii. Impairment of Assets

The Company assesses at each Balance Sheet date whether there is any indication that an asset may be impaired. For the purposes of assessing impairment, the smallest identifiable group of assets that generates cash inflows from continuing use that are largely independent of the cash inflows from other assets or group of assets, is considered as a cash generating unit. If any such indication exists, the Company estimates the recoverable amount of the asset. The recoverable amount is the higher of an asset's fair value less costs of disposal and value in use. If such recoverable amount of the asset or the recoverable amount of the cash generating unit to which the asset belongs is less than its carrying amount, the carrying amount is reduced to its recoverable amount. The reduction is treated as an impairment loss and is recognised in the Statement of Profit and Loss. If at the balance sheet date there is an indication that a previously assessed impairment loss no longer exists or may have decreased, the recoverable amount is reassessed and the asset is reflected at the recoverable amount.

viii. Financial instruments

Financial assets (other than trade receivables) and financial liabilities are recognised when the Company becomes a party to the contractual provisions of the instruments. Financial assets and financial liabilities are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets and financial liabilities at fair value through profit or loss) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at fair value through statement of profit or loss are recognised immediately in the statement of profit or loss.

Financial assets

Classification

The Company classifies its financial assets in the following measurement categories:

- those to be measured subsequently at fair value (either through other comprehensive income, or through profit or loss), and
- those measured at amortised cost. The classification depends on the entity's business model for managing the financial assets and the contractual terms of the cash flows.

Subsequent Measurement

For assets measured at fair value, gains and losses will either be recorded in profit or loss or other comprehensive income.

Amortised cost

Assets that are held for collection of contractual cash flows where those cash flows represent solely payments of principal and interest are measured at amortised cost.

Financial assets at fair value through other comprehensive income (FVTOCI)

A financial asset is measured at FVTOCI if it is held within a business model whose objective is achieved by both collecting contractual cash flows and selling financial assets and the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

Fair value through profit or loss (FVTPL)

Assets that do not meet the criteria for amortised cost or FVTOCI are measured at fair value through profit or loss.

Impairment of financial assets

The Company applies the expected credit loss model for recognising impairment loss on financial assets measured at amortised cost, trade receivables and other contractual rights to receive cash or other financial asset.

For trade receivables or any contractual right to receive cash or another financial asset that result from transactions that are within the scope of Ind AS 115, the Company always measures the loss allowance at an amount equal to lifetime expected credit losses.

Further, for the purpose of measuring lifetime expected credit loss ('ECL') allowance for trade receivables, the Company has used a practical expedient as permitted under Ind AS 109. This expected credit loss allowance is computed based on a provision matrix which takes into account historical credit loss experience and adjusted for forward-looking information.

Derecognition of financial assets:

A financial asset is derecognised only when:

- the Company has transferred the rights to receive cash flows from the financial asset or
- retains the contractual rights to receive the cash flows of the financial asset, but assumes a contractual obligation to pay the cash flows to one or more recipients.

Where the entity has transferred an asset, the Company evaluates whether it has transferred substantially all risks and rewards of ownership of the financial asset. In such cases, the financial asset is derecognised. Where the entity has not transferred substantially all risks and rewards of ownership of the financial asset, the financial asset is not derecognised.

Financial liabilities

All financial liabilities are subsequently measured at amortised cost using the effective interest method or at FVTPL.

Financial liabilities that are not held-for-trading and are not designated as at FVTPL are measured at amortised cost.

Offsetting financial instruments

Financial assets and liabilities are offset and the net amount is reported in the balance sheet where there is a legally enforceable right to offset the recognized amounts and there is an intention to settle on a net basis or realise the asset and settle the liability simultaneously.

ix. Inventories

Raw materials, packing materials, purchased finished goods, work-in-progress, manufactured finished goods, other than specific spares for machinery are valued at lower of cost (which includes duties and taxes, except those subsequently recoverable) net realizable value. Cost is arrived at on moving weighted average basis.

However, materials and other items held for use in the production of inventories are not written down below cost if the finished products in which they will be incorporated are expected to be sold at or above cost. Cost comprises all costs of purchase, costs of conversion and other costs incurred in bringing the inventory to the present location and condition.

x. Trade receivables

Trade receivables that do not contain a significant financing component are measured at transaction price of good sold or services rendered as defined in Ind AS 115, Revenue from Contract with Customers.

xi. Cash and cash equivalents

In the cash flow statement, cash and cash equivalents includes cash on hand, demand deposits with banks, other short-term highly liquid investments with original maturities of three months or less that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

xii. Leases

The Company's lease asset classes primarily consist of leases for land.

At the date of commencement of the lease, the Company recognizes a right-of-use asset ("ROU") and a corresponding lease liability for all lease arrangements in which it is a lessee, except for leases with a term of twelve months or less (short term leases) and low value leases. For these short-term and low value leases, the Company recognizes the lease payments as an operating expense on a straight-line basis over the term of the lease.

The right-of-use assets are initially recognized at cost, which comprises the initial amount of the lease liability adjusted for any lease payments made at or prior to the commencement date of the lease plus any initial direct costs less any lease incentives. They are subsequently measured at cost less accumulated depreciation and impairment losses.

Right-of-use assets are depreciated from the commencement date on a straight-line basis over the shorter of the lease term and useful life of the underlying asset. Right-of-use assets are evaluated for recoverability whenever events or changes in circumstances indicate that their carrying amounts may not be recoverable.

The lease liability is initially measured at amortized cost at the present value of the future lease payments. The lease payments are discounted using the interest rate implicit in the lease or, if not readily determinable, using the incremental borrowing rates in the country of domicile of the leases. Lease liabilities are remeasured with a corresponding adjustment to the related right-of-use asset if the Company changes its assessment if whether it will exercise an extension or a termination option.

Lease liability and ROU asset have been separately presented in the balance sheet and lease payments have been classified as financing cash flows.

The following is the summary of practical expedients elected on initial application:

- Applied the exemption not to recognize right-of-use assets and liabilities for leases with less than 12 months of lease term on the date of initial application.

xiii. Taxation

Income tax expense represents the sum of the tax currently payable and deferred tax.

Current tax

The tax currently payable is based on taxable profit for the year. Taxable profit differs from 'profit before tax' as reported in the statement of profit and loss because of items of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Company's current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary differences to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from the initial recognition (other than in a business combination) of assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax liabilities and assets are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset realised, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period. The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Company expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

Current and deferred tax for the year

Current and deferred tax are recognised in the statement of profit and loss, except when they relate to items that are recognised in other comprehensive income or directly in equity, in which case, the current and deferred tax are also recognised in other comprehensive income or directly in equity respectively.

xiv. Provisions and Contingent Liabilities

The Company recognizes provisions when a present legal or constructive obligation as a result of a past event exists and it is probable that an outflow of resources embodying economic benefits will be required to settle such obligation and the amount of such obligation can be reliably estimated. Provisions are not recognized for future operating losses.

If the effect of time value of money is material, provisions are discounted using a current pre-tax rate that reflects, when appropriate, the risks specific to the liability. When discounting is used, the increase in the provision due to the passage of time is recognized as a finance cost.

A disclosure for a contingent liability is made when there is a possible obligation or a present obligation that may, but probably will not require an outflow of resources embodying economic benefits or the amount of such obligation cannot be measured reliably. When there is a possible obligation or a present obligation in respect of which likelihood of outflow of resources embodying economic benefits is remote, no provision or disclosure is made.

Contingent assets are not recognised in the financial statements; however, they are disclosed where the inflow of economic benefits is probable. When the realization of income is virtually certain, then the related asset is no longer a contingent asset and is recognised as an asset.

Provisions and contingencies are reviewed at each balance sheet date and adjusted to reflect the correct management estimates.

xv. Dividends

Provision is made for the amount of any dividend declared, being appropriately authorised and no longer at the discretion of the entity, on or before the end of the reporting period but not distributed at the end of the reporting period.

xvi. Subsequent events

Financial statements are approved after considering 'Adjusting Event' and 'Non-adjusting event'. Adjustments to assets and liabilities are made for events occurring after the balance sheet date that provide additional information materially affecting the determination of the amounts relating to conditions existing at the balance sheet date or because of statutory requirements or because of their special nature. For non-adjusting events, the Company may provide a disclosure in the financial statements considering the nature of the transaction.

xvii. Earnings per share

Basic earnings per share is computed by dividing the profit after tax before other comprehensive income by the weighted average number of equity shares outstanding during the financial year.

Diluted earnings per share is computed by dividing the profit after tax by the weighted average number of equity and dilutive equity equivalent shares outstanding during the year, except where the results would be anti dilutive.

xviii. Segment reporting

The board of directors assesses performance of the Company as Chief Operating Decision Maker. The Company is operating in single reportable segment of 'Technical Textile' in terms of Ind AS 108. Accordingly, the segment revenue, segment results, segment assets and segment liabilities are reflected in the financial statements themselves as at and for the financial year ended 31st March 2026.

xix. Going Concern

When preparing financial statements, Management makes an assessment of the Company's ability to continue as going concern. Financial Statements is prepared on going concern basis unless management either intends to liquidate the Company or to cease trading, or has no realistic alternative but to do so. When management is aware, in making its assessment, of material uncertainties related to events or conditions that may cast significant doubt upon the Company's ability to continue as going concern, those uncertainties are disclosed. When the financial statements is not prepared on a going concern basis, that fact is disclosed, together with the basis on which the financial statements is prepared and the reason why the Company is not regarded as going concern.

xx. Rounding of amounts

All amounts disclosed in the Financial Statements and notes have been rounded off to the nearest lakhs as per the requirement of Schedule III, unless otherwise stated.

xxi. RECENT ACCOUNTING DEVELOPMENTS:

The following Indian Accounting Standards have been modified on miscellaneous issues with effect from April 1, 2023. Such changes include clarification/guidance on:

Ind AS 1 – Presentation of Financial Statements

The amendment requires companies to disclose their material accounting policies rather than their significant accounting policies. The Company has evaluated the amendment and the impact of the amendment is insignificant in Company's financial statements.

Ind AS 8 – Accounting Policies, Changes in Accounting Estimates and Errors

This amendment has introduced a definition of 'accounting estimates' and included amendments to IndAS 8 to help entities distinguish changes in accounting policies from changes in accounting estimates. The Company has evaluated the amendment and there is no impact on its financial statements.

Ind AS 12 – Income Taxes

This amendment has narrowed the scope of the initial recognition exemption so that it does not apply to transactions that give rise to equal and offsetting temporary differences. The Company has evaluated the amendment and there is no impact on its financial statements.

Ind AS 101 – First time adoption of Ind AS

Deferred tax assets and deferred tax liabilities to be recognized for all temporary differences associated with right-of-use assets, lease liabilities, decommissioning / restoration / similar liabilities.

Ind AS 107 – Financial Instruments:

Disclosures – Information about the measurement basis for financial instruments shall be disclosed as part of material accounting policy information.

Notes: None of the above amendments had any material effect on the company's financial statements except for disclosure of Material Accounting Policies instead of Significant Accounting Policies in the Financial Statements.

2B. Critical accounting judgements and key sources of estimation uncertainty

In the application of the Company's accounting policies, which are described in note 2A, the management of the Company are required to make judgements, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates. The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

In the following areas the management of the Company has made critical judgements and estimates:-

Useful lives of property, plant and equipment

The Company reviews the useful lives and carrying amount of property, plant and equipment at the end of each reporting period. This reassessment may result in change in depreciation expense in future periods.

Estimation of defined benefit obligation

The company has defined benefit plans for its employees which are actuarially valued. Such valuation is based on many estimates and other factors, which may have a scope of causing a material adjustment to the carrying amounts of assets and liabilities.

Provisions and Contingencies

In the normal course of business, contingent liabilities arise from litigations and claims. Potential liabilities that are possible but not probable of crystallising or are very difficult to quantify reliably are treated as contingent liabilities. Such contingent liabilities are disclosed in the notes but are not recognised. Potential liabilities that are remote are neither recognized nor disclosed as contingent liability. The management decides whether the matters needs to be classified as 'remote', 'possible' or 'probable' based on expert advice, past judgements, terms of the contract, regulatory provisions, etc.

Defined benefit obligations

Defined benefit obligations are measured at fair value for financial reporting purposes. Fair value determined by actuary is based on actuarial assumptions. Management judgement is required to determine such actuarial assumptions. Such assumptions are reviewed annually using the best information available with the Management.

i) Defined Contribution Plans

The Company makes Provident Fund contributions, which are defined contribution plans, for qualifying employees. Company has no further payment obligations once the contributions have been paid. Under the Provident Fund Schemes, the Company is required to contribute a specified percentage of the payroll costs to fund the benefits. The contributions payable to these plans by the Company are in compliance with the rates specified in the rules of the schemes. The Company recognised ₹ 37.02 Lakh (previous year ₹ 36.96 Lakh) as an expense and included in Note 29 - Employee Benefit Expenses 'Contribution to Provident Fund and Other Funds' in the Statement of Profit and Loss for the year ended 31st March 2026.

ii) Defined Benefit Plans

The Company has a defined benefit gratuity plan. Every employee who has completed five years or more of service gets a gratuity on retirement / resignation or retirement under VRS at 15 days salary (last drawn salary) for each completed year of service. The present value of gratuity obligation is determined based on actuarial valuation using the Projected Unit Credit Method, which recognises each period of service as giving rise to additional unit of employee benefit entitlement and measures each unit separately to build up the final obligation.

c) Capital Management

Total equity as shown in the balance sheet includes equity share capital, securities premium and retained earnings.

The Company aims to manage its capital efficiently so as to safeguard its ability to continue as a going concern and to optimise returns to its shareholders.

The Company's policy is to maintain a stable and strong capital structure with a focus on total equity so as to maintain investor, creditors and market confidence and to sustain future development and growth of its business. The Company will take appropriate steps in order to maintain, or if necessary adjust, its capital structure. The management monitors the return on capital as well as the level of dividends to shareholders.

d) Financial risk management

Company's activities expose it to credit risk, liquidity risk and market risk. This note explains the sources of risk which the entity is exposed to and how the entity manages the risk and its impact on the financial statements.

(i) Market risk

Market risk is the risk that the fair value of future cash flows of a financial instrument will fluctuate because of changes in market prices. Market risk comprises three types of risk - interest rate risk, foreign currency risk and other price risk such as equity price risk. Financial instruments affected by market risk include loans and borrowings, deposits, other financial instruments.

(ii) Liquidity risk

Liquidity risk is the risk that the Company will find it difficult in meeting its obligations associated with its financial liabilities in time.

Prudent liquidity risk management implies maintaining sufficient cash and marketable securities and the availability of funding through an adequate amount of committed credit facilities to meet obligations when due and to close out market positions. Due to the dynamic nature of the underlying business, Company's treasury maintains flexibility in funding by maintaining availability under cash and cash equivalents, bank deposits and mutual funds.

Management monitors rolling forecasts of the Company's liquidity position and cash and cash equivalents on the basis of expected cash flows. The tables below analyses the Company's financial liabilities into relevant maturity groupings based on their contractual maturities.

(iii) Interest rate risk

Interest rate risk can be either fair value interest rate risk or cash flow interest rate risk. Fair value interest rate risk is the risk of changes in fair value of fixed interest bearing investments because of fluctuations in the interest rates. Cash flow interest rate risk investments because of fluctuations in the interest rates. Cash flow interest rate risk because of fluctuations in interest rates. The Company's exposure to the risk of changes in market interest rates relates primarily to the Company's long-term debt obligations to its preference shareholders.

(iv) Interest rate sensitivity

The borrowing of the Company includes vehicle loans which carries fixed coupon rate and hence the Company is not exposed to interest rate risk.

(v) Credit risk

Credit risk is the risk of financial loss to the Company if a customer or counterparty to a financial instrument fails to meet its contractual obligations, and arises principally from the Company's receivables from customers, deposits and loans given, investments and balances at bank. The Company measures the expected credit loss of trade receivables based on historical trend, industry practices and the business environment in which the entity operates. Expected Credit Loss is based on actual credit loss experienced and past trends based on the historical data.
