This is with reference to your email dated 30th October 2025 regarding the imposition of a fine of Rs. 2,000/- plus GST for an alleged one-day delay in submission of the Annual Report for the financial year ended 31st March 2025.

In this regard, we respectfully submit that there was no delay in the submission of the Annual Report. As confirmed earlier through multiple communications, including submission of the RTA Certificate, the Annual Report was dispatched to shareholders on 28th August 2025 and submitted to the Exchange on the same date, in full compliance with Regulation 34 of the SEBI (LODR) Regulations, 2015. The copy of Acknowledgement of BSE and dispatch certificate of the RTA are attached herewith.

However, without prejudice to the above, and in order to avoid any further procedural inconvenience, the Company has paid the fine of Rs. 2,360/- (inclusive of GST) on 11th November 2025, vide UTR No. PUNBN62025111158158476.

Further, in compliance with the instructions contained in your communication, the matter relating to the purported non-compliance and the payment of the fine was placed before the Board of Directors at its meeting held on 14th November, 2025 and the Board duly noted the matter.
