Simplex Infra Q1 Net up 41% to ₹36cr

Kolkata, Aug.14, 2010 - Simplex Infrastructures Limited has announced its standalone financial results after limited review by the statutory auditors for the 1st Quarter ended June 2010. The turnover has grown 6% to ₹1175cr from ₹1108cr in the same quarter last year. The EBITDA has increased 7% to ₹121cr from ₹113cr. PBT has jumped 33% to ₹54cr from ₹40cr and PAT 41% to ₹36.2cr from ₹25.7cr. EBITDA margins have improved to 10.3% from 10.2%, PBT margins have risen to 4.6% from 3.6% and PAT margins to 3.1% from 2.3%.

The order book at the end of June'10 is ₹12262cr, growing 22% over the same time last year, the Q1 order inflow being ₹1861cr.
