## Vijaya Diagnostic Centre Ltd announces Q4 FY25 results, with a steady 11.6% YoY revenue growth and ~13% organic growth

**Hyderabad, May 12, 2025:** Vijaya Diagnostic Centre Limited (NSE: VIJAYA, BSE: 543350), one of India's leading integrated diagnostic chains, has announced its financial results for the quarter ended 31<sup>st</sup> Mar 2025.

### **Note:**

**Acquisition (PH Diagnostic Centre Private Limited, Pune):** PH has become a whole owned subsidiary effective from 21<sup>st</sup> December 2023. Consequently, its financials have been consolidated from 21<sup>st</sup> December 2023 in the last financial year FY 2023-24.

Hence, the consolidated operational and financial figures of Q4 FY25, Q4 FY24, 12M FY 25 and 12M FY24 below include PH, unless otherwise stated.
