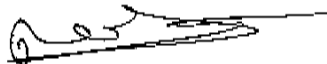

CERA Q3FY16 Result**CERA's valuable Vision: Increasing EBIDTA**

Maintaining its growth in sales and profit, Cera Sanitaryware has achieved 11.58% per cent rise in top line and a 24.42% percent increase in net profit in the third quarter of the current fiscal ended on December 31, 2015.

According to unaudited financial results for Q3 released by the company after a meeting of the company's board today, CERA has recorded a net sales income of Rs.233.53 crores in October-December this year compared to Rs.209.30 crores in Q3 during 2014-15.

The net profit for Q3 has totalled Rs.20.11 crores as against Rs.16.16 crores in October-December 2014-15.

It would be worthwhile to mention that CERA has recorded EBIDTA of Rs.37.38 crores in October-December this year compared to Rs.31.15 crores in Q3 during 2014-15.

The earnings per share (basic and diluted) during October-December, 2015-16 are worked out at Rs.15.46 compared to Rs.12.77 for October-December 2014-15.
