CERA Q1 Result

CERA REGISTERS GROWTH IN SALES AND NET PROFIT IN Q1

Cera Sanitaryware Limited (CERA) has achieved a **12.18%** growth in top-line and a **36.59 %** growth in net-profit for the first quarter of the current fiscal ended on June 30, 2016.

According to unaudited financial results for Q1 released by the company here today after a meeting of the company's board, the company achieved a net sales income of **Rs.223.94** crores during April-June this year compared to **Rs.199.63** crores in Q1 during 2015-16.

The net profit for Q1 in the current fiscal is at **Rs.21.40** crores as against **Rs.15.66** crores in April-June 2015.

The earnings per share (basic and diluted) during April-June 16 is at **Rs.16.45** compared to **Rs.12.05** for April-June 15.
