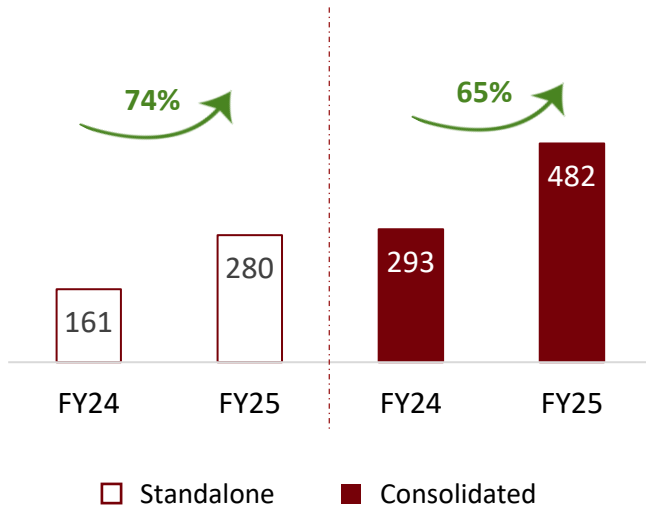

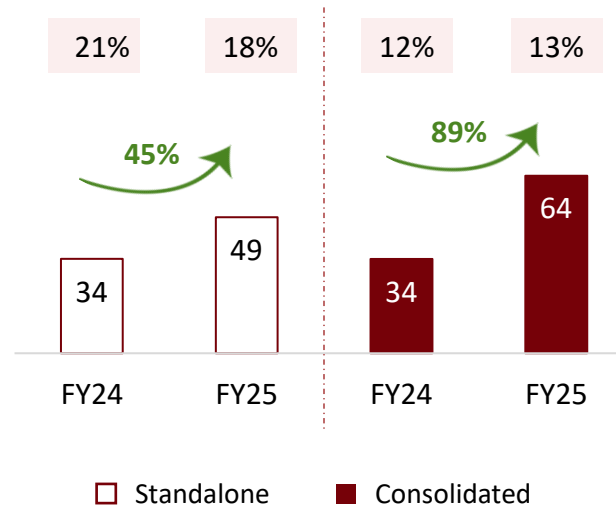
Financial Performance: Standalone & Consolidated



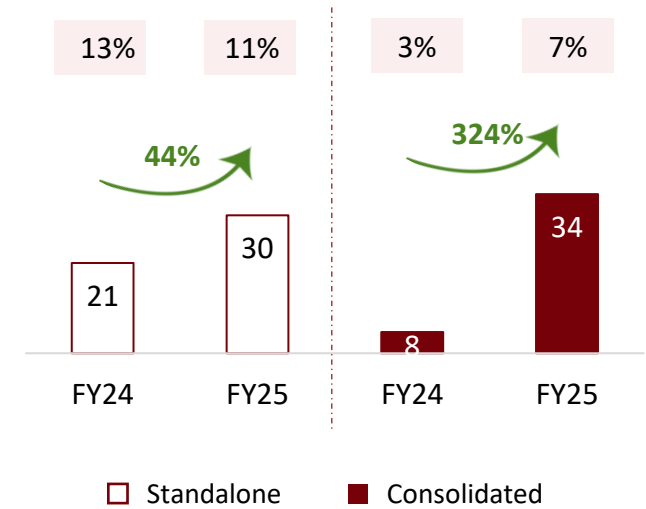
Revenue from Operations (Rs Mn)

- Revenue stood at **Rs 482 Mn** in FY25, an increase of **65% YoY**
- EBITDA stood at **Rs 64 Mn** in FY25 (Margin of 13%), an increase of **89% YoY**; moderated by higher employee costs, addition of KMPs, and strategic investments to drive future growth.
- PAT stood at **Rs 34 Mn** in FY25 (Margin of 7%), an increase of **324% YoY**

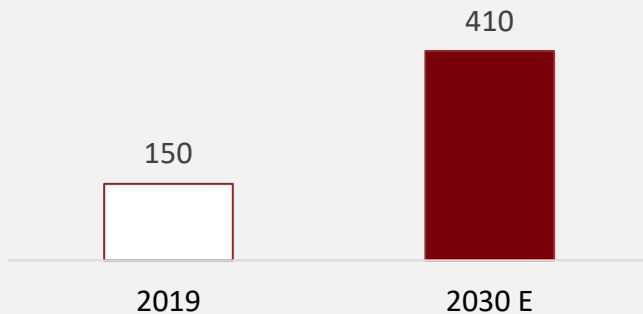

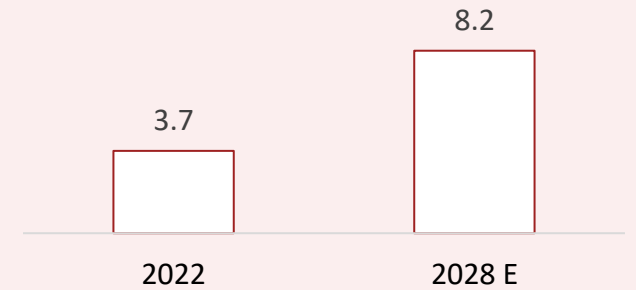
India's Travel Expenditure



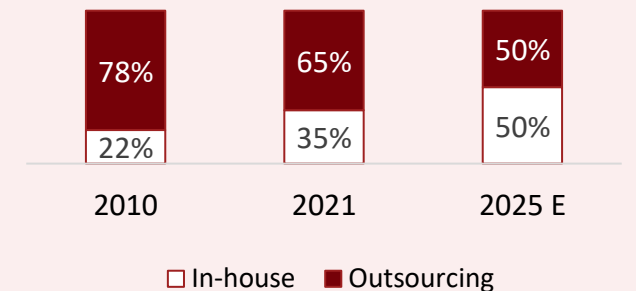

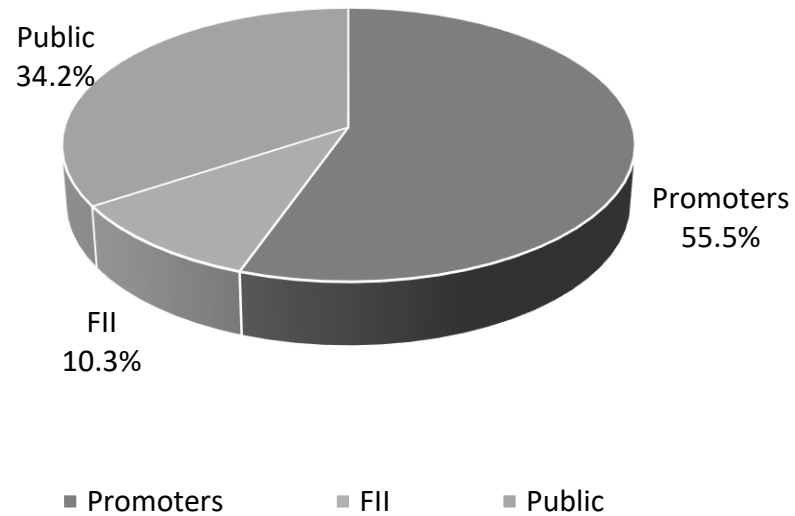
