# Industry Outlook

- Non availability of continuous power combined with lower selling prices place stress on profitability of AP based players
- Prices expected to increase; they however continue to be significantly lower YoY
- Majority of demand in the South is arising due to increase in construction activity mainly in the housing sector and general election also expected to provide impetus to demand
- Capacity additions in the South is expected to stay low at 55 60%
- Although energy related input costs are expected to increase over the next two years due to further hikes in diesel & coal prices, international coal prices are expected to soften

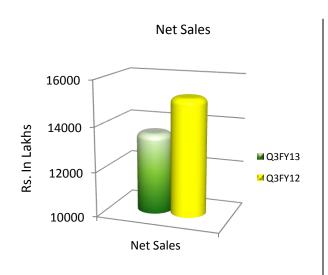

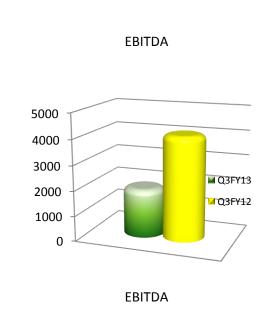

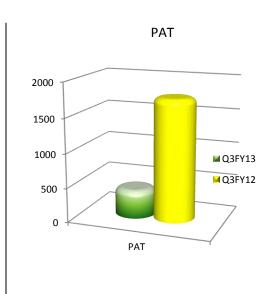
Our Balance Sheet continues to depict healthy numbers and our workforce has been a driving contributing to the growth of our Company.

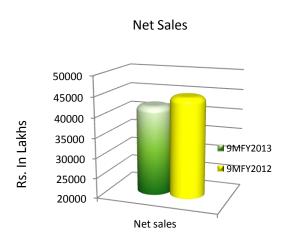


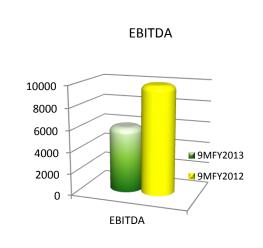


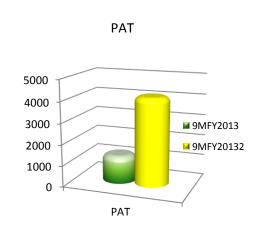


- Net Sales declined by 10.73% YoY to ₹ 13,585 lakh from ₹ 15,218 lakhs compared to Q3FY12

### 9MFY2013 Performance Review







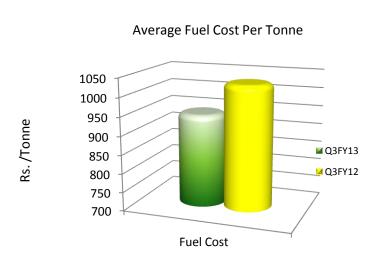
- Net Sales declined by 5.93% to ₹42,204 lakh in 9MFY13 from ₹ 44,861 lakh in 9MFY12

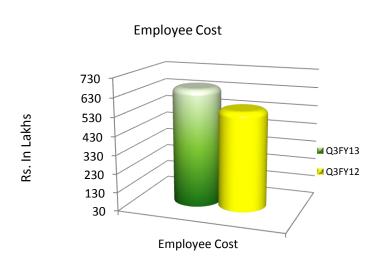


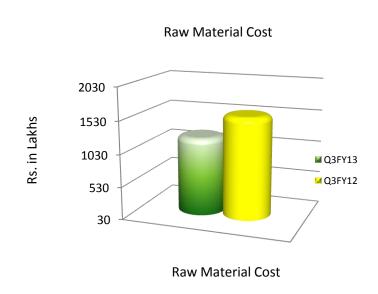


#### **Cost Overview**

- As more domestic coal was used during the quarter, average fuel cost per tonne of clinker production during the quarter was at ₹ 947 as compared to ₹ 1,032 per tonne in the corresponding quarter in previous year.
- On account of higher diesel prices prevailing during the year, total freight cost per tonne of cement for the quarter stood at ₹ 675 as compared to ₹ 630 in the previous corresponding quarter.

### **Cost Overview**



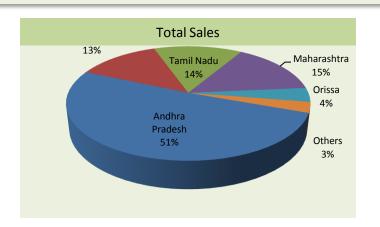


#### **Cost Overview**

- There is a decrease in raw material costs of 22.96%. This is mainly on account of lower volumes.
- Employee costs increased by 18.01% over the corresponding quarter last year, mainly on account of increments and other benefits.

## **Plant Highlights**

- During the quarter, the plant operated at reasonable utilization levels, producing 321,240 tons of clinker and 362,811 tons of cement.
- Utilization levels for clinker for this quarter at 64%.
- ➤ Volume of cement production in Q3FY2013 was lower by about 4.43% as compared to the corresponding quarter in the previous year.
- The company continues to have its presence in the established markets of Orissa, Karnataka, Tamil Nadu and Maharashtra as well as in Andhra Pradesh. During the Quarter approximately 49% of cement dispatches was to various markets outside the home state.
