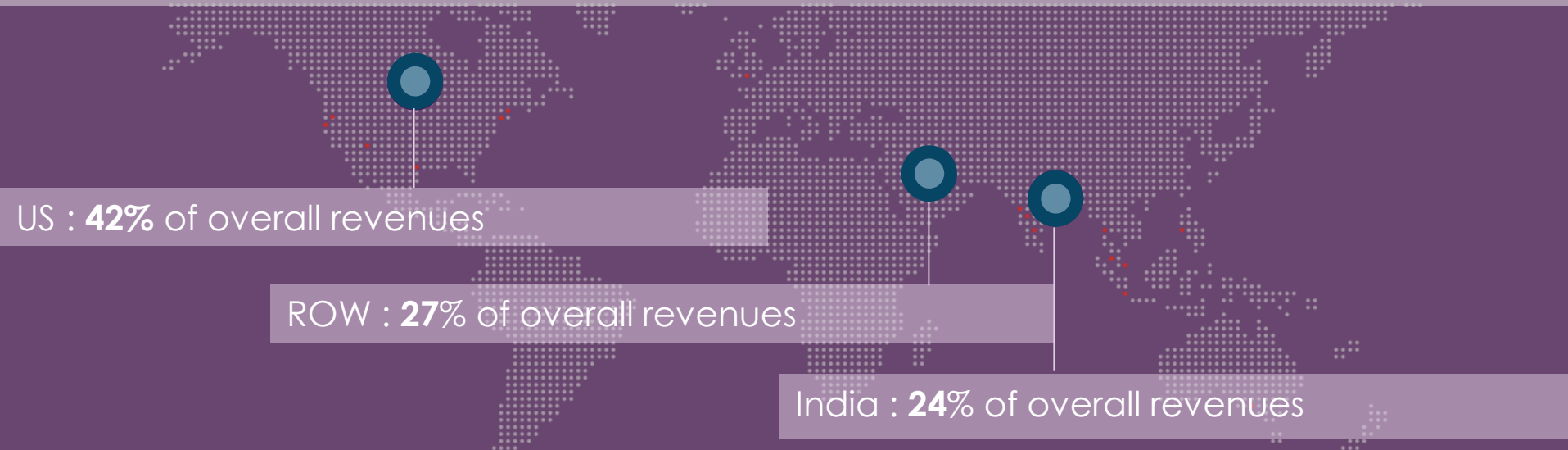

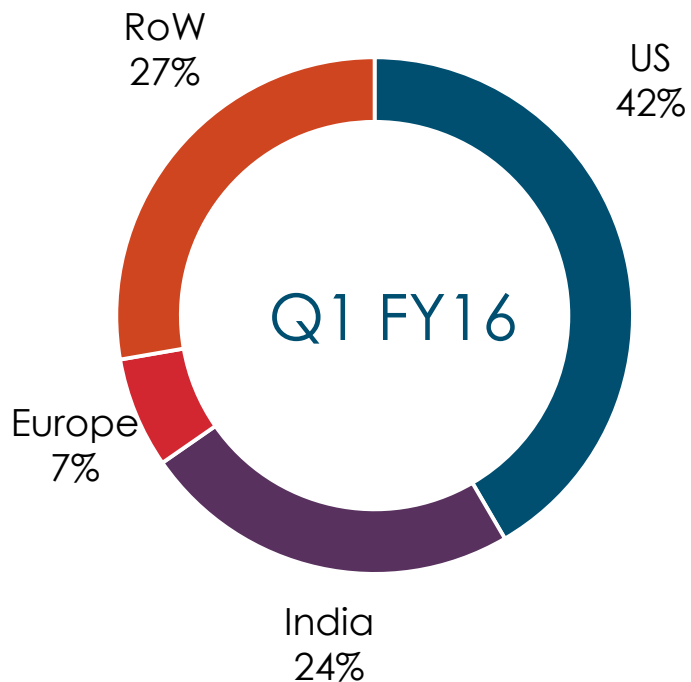

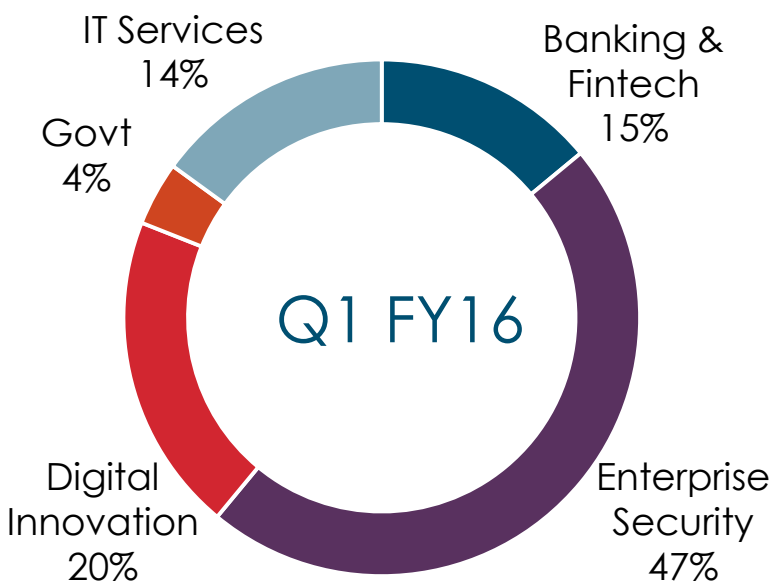
Revenue Distribution by Region

Revenue Distribution by Line of Business

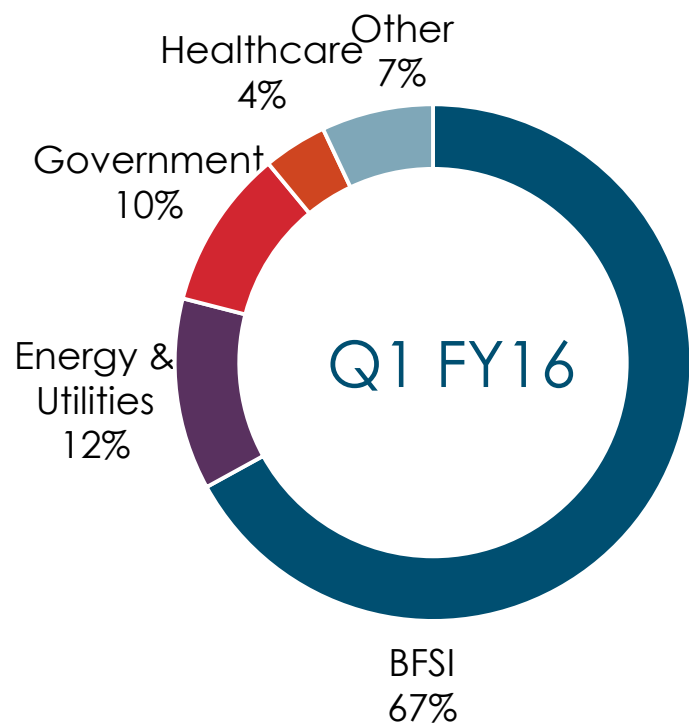
