Performance of your Company

The Indian textile and apparel sector recorded a mixed performance in FY 2025-26. Domestic demand held firm, particularly in urban apparel, technical textiles, and home furnishings, while export growth remained constrained by soft demand in Europe and the United States and by intensifying competition from lower-cost manufacturing bases. Value-added garments, sustainable and recycled product categories, and man-made-fibre segments continued to be the principal drivers of incremental demand.

The Company has in place adequate internal control systems commensurate with the size and nature of its operations. These systems ensure accuracy in financial reporting, operational efficiency, and legal compliance. The Audit Committee periodically reviews the internal audit findings and corrective actions are taken accordingly.

Operations

Results of the Company for the last financial year are as follows; Total revenue for the year ended 31st March, 2026 has been decreased to Rs. 10,225.46 lakhs as compared to previous year's Rs. 11,072.51 lakhs. Hence there was a decrease of 9% to 10%. The operating profit/(loss) before tax and exceptional items is Rs. (12.73) lakhs. The net profit/(loss) for the year after current year tax and deffered tax is Rs. (21.55) lakhs as compare to net loss of Rs. (65.68) lakhs in the previous financial year before exceptional items.

1. Global and Indian Economic Overview

In FY 2025-26, the global economy operated against a backdrop of moderating but persistent inflation, cautious monetary easing by major central banks, and continuing geopolitical and trade-policy uncertainty. Global GDP growth remained subdued, in the region of 2.7-3.0%, as elevated financing costs, softer consumption in the US and EU, and fragmented trade flows continued to weigh on capital-intensive and export-oriented sectors. While supply chains largely normalised and commodity prices stayed broadly stable, protectionist measures and tariff realignments introduced fresh volatility for globally traded goods, including textiles.

India again distinguished itself as one of the fastest-growing major economies, supported by resilient domestic consumption, sustained government capital expenditure, and a broad-based manufacturing and services expansion. Retail inflation remained largely within the central bank's comfort band, and continued fiscal consolidation, together with robust tax collections, underpinned macroeconomic stability. This domestic resilience provided a supportive operating environment for mid-sized manufacturers such as the Company, even as external demand stayed uneven.

2. Industry Structure, Market Size, and Developments

The Indian textile and apparel sector recorded a mixed performance in FY 2025-26. Domestic demand held firm, particularly in urban apparel, technical textiles, and home furnishings, while export growth remained constrained by soft demand in Europe and the United States and by intensifying competition from lower-cost manufacturing bases. Value-added garments, sustainable and recycled product categories, and man-made-fibre segments continued to be the principal drivers of incremental demand.

Government interventions through the Production Linked Incentive (PLI) scheme, PM MITRA textile parks, and the RoDTEP remission continued to support investment, capacity modernisation, and competitiveness across the value chain. At the same time, volatility in cotton and other raw-material prices, elevated power and fuel costs, and an uncertain global trade environment—including the prospect of higher tariffs in key export markets—remained key structural concerns for the industry.

3. Operational and Financial Performance – FY 2025-26

During FY 2025-26, the Company recorded Revenue from Operations of ₹10,150.75 lakhs, as against ₹11,019.55 lakhs in FY 2024-25, a decline of approximately 8%. The moderation in topline was largely attributable to softer sales realisations and subdued external demand conditions during the year, notwithstanding steady domestic offtake.

Despite the lower revenue, the Company achieved a significant improvement in profitability. Loss before tax narrowed sharply to ₹12.73 lakhs from ₹56.79 lakhs in the previous year, and Loss after tax reduced to ₹21.55 lakhs from ₹65.70 lakhs. This improvement was driven by disciplined cost

management, a more favourable raw-material and power-cost profile in relative terms, lower finance costs, and an improved product mix, which together lifted operating margins even on a lower revenue base.

Earnings/(Loss) per Equity Share improved to ₹(0.08) from ₹(0.24) in the prior year. Finance costs declined to ₹74.63 lakhs from ₹102.44 lakhs, reflecting continued balance-sheet discipline, while other income rose to ₹74.71 lakhs, aided partly by the gain on sale of property, plant and equipment. The Company generated positive cash flow from operations of ₹211.87 lakhs, enabling continued servicing of obligations and modest capital investment.

4. Segment-wise Performance

The Company is engaged primarily in the textile business and, in terms of Ind AS 108 – Operating Segments, operates in a single reportable segment. Accordingly, segment-wise financial disclosure is not separately applicable. Performance across the Company's textile operations is discussed under the operational and financial performance section above.

5. Opportunities and Threats

Opportunities

- **China+1 Strategy:** Global buyers continue to diversify sourcing away from a single geography, positioning India—and mid-sized players such as the Company—as an increasingly attractive alternative destination.
- **Sustainability Demand:** Rising demand for organic cotton, recycled yarn, and environment-friendly processes opens avenues for higher-value, differentiated products.
- **Government Support:** Incentive schemes and infrastructure parks (PLI, PM MITRA, RoDTEP) are expected to benefit competitive mid-sized manufacturers.
- **Digital Integration:** Adoption of automation and data analytics offers scope to improve supply-chain efficiency, quality consistency, and cost control.

Threats

- **Global Economic Risks:** A slowdown in key export markets, particularly Europe and the US, may continue to dampen export demand and realisations.

- **Tariff & Trade Uncertainty:** Unpredictable trade policy and rising protectionist measures, including possible tariff hikes in the United States, pose a direct risk to Indian textile exports and to margins and sourcing preferences.
- **Margin Pressure:** Rising wage bills and aggressive pricing from competing manufacturing bases such as Bangladesh and Vietnam continue to compress margins.
- **Raw Material & Energy Volatility:** Cotton prices, along with power and fuel costs, remain volatile and can materially affect input costs.
- **Liquidity & Working Capital:** A tight credit environment and delayed customer payments continue to strain working capital and cash flows.

6. Risks and Concerns

The Company remains exposed to raw-material price volatility, foreign-exchange fluctuations on account of its export exposure, evolving global trade and tariff policies, and competitive pricing pressures. Working-capital management, particularly the timely realisation of trade receivables in a tight credit environment, continues to be an area of focused attention. The management continuously monitors these risks and adopts appropriate mitigation measures, including cost optimisation, prudent procurement, customer diversification, and disciplined balance-sheet management.

7. Internal Control Systems and Adequacy

The Company has in place adequate internal control systems commensurate with the size, scale, and nature of its operations. These systems are designed to ensure accuracy and reliability in financial reporting, operational efficiency, safeguarding of assets, and compliance with applicable laws and regulations. The Audit Committee periodically reviews internal audit findings, the adequacy of internal financial controls, and the status of corrective actions, and appropriate remedial measures are implemented where required.

8. Financial Position and Liquidity

As at 31st March 2026, the Company's total assets stood at ₹5,480.83 lakhs, compared with ₹6,003.31 lakhs a year earlier, reflecting reduction in property, plant and equipment, inventories, and trade receivables. Total Equity was ₹2,601.88 lakhs and non-current borrowings stood at ₹1,257.30 lakhs. The Company generated net cash from operating activities of ₹211.87 lakhs during the year and continued to service its financing obligations, ending the year with a modestly improved cash position. The management remains committed to strengthening liquidity through improved receivable collections, inventory efficiency, and gradual deleveraging over the medium term.

9. Human Resources and Industrial Relations

The Company regards its workforce as a key asset and continues to invest in skill development, workplace safety, and employee engagement. Employee benefit expenses for the year were ₹1,030.68 lakhs. Industrial relations remained cordial throughout the year, and the Company maintained a stable and productive working environment across its operations.

10. Outlook

Despite near-term headwinds arising from an uncertain global trade environment and competitive pricing pressures, the medium- to long-term outlook for the Indian textile sector remains constructive, supported by domestic demand, favourable policy measures, and global sourcing diversification. In this context, the Company intends to:

- Strengthen and diversify its customer base;
- Invest selectively in sustainable and efficiency-enhancing technologies;
- Continue to improve cost efficiency and product mix;
- Reduce debt gradually and strengthen the balance sheet.

The management is committed to transforming the Company into a future-ready textile player through operational excellence, customer centricity, technology adoption, and disciplined financial management.

Notes to financial statements for the year ended 31 March 2026

Corporate Information

STL Global Limited (the "Company") is a public limited Company domiciled in India and is incorporated on dated July 22, 1997 under the provision of the Companies Act applicable in India and having its registered office at UNIT No.111, Block I, Tribhuvan Complex Ishwar Nagar New Delhi- 110065. The shares of the company are listed on National stock exchange and Bombay stock exchange. The Company is primarily engaged in the Textile Business. The Company has its manufacturing facilities located at Faridabad (Haryana) and sells its products in India.

Significant Accounting Policies

1.1 Basis of preparation of financial statements

Statement of Compliance

These financial statements are prepared in accordance with Indian Accounting Standards (Ind AS) under the historical cost convention on the accrual basis except for certain financial instruments which are measured at fair values, the provisions of the Companies Act, 2013 ('the Act') (to the extent notified) and guidelines issued by the Securities and Exchange Board of India (SEBI). The Ind AS are prescribed under Section 133 of the Act read with Rule 3 of the Companies (Indian Accounting Standards) Rules, 2015 and Companies (Indian Accounting Standards) Amendment Rules, 2016, as amended from time to time.

Use of Estimates

The preparation of financial statements in conformity with Generally Accepted Accounting Principles (GAAP) requires management to make judgments, estimates and assumptions that affect the application of accounting policies and reported amounts of assets, liabilities, income and expenses and the disclosure of contingent liabilities on the date of the financial statements. Actual results could differ from those estimates. Estimates and underlying assumptions are reviewed on an ongoing basis. Any revision to accounting estimates is recognised prospectively in current and future periods.

Functional and presentation Currency

These financial statements are presented in Indian Rupees (INR), which is the Company's functional currency. All financial information presented in INR has been rounded to the nearest Lakhs (up to two decimals).

The financial statements are approved for issue by the Company's Board of Directors on May 29, 2025.

1.2 Critical accounting estimates and management judgement

In application of the accounting policies, the management of the Company is required to make judgements, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and assumptions are based on historical experience and other factors that are considered to be relevant. Information about significant areas of estimation, uncertainty and critical judgements used in applying accounting policies that have the most significant effect on the amounts recognised in the financial statements is included in the following notes.

1.3 Property, plant and equipment

Property, plant and equipment (PPE) are initially recognised at cost. The initial cost of PPE comprises its purchase price, including non-refundable duties and taxes net of any trade discounts and rebates. The cost of PPE includes borrowing cost directly attributable to acquisition, construction of qualifying assets subsequent to initial recognition. PPE are stated at cost less accumulated depreciation (other than freehold land, which are stated at cost) and impairment losses, if any.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item flow to the company and the cost of the item can be measured reliably. The carrying amount of any component accounted for as a separate asset is derecognised when replaced. All other repair and maintenance are charged to profit and loss during the reporting period in which they are incurred.

Depreciation is recognised so as to write off the cost of assets (other than freehold land and Capital work in progress) less their residual value over the useful lives using the Written Down Value method (W.D.V) in the manner prescribed in the schedule II of the Act.

The carrying value of PPE are reviewed for impairment when events or changes in circumstances indicate that the carrying value may not be recoverable.

Intangible Assets are stated at cost of acquisition net of recoverable taxes, less accumulated depreciation and impairment loss, if any. The Cost of intangible Assets comprises purchase price and any cost directly attributable to bringing the assets to its working condition for the intended use.

1.4 Inventories

Inventories are valued at the lower of cost and the net realisable value after providing for obsolescence and other losses, if any. Cost of inventories comprises cost of purchase, cost of conversion and other costs including manufacturing overheads incurred in bringing them to their respective present location and conditions.

1.5 Cash and cash equivalents (for purposes of Cash Flow Statement)

Cash and cash equivalent comprises cash in hand and at bank, demand deposits with banks, other short term highly liquid investment with original maturities of three months or less which is subject to insignificant risk of change in value.

1.6 Revenue recognition

Revenue from operation includes Sales of goods and services and adjusted for Sale returns and trade discounts and exclude Goods and Service Tax (GST).

Interest income is accounted on accrual basis. Dividend income is accounted for when the right to receive it is established.

1.7 Segment Reporting

Operating segment are reported in a manner consistent with the internal reporting provided to the chief operating decision maker. The chief operating decision maker, who is responsible for allocating resources and assessing performance of the operating segments.

Segment revenue, segment expenses, segment assets and segment liabilities have been identified to segments on the basis of their relationship to the operating activities of the segment. Inter segment revenue are accounted on the basis of transactions which are primarily determined based on market /fair value factors. Revenue, expenses, assets and liabilities which relate to the company as a whole and are not allocable to the segment on a reasonable basis have been included under " unallocable revenue/expense/assets/liabilities.

1.8 Foreign currency transactions

Foreign exchange transactions are accounted at the exchange rates prevailing on the date of the transaction

Realised gains and losses on foreign exchange transactions during the year are recognized in the Profit & loss account. Foreign currency monetary assets and liabilities are translated at year-end rates and resultant gains/losses on foreign exchange transactions are recognised in the Profit & loss account.

1.9 Leases

Leases, where the lessor effectively retains substantially all the risks and benefits of ownership of the leased items, are classified as operating leases. Operating lease payments are recognized as an expenses in the statement of profit and loss on a straight line over the leased terms.

1.10 Earning Per Share (EPS)

Basic EPS is calculated by dividing the net profit or loss for the year attributable to equity shareholders by the weighted average number of equity shares outstanding during the year. For the purpose of calculating diluted earning per share, the net profit or loss for the period attributable to equity shareholders and the weighted average number of shares outstanding during the period are adjusted for the effect of all dilutive potential equity shares.

1.11 Investments

Investment that are readily realisable and intended to be held for not more than a year are classified as current investments. All other investments are classified as long-term investments. Current investment are carried at cost and measured subsequently at fair value either through other comprehensive income, or through profit or loss.

1.12 Employee benefits

Short term employee benefits

All employee benefits payable wholly within twelve months of rendering the service are classified as short term employee benefits and they are recognized in the period in which the employee renders the related service. The company recognizes the undiscounted amount of short-term employee benefits expected to be paid in exchange for services rendered as a liability (accrued expense) after deducting any amount already paid.

Long term employee benefits

Defined contribution plans

Contributions to defined contribution schemes such as employees state insurance, labour welfare fund, superannuation scheme, employee pension scheme etc. are charged as an expense based on the amount of contribution required to be made as and when services are rendered by the employees. Company's provident fund contribution is made to a government administered fund and is charged as an expense in the Statement of Profit and Loss. The above benefits are classified as Defined Contribution Schemes as the Company has no further obligations beyond the monthly contributions.

Defined benefit plans

Gratuity liability is defined benefit obligations and is provided for on the basis of an actuarial valuation made at the end of the each financial year.

Provision for compensated absence are provided for based on the estimates. Long term compensated leave are provided for based on actuarial valuation at the year end.

Actuarial gain/losses are immediately taken to profit and loss account and are not deferred.

The Company's contributions to State plans namely Employee State Insurance Fund and employees Pension Scheme are charged to Profit & Loss Account.

1.13 Borrowing costs

Borrowing costs that are attributable to the acquisition or construction of qualifying assets are capitalised as part of the cost of such assets. A qualifying assets is one that necessarily takes substantial period of time to get ready for intended use. All other borrowing costs are charged to revenue.

1.14 Taxes on income

Current tax is the amount of tax payable on the taxable income for the year as determined in accordance with the provisions of the Income Tax Act, 1961.

Deferred tax is recognised on timing differences, being the differences between the taxable income and the accounting income that originate in one period and are capable of reversal in one or more subsequent periods. Deferred tax is measured using the tax rates and the tax laws enacted or substantially enacted as at the reporting date. Deferred tax liabilities are recognised for all timing differences. Deferred tax assets in respect of unabsorbed depreciation and carry forward of losses are recognised only if there is virtual certainty that there will be sufficient future taxable income available to realise such assets. Deferred tax assets are recognised for timing differences of other items only to the extent that reasonable certainty exists that sufficient future taxable income will be available against which these can be realised. Deferred tax assets and liabilities are offset if such items relate to taxes on income levied by the same governing tax laws and the Company has a legally enforceable right for such set off. Deferred tax assets are reviewed at each Balance Sheet date for their realisability.

1.15 Impairment of non-financial assets

An asset is treated as impaired when the carrying cost of assets exceeds its recoverable value. An impairment loss is charged to the Profit & Loss statement in the year in which an asset is identified as impaired. The Impairment loss recognised in prior accounting period is reversed if there have been a change in the estimate of recoverable amount.

1.16 Contingent Liability

Contingent liabilities in respect of show cause notices received is considered only when they are converted into demands. Payments in respect of such demands, if any are shown as advances.

Contingent liabilities under various fiscal laws includes those in respect of which the company/ Department is in appeal. No Provision is made for a liability which is contingent in nature but if material is disclosed in the financial statement by way of notes.

1.17 Current versus non-current classification

The classification of Assets and liabilities of the Company into current or non-current is based on the criterion specified in the schedule III to the Companies Act, 2013. The Company has ascertained its operating cycle as 12 months for the purpose of current and non-current classification of assets and liabilities except trade receivables.

1.18 Financial Instruments

A financial instrument is any contract that gives rise to a financial asset of one entity and a financial liability or equity instrument of another entity. Financial assets and financial liabilities are recognised when Company becomes a party to the contractual provisions of the instruments.

Financial assets and financial liabilities are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets and financial liabilities at fair value through profit or loss) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at fair value through profit or loss are recognised immediately in the statement of profit and loss.

(i) Equity Instruments

An equity instrument is any contract that evidences a residual interest in the assets of an entity after deducting all of its liabilities. Equity instruments issued by the Company are recognised at the proceeds received. Incremental costs directly attributable to the issuance of new ordinary equity shares are recognized as a deduction from equity, net of tax effects.

(ii) Financial assets

(a) Financial assets at amortised cost

Financial assets are subsequently measured at amortised cost using the Effective Interest Rate method (EIR) if these financial assets are held within a business whose objective is to hold these assets in order to collect contractual cash flows and the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the EIR. The EIR amortisation is included in finance income in the profit or loss. The losses arising from impairment are recognised in the profit or loss. This category generally applies to bank deposits, loans and other financial assets.

(b) Financial assets at fair value through profit or loss (FVTPL)

Financial assets are measured at fair value through profit or loss unless it is measured at amortised cost or at fair value through other comprehensive income on initial recognition.

(c) Impairment of financial assets

In accordance with Ind-AS 109, the Company applies Expected Credit Loss (ECL) model for measurement and recognition of impairment loss on the financial assets and credit risk exposure.

ECL impairment loss allowance (or reversal) recognized during the period is recognized as income/ expense in the statement of profit and loss (P&L). This amount is reflected under the head 'other expenses' in the P&L. In balance sheet, ECL is presented as an allowance, i.e., as an integral part of the measurement of financial assets.

(d) Derecognition

The Company derecognises a financial asset when the contractual rights to the cash flows from the asset expire, or when it transfers the financial asset and substantially all the risks and rewards of ownership of the asset to another party.

(iii) Financial liabilities

(a) Financial liabilities at amortised cost

Financial liabilities are measured at amortised cost using the effective interest rate method (EIR). Gains and losses are recognised in profit or loss when the liabilities are derecognised as well as through the EIR amortisation process. Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the EIR. The EIR amortisation is included as finance costs in the statement of profit and loss. This category applies to trade and other payables.

(b) Derecognition

The Company derecognises financial liabilities when, and only when, the Company's obligations are discharged, cancelled or have expired. The difference between the carrying amount of the financial liability derecognised and the consideration paid / payable is recognised in the statement of profit and loss.

(iv) Offsetting of financial instruments

Financial assets and financial liabilities are offset and the net amount is reported in the balance sheet if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, to realise the assets and settle the liabilities simultaneously.
