Continued Operational Progress

Twamev Construction and Infrastructure Ltd. (formerly *Tantia Construction Ltd.*) continued its focus on operational stabilisation during the quarter ended 31 December 2025, reflecting steady progress on the strategic priorities articulated at the beginning of the financial year. Net sales for the quarter increased by 38% over the corresponding period in the prior year, while profitability and earnings per share remained stable.

During the quarter, Twamev benefited from a significant reduction in finance costs, supported by balance sheet discipline, and continued to advance its efforts to stabilise EBITDA margins through a calibrated rebalancing of its project delivery model. Together, these developments underscore the Company's ongoing transition toward a more resilient and sustainable operating framework

A brief analysis of the performance for the nine months ending on 31st December 2025 is outlined below.

Financial Highlights (Standalone) – Nine Months Ended 31st December 2025

- **Revenue:** Net sales increased by **28%**, reaching **₹44.94 crores** during nine months ending on 31st December 2025, compared to ₹35.13 crores during nine months ending on 31st December 2024.
- **Operating EBITDA (before Other Income):** Operating EBITDA margin for the period stood at **16.0%**, compared with 14.7% in the corresponding period of the previous year.
- **Net Profit:** Profit After Tax (PAT) at **₹7.18 crores** for the nine months ending on 31st December 2025 is a 120% increase over the PAT for the corresponding period in the previous year. This is driven by focused project delivery and strong oversight over costs.
- **Strong EPS Delivery:** Substantial growth in profit is reflected in the doubling of EPS to **₹0.46** for the nine months ending 31st December 2025, when compared to EPS of ₹0.21 for the corresponding period in the previous year.
- **Project Update:** All ongoing projects are on track with respect to both time and costs.
