OPERATION REVIEW:

During the year under review, your Company achieved Revenue from operations of Rs. 52,140.90 Lakhs as compared to Rs. 54,219.67 Lakhs of previous Financial Year. Total Income of Rs. 57,675.47 Lakhs compared to Rs. 59,366.69 Lakhs of previous Financial Year.

The EBITDA was Rs. 7,590.86 Lakhs for current year (14.56 % of the Revenue from operations) as against of Rs. 10,603.25 Lakhs (19.56 % of the Revenue from operations).

After considering Interest, Depreciation and Foreign Exchange (Loss)/Gain and an Exceptional Item, the Company has Loss Before Tax of Rs. 4,633.33 Lakhs for the current year as against Profit Before Tax of Rs 323.88 Lakhs in the previous year. After considering tax expenses the Company has Loss After Tax of Rs. 3,228.84 Lakhs for the current year as against Loss After Tax of Rs. 65.03 Lakhs. Total Comprehensive Income for the period was (Rs. 2,936.55) Lakhs for the current year as against Loss of (Rs.54.51) Lakhs in the previous year.

DIVIDEND:

The Board of Directors' regret inability to declare dividend in view of Loss incurred during the year.

The Company has received a communication from the holder of the Preference Shareholder that they have waived off the cumulative preference share dividends amounting to Rs. 360 Lakhs for the current year, no provision has been made for the preference dividend, nor has this amount been shown under contingent liabilities.

TRANSFER TO RESERVES

No amount has been transferred to general reserves for the Financial Year ended March 31, 2026.

Overview

Global Vectra Helicorp Limited (“GVHL” or “the Company”) continues to remain one of India’s leading private sector helicopter operators with a strong track record in safe and reliable rotary-wing aviation services. HELICOPTER INDUSTRY IN INDIA

OIL AND GAS INDUSTRY: -

Introduction

The Oil and Gas Sector is among the eight core industries in India and plays a vital role in influencing the growth and performance of several other sectors of the economy. India continues to be one of the world's fastest-growing major energy markets and has retained its position as the **third-largest oil**

consumer globally and among the largest energy consumers in the world.

India's consumption of petroleum products during **FY 2025-26** is estimated to have crossed **252–255 million metric tonnes (MMT)**, registering healthy growth over FY 2024-25 consumption of 243.2 MMT, supported by rising mobility demand, industrial expansion, aviation growth and robust economic activity.

India possesses significant hydrocarbon potential across multiple onshore, shallow offshore and deepwater sedimentary basins, offering substantial opportunities for future exploration and production activities.

The Government of India continues to aggressively increase exploration acreage under successive OALP rounds, with the objective of unlocking domestic hydrocarbon potential and reducing import dependence.

India's cumulative crude oil production during **FY 2025-26** is estimated in the range of **29.5–30.5 MMT**, broadly stable despite natural decline in mature fields, aided by redevelopment programs and enhanced recovery initiatives.

India imported approximately **240+ MMT of crude oil during FY 2025-26**, with crude import dependence estimated at around **88%**, reflecting continued reliance on overseas supplies despite domestic production efforts.

India is expected to remain one of the most important drivers of future global oil demand growth, supported by sustained economic expansion, urbanisation and rising energy consumption making it one of the largest contributors to future global oil demand growth.

Diesel demand in India is expected to rise significantly, while gasoline, ATF, LPG and petrochemical feedstock demand are also projected to remain strong.

India's demand for energy continues to grow faster than most major economies globally and this trend is expected to continue, driven by favourable demographics, rising incomes, urbanisation, manufacturing growth and infrastructure development.

Indian Oil and Gas Sector

Upstream Segment (Exploration & Production)

The upstream sector continues to be led by Oil and Natural Gas Corporation, which remains India's largest exploration and production company. ONGC, together with Oil India Limited and private sector participants such as Reliance Industries Limited and Cairn Oil & Gas, plays a major role in domestic hydrocarbon production.

ONGC continues to account for a dominant share of India's crude oil and natural gas production, with ongoing investments in Mumbai Offshore, KG Basin and frontier deepwater assets.

Midstream Segment (Storage & Transportation)

India has built an extensive network of crude oil, petroleum product and natural gas pipelines. The country now has more than:

- **Extensive crude oil pipeline infrastructure across the country**
- **A rapidly expanding natural gas transmission network supporting increasing gas demand**
- **Product pipelines operated by PSU and private companies**

This infrastructure is critical for national energy security and efficient fuel movement.

Downstream Segment (Refining, Processing & Marketing)

India remains Asia's second-largest refiner and among the largest globally. Major refining companies include:

- Indian Oil Corporation Limited
- Bharat Petroleum Corporation Limited
- Hindustan Petroleum Corporation Limited
- Reliance Industries Limited
- Nayara Energy

India continues to be a significant exporter of diesel, ATF and refined petroleum products.

Market Size

India has **26 sedimentary basins** spread across approximately **3.36 million sq. km.**

- Onshore + shallow offshore up to 400m isobath: **~2.04 million sq. km.**
- Deepwater beyond 400m isobath: **~1.32 million sq. km.**

Primary energy demand is expected to nearly double by 2040 as India's GDP rises substantially over the coming decade.

India remains one of the largest contributors to non-OECD petroleum demand growth globally.

Refinery throughput, fuel demand and petrochemical consumption continue to show long-term structural growth.

Diesel and gasoline are expected to continue accounting for a major share of petroleum demand, while aviation turbine fuel demand is also expected to rise sharply with aviation growth.

India's share in global primary energy consumption is projected to significantly increase by 2035.

Government Initiatives and Investments

The Government of India has permitted **100% Foreign Direct Investment (FDI)** under automatic route in several oil and gas segments including upstream and private refining.

Major recent developments include:

- Expansion of Strategic Petroleum Reserve capacity at Chandikhol and Padur
- Continued Open Acreage Licensing Policy (OALP) bid rounds
- Gas infrastructure expansion under CGD programs
- Pipeline projects under GAIL and other entities
- Boost to domestic E&P through HELP reforms
- Biofuel blending targets

- Green Hydrogen Mission
- LNG import diversification initiatives
- Refining capacity expansion targets

India has also intensified offshore exploration efforts, including promising acreage in the Andaman Sea and deepwater western offshore regions.

Exploration Expansion (OALP)

Under multiple Open Acreage Licensing Policy rounds, India has offered large exploration acreage across:

- Onland basins
- Shallow water blocks
- Deepwater blocks
- Ultra-deepwater blocks

These rounds are expected to attract domestic and international investment and significantly improve exploration intensity.

The Government has indicated that more than **1 million sq. km. offshore acreage** has been made available in recent years for exploration.

Currently, only a fraction of India's sedimentary basin potential is under active exploration, leaving substantial future opportunity.

Road Ahead

India is undertaking re-assessment of hydrocarbon resources across all 26 sedimentary basins using updated seismic, geological and geophysical data.

Basins under focus include:

- Mumbai Offshore
- Krishna-Godavari
- Mahanadi
- Cambay
- Rajasthan
- Kerala-Konkan
- Vindhyann
- Frontier Andaman areas

The Government continues to encourage:

- Multi-client seismic programs
- Enhanced recovery in mature fields
- Deepwater development
- Natural gas share increase in energy mix
- Coal bed methane and unconventional resources

These developments indicate that India's hydrocarbon sector is entering a structurally stronger phase with rising investment, improved policy support and increasing energy security focus.

Growing Demand

India is expected to remain a key exporter of transportation fuels to Asia, Africa and Atlantic Basin markets.

Continued investments in refining complexity and capacity are expected to support production of diesel, ATF and middle distillates.

Oil demand in India is expected to witness sustained long-term growth driven by industrialisation, mobility and economic development.

Natural gas demand is also expected to rise sharply with:

- CGD expansion
- Industrial switching
- Fertiliser demand
- Power sector use
- LNG infrastructure growth

India's energy demand is expected to grow faster than most major economies.

Expansion

Indian oil companies are investing heavily in refining and petrochemicals.

India continues to invest significantly in refining capacity expansion through multiple ongoing and proposed projects aimed at meeting rising domestic demand and strengthening export capabilities, such as:

- Barmer (HPCL)
- Paradip expansion (IOCL)
- Ratnagiri (subject to progress)
- Nagapattinam (CPCL)

India is also expanding petroleum reserves, pipeline networks and northeast hydrocarbon infrastructure.

The upstream E&P segment is expected to attract multi-billion-dollar investments over the coming years.

Supportive FDI Guidelines

India continues to strengthen investor-friendly policies through:

- Revenue sharing model reforms
- Simplified approvals
- 100% FDI in eligible sectors
- Improved contract framework
- Digital National Data Repository (NDR)
- Transparent bidding systems

These measures are expected to attract global oil majors, independent E&P firms and technology providers into the Indian market.

Conclusion

India's Oil and Gas sector remains one of the strongest long-term growth stories globally. Rising domestic demand, refining strength, infrastructure expansion, policy reforms and offshore exploration potential are expected to sustain significant investment opportunities.

For helicopter operators supporting offshore exploration, production logistics and emergency services, the long-term outlook remains particularly favourable as India expands domestic hydrocarbon development and deepwater activity.

Future of Oil & Gas in India

India's oil demand is expected to grow steadily over the long term, positioning the country as one of the major contributors to future global energy demand growth.

Despite growth in renewables, hydrocarbons will remain critical for:

- Road freight and logistics
- Aviation turbine fuel demand
- Petrochemical feedstocks
- LPG and cooking fuel
- Shipping fuels
- Fertiliser sector gas demand

2. Emergency Medical Evacuation

Rapid medevac of injured or ill personnel from offshore assets.

3. Critical Logistics Support

Movement of urgent spares, documents, tools and specialist manpower.

4. Time Efficiency

Helicopters significantly reduce travel time compared with marine vessels.

5. Safety Readiness

Modern offshore standards require rapid-response transport capability.

Therefore, any expansion in offshore oil production generally creates parallel demand for helicopter flying hours.

6. Diversified Service Segments

The onshore helicopter industry in India supports multiple segments including heli-pilgrimage services, airborne geophysical surveys, LIDAR mapping, underslung cargo operations, VIP/VVIP transportation, election flying, corporate travel, defence support missions, RBI operations and anti-Naxal operations.

7. Growth in Heli-Pilgrimage Operations

Heli-pilgrimage operations have witnessed significant growth due to increasing demand for safe, convenient and time-efficient access to remote and high-altitude religious destinations such as Vaishno Devi, Amarnath and the Char Dham circuit. Operators such as Global Vectra Helicorp Limited have developed substantial operational experience in this segment.

8. Airborne Geophysical Surveys and LIDAR Operations

Airborne geophysical surveys and helicopter-based LIDAR operations are increasingly supporting mineral exploration, geological mapping, environmental monitoring, disaster management and infrastructure planning through high-precision aerial data acquisition in inaccessible terrain.

9. MHA Subsidized Connectivity Operations

The defence sector continues to be an important contributor to onshore helicopter operations through requirements for passenger movement, cargo transportation, air maintenance and logistical support in remote and high-altitude regions.

12. VIP/VVIP, Election and Corporate Flying

State governments, political organizations and corporate entities increasingly utilize helicopter services for VIP/VVIP transportation, election flying and executive travel owing to the operational flexibility and time efficiency offered by rotary-wing aviation.

13. Strategic and Security Operations

Helicopters also play a crucial role in strategic and security-related operations including RBI currency transportation, emergency response missions and anti-Naxal operations across difficult and inaccessible terrain.

14. Industry Challenges

Despite challenges arising from inflationary pressures, foreign exchange volatility, supply chain disruptions, rising maintenance costs and shortage of skilled manpower, the long-term outlook for the Indian onshore helicopter industry remains positive.

The medium to long-term outlook for offshore helicopters in India remains positive.

India seeks to reduce import dependence, which requires higher domestic production.

Oil majors increasingly require:

- Twin-engine IFR capable fleets
- High dispatch reliability
- Backup aircraft support

4. Policy:

- 4.1.1.** The Board, on the recommendation of the Nomination and Remuneration (NR) Committee, shall review and approve the remuneration payable to the Executive Directors of the Company within the overall limits approved by the shareholders.
- 4.1.2.** The Board, on the recommendation of the NR Committee, shall also review and approve the remuneration payable to the Key Managerial Personnel of the Company.
- 4.1.3.** The remuneration structure to the Executive Directors and Key Managerial Personnel shall include the following components:
- (i) Basic Pay
 - (ii) Perquisites and Allowances
 - (iii) Other benefit as per Company Policy

Report on the Audit of the Ind-AS Financial Statements

Opinion

We have audited the accompanying Ind-AS Financial Statements of **GLOBAL VECTRA HELICORP LIMITED** ("the Company"), which comprise the Balance Sheet as at March 31, 2026, the Statement of Profit and Loss (including Other Comprehensive Income), the Statement of Changes in Equity, Statement of Cash Flows for the year then ended, and the Notes to the Ind-AS Financial Statements, including a summary of material accounting policies and other explanatory information (hereinafter referred to as "Ind-AS Financial Statements").

In our opinion and to the best of our information and according to the explanations given to us, the aforesaid Ind-AS Financial Statements give the information required by the Companies Act, 2013, ("the Act") in the manner so required and give a true and fair view in conformity with the Indian Accounting Standards prescribed under section 133 of the Act read with the Companies (Indian Accounting Standard) Rules, 2015, as amended, ("Ind-AS") and with accounting principles generally accepted in India, of the state of affairs of the Company as at March 31, 2026, the loss, total comprehensive income, changes in equity and its cash flows for the year ended on that date.

Basis for Opinion

We conducted our audit of the Ind-AS Financial Statements in accordance with the Standards on Auditing (SAs) specified under section 143(10) of the Companies Act, 2013. Our responsibilities under those Standards are further described in the *Auditor's Responsibilities for the Audit of the Ind-AS Financial Statements* section of our report. We are independent of the Company in accordance with the Code of Ethics issued by the Institute of Chartered Accountants of India together with the ethical requirements that are relevant to our audit of the Ind-AS Financial Statements under the provisions of the Companies Act, 2013 and the Rules thereunder, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the Code of Ethics. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Material Uncertainty related to Going Concern

We draw attention to Note 1(a)(ii) to the accompanying Ind-AS Financial Statements wherein it is stated that, for the year ended March 31, 2026, the Company recorded a net loss after taxes of ₹3,228.84 lakhs and a net loss after other comprehensive income of ₹2,936.55 lakhs, resulting in a net worth of (₹810.31) lakhs as at that date. Current liabilities exceeded current assets by ₹27,576.95 lakhs.

Having regard to the projections, the Company's future business plans, and the detailed cash flow forecasts reviewed by the Board of Directors, we are of the opinion that the use of the going concern basis of accounting in the preparation of the Financial Statements for the year ended March 31, is appropriate.

Our opinion is not modified in respect of this matter.

Key Audit Matters

Key audit matters are those matters that, in our professional judgment, were of most significance in our audit of the Ind-AS Financial Statements of the current period. These matters were addressed in the context of our audit of the Ind-AS Financial Statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.

In addition to the matters described in the Material Uncertainty Related to Going Concern, we have determined the matter described below to be the key audit matter to be communicated in our report.

Key Audit Matter Description	Auditor's Response
Aircraft Maintenance Obligations The Company operates aircraft which are owned or held under lease arrangements and incurs liabilities for maintenance costs in respect of aircraft leased during the term of the lease. These arise from legal and contractual obligations relating to the condition of the aircraft when it is returned to the lessor. At each reporting date, the calculation of the maintenance provision includes a number of variable factors and assumptions including: likely utilisation of the aircraft; the expected cost of the heavy maintenance at the future date it is expected to occur; the condition of the aircraft engine, contractual return conditions. Given the involvement of inherent level of management judgement required as a result of the complex and subjective element around these variable factors and assumptions in order to quantify the amounts, we have identified this as a key audit matter.	Our audit procedures includes: - assessed the design, implementation and operating effectiveness of the management's internal controls over the maintenance process including accounting for maintenance provisions for aircraft held under operating leases. - assessed the amount recorded and key assumptions adopted by the management in estimating the amount, and reviewed the terms of the operating leases, compared assumptions to contract terms and the Company's maintenance cost experience; - obtained information about the utilisation pattern by reference to the expected future maintenance event dates from Company's personnel and assessed the consistency of the provisions with the engineering department's assessment of the condition of aircraft, based on underlying engine inspections and results, analysis of historical flight hours, estimate of the cost of maintenance work to historic invoices; - assessed the provision by ensuring that all significant return condition obligations included in aircraft lease contracts have been considered;

Information Other than the Ind-AS Financial Statements and Auditor's Report Thereon

The Company's Board of Directors is responsible for the other information. The other information comprises the information included in the Annual Report, namely Financial Highlights, Directors' Report and Report on Corporate Governance but does not include the Ind-AS Financial Statements and our auditor's report thereon which we obtained prior to the date of this auditor's report.

Our opinion on the Ind-AS Financial Statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the Ind-AS Financial Statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the Ind-AS Financial Statements or our knowledge obtained in the audit or otherwise appears to be materially misstated.

If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

Responsibilities of Management and Those Charged with Governance for the Ind-AS Financial Statements

The Company's Board of Directors is responsible for the matters stated in section 134(5) of the Act, with respect to the preparation of these Ind-AS Financial Statements that give a true and fair view of the financial position, financial performance, changes in equity and cash flows of the Company in accordance with the accounting principles generally accepted in India, including the Accounting Standards specified under section 133 of the Act. This responsibility also includes maintenance of adequate accounting records in accordance with the provisions of the Act for safeguarding of the assets of the Company and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the Ind-AS Financial Statements that give a true and fair view and are free from material misstatement, whether due to fraud or error.

In preparing the Ind-AS Financial Statements, the Board of Directors is responsible for assessing the Company's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless Board of Directors either intends to liquidate the Company or to cease operations, or has no realistic alternative but to do so. Those Board of Directors are also responsible for overseeing the Company's financial reporting process.

Auditor's Responsibilities for the Audit of the Ind-AS Financial Statements

Our objectives are to obtain reasonable assurance about whether the Ind-AS Financial Statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with SAs will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these Ind-AS Financial Statements.

As part of an audit in accordance with SAs, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

- (a) Identify and assess the risks of material misstatement of the Ind-AS Financial Statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- (b) Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances. Under section 143(3)(i) of the Companies Act, 2013 we are also responsible for expressing our opinion on whether the Company has adequate internal financial controls system in place and the operating effectiveness of such controls.
- (c) Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by Management.
- (d) Conclude on the appropriateness of Management's use of the going concern basis of accounting and based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Company's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Company to cease to continue as a going concern.
- (e) Evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

We also provide those charged with governance with a statement that we have complied with relevant ethical requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on our independence, and where applicable, related safeguards.

From the matters communicated with those charged with governance, we determine those matters that were of most significance in the audit of the Ind-AS Financial Statements of the current period and are therefore the key audit matters. We describe these matters in our auditor's report unless law or regulation precludes public disclosure about the matter or when, in extremely rare circumstances, we determine that a matter should not be communicated in our report because the adverse consequences of doing so would reasonably be expected to outweigh the public interest benefits of such communication.

Report on Other Legal and Regulatory Requirements

1.  - (e) On the basis of the written representations received from the Directors of the Company as on March 31, 2026, taken on record by the Board of Directors, none of the Directors of the Company is disqualified as on March 31, 2026 from being appointed as a Director in terms of Section 164 (2) of the Act.
 - (f) With respect to the adequacy of the internal financial controls with reference to financial statements of the Company and the operating effectiveness of such controls, refer to our separate Report in **Annexure "B"**.
 - (g) With respect to the other matters to be included in the Auditor's Report in accordance with Rule 11 of the Companies (Audit and Auditors) Rules, 2014 ("the Rules"), in our opinion and to the best of our information and according to the explanations given to us:

- i. The Company has disclosed the impact of pending litigations on its financial position in its Ind-AS Financial Statements – Refer Note 31 to the Ind-AS Financial Statements.
- ii. The Company did not have any long-term contracts during the year ended March 31, 2026, for which there were any material foreseeable losses. Derivative contracts are appropriately dealt with in the books of account.
- iii. There are no amounts, which were required to be transferred to the Investor Education and Protection Fund by the Company.
- iv. The Management has represented that;
 - (a) to the best of its knowledge and belief, as disclosed in the note 44.9 to the Ind-AS Financial Statements, no funds have been advanced or loaned or invested (either from borrowed funds or share premium or any other sources or kind of funds) by the Company to or in any other person or entity, including foreign entity ("Intermediaries"), with the understanding, whether recorded in writing or otherwise, that the Intermediary shall, whether, directly or indirectly lend or invest in other persons or entities identified in any manner whatsoever by or on behalf of the Company ("Ultimate Beneficiaries") or provide any guarantee, security or the like on behalf of the Ultimate Beneficiaries.
 - (b) to the best of its knowledge and belief, as disclosed in the note 44.10 to the Ind-AS Financial Statements, no funds have been received by the Company from any person or entity, including foreign entity ("Funding Parties"), with the understanding, whether recorded in writing or otherwise, that the Company shall, whether, directly or indirectly, lend or invest in other persons or entities identified in any manner whatsoever by or on behalf of the Funding Party ("Ultimate Beneficiaries") or provide any guarantee, security or the like on behalf of the Ultimate Beneficiaries; and

Based on such audit procedures performed by us that have been considered reasonable and appropriate in the circumstances, nothing has come to our notice that has caused us to believe that the representations under sub-clause (i) and (ii) of Rule 11(e) of the Rules as provided under (a) and (b) above, contain any material mis-statement.

- v. The Company has not declared or paid any dividend during the year.
 - vi. Based on our examination, which included test checks, the Company has used accounting software programs for maintaining its books of account which have a feature of recording audit trail (edit log) facility and the same have operated throughout the year for all relevant transactions recorded in the software. Further, during the course of our audit we did not come across any instance of audit trail feature being tampered with.
- The audit trail has been preserved by the Company, as per the statutory requirements for record retention.
3. In our opinion and according to information and explanations given to us and based on our examination of the records of the Company, the Company has paid / provided managerial remuneration in accordance with the requisite approvals mandated by the provisions of Section 197 of the Act.

Notes forming part of financial statements for the year ended 31st March, 2026 (Currency Indian Rupees)

Note 1

Statement of Material Accounting Policies

A. General Information

Global Vectra Helicorp Limited ('the Company') was incorporated in 1998 as a private limited company and was subsequently listed on 27 October 2006 on the Bombay Stock Exchange and the National Stock Exchange.

The Company is mainly engaged in helicopter charter services for offshore transportation, servicing the oil and gas exploration and production sector in India. The Company is also engaged in helicopter charter services for onshore transportation.

B. Basis of Preparation of Financial Statements

a) (i) Statement of compliance with Ind AS

The financial statements of the Company comply with all material aspects with Indian Accounting Standards (Ind AS) notified under Section 133 of the Companies Act, 2013 (the Act) [Companies (Indian Accounting Standards) Rules, 2015] and other relevant provisions of the Act.

The Financial statements are prepared in Indian rupees rounded off to the nearest lakhs except for share data, unless otherwise stated.

The financial statements of the Company for the year ended 31st March, 2026 were approved for issue in accordance with the Resolution passed by the Board of Directors at their meeting held on 27th May, 2026.

a) (ii) Going concern assumption

The Board of Directors and Management are confident that the Company will continue as a going concern for the foreseeable future. This assessment is supported by a series of concrete operational improvements and financing measures that have been implemented or are well advanced, as described below.

For the year ended March 31, 2026, the Company recorded a net loss after taxes of Rs. 3,228.84 lakhs and a net loss after other comprehensive income of Rs. 2,936.55 lakhs, resulting in a negative net worth of ₹810.31 lakhs as at that date. Current liabilities exceeded current assets by Rs. 27,576.95 lakhs. These outcomes reflect a period of significant external headwinds rather than structural deterioration in the Company's business model.

The losses were driven by identifiable and largely external factors: industry-wide supply chain disruptions affecting aircraft availability, the consequent contractual penalties levied by the customer, and the sustained depreciation of the Indian Rupee against the US Dollar and Euro. The Company has directly addressed each of these factors through targeted

operational actions.

On the operational side, customer penalties have been substantially reduced through the induction of a dedicated standby aircraft, the establishment of consignment stock arrangements directly with Original Equipment Manufacturers (OEMs) to improve parts availability, and a comprehensive fleet rationalisation programme. Critically, the Company has secured materially improved contract values on a going-forward basis, which are expected to contribute significantly to revenue and profitability in the coming periods.

On the financing side, the Company is in an advanced stage of enhancing its working capital credit facilities and is actively arranging External Commercial Borrowings to further strengthen its liquidity position. These measures are expected to ensure that the Company is able to realise its assets and discharge its liabilities in the normal course of business.

Having regard to the above measures, the future business plans, and the detailed cash flow projections reviewed by the Board, these audited financial results for the year ended March 31, 2026 have been prepared on a going concern basis. The financial statements do not include any adjustments that would result from the going concern basis of accounting being inappropriate.

a) (iii) Operating cycle for Current/Non-current classification

All assets and liabilities are classified as current or non-current as per the company's normal operating cycle and other criteria set out in Schedule III to the Companies Act, 2013. Based on the nature of services rendered to the customers and the time between the deployment of resources and their realisation in cash and cash equivalents, the company has ascertained its operating cycle as 12 months for the purpose of current/non-current classification of assets and liabilities.

b) Historical cost convention

The financial statements have been prepared on a historical cost basis with the exception of certain assets and liabilities that are required to be carried at fair value by Ind AS.

c) Use of estimates and judgements

The preparation of the financial statements in conformity with Ind AS, requires management to make judgements, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets, liabilities, income and expenses. Actual results may differ from these estimates. Estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimates are revised.

The areas involving critical estimates and judgements are:

- i. Determination of the estimated useful lives and residual value of property, plant and equipment and intangible assets.
- ii. Recognition and measurement of defined benefit obligations, key actuarial assumptions.
- iii. Impairment of financial assets
- iv. Recognition of deferred tax assets and deferred tax liabilities
- v. Recognition and measurement of provisions and contingencies, key assumptions about the likelihood and magnitude of an outflow of resources.
- vi. Fair value of financial instruments and applicable discount rate
- vii. Measurement of Right of use asset and Lease liabilities
- viii. Key assumptions used in discounted cash flow projections
- ix. Estimation of provision of maintenance, redelivery and overhaul cost of aircrafts
- x. Estimation of incremental borrowing rate
- xi. Impairment of Property, plant and equipment, Right of Use assets and Intangible assets.
- xii. Determining major engine overhaul cost and heavy maintenance cost as separate component for owned aircrafts.

C. Summary of Material Accounting Policies

a) *Property, plant and equipment*

i) *Recognition and measurement*

Property, Plant and Equipment are stated at cost of acquisition, including any attributable cost for bringing the asset to its working condition for its intended use, less accumulated depreciation and impairment losses, if any.

The cost of Property, Plant and Equipment comprises its purchase price, including import duties and non-refundable taxes or levies and any directly attributable cost of bringing the asset to the location and in working condition for its intended use; any trade discounts and rebates are deducted in arriving at the purchase price.

Property, Plant and Equipment not ready for the intended use on the date of Balance Sheet are disclosed as "Capital work-in-progress".

ii) *Subsequent expenditure*

Subsequent expenditure is capitalised only if it is probable that the future economic benefits associated with the expenditure will flow to the company and cost of the item can be measured reliably.

iii) *Depreciation*

Depreciation for the year is recognised in the Statement of Profit and Loss.

Depreciation on Property, Plant and Equipment over the useful lives of assets as prescribed under Schedule II of the Act which in management's opinion reflects the estimated useful economic lives of Property, Plant and Equipment. The estimated useful life of items of property, plant and equipment is mentioned below:

* Leasehold improvements in the nature of Administrative building are amortised over the primary lease period or the useful life of the assets, whichever is shorter.

Major components of helicopters which require replacement at regular intervals are identified and depreciated separately over their respective estimated remaining useful life. Accordingly, overhaul costs of engines and gear boxes are depreciated over 5,000 hours and 4,000 hours respectively, being their estimated useful life. Items such as Inventory spares are classified as Property, Plant and Equipment when they meet the recognition criteria as set out in Ind AS 16 and depreciated over 2,500 hours to 20,000 hours.

Depreciation for the year is recognised in the statement of profit and loss.

Derecognition

An item of property, plant and equipment and any significant part initially recognised is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Gains or losses arising from de-recognition of property, plant and equipment are measured as the difference between the net disposal proceeds and the carrying amount of the asset and are recognized in the statement of profit and loss when the asset is derecognized.

The residual values, useful life and method of depreciation is reviewed by the management at each financial year-end and revised, if appropriate. In case of a revision, the unamortised depreciable amount is changed over the revised remaining useful life.

b) Intangible assets**i) Recognition and measurement**

Intangible assets (computer software) are recognised at cost of purchase including directly incidental related to purchase and installation cost and are carried at costs less accumulated amortisation and impairment losses, if any.

ii) Subsequent cost

Subsequent costs are capitalised only when it increases the future economic benefits from the specific asset to which it relates. All other expenditure on intangible assets is recognised in the Statement of Profit and Loss, as incurred.

iii) Derecognition

An intangible asset is derecognised on disposal or when no future economic benefits are expected from its use. Gain or loss arising from derecognition of an intangible asset is measured as the difference between the net disposal proceeds and the carrying amount of the intangible assets and is recognised in the Statement of Profit and Loss.

iv) Amortisation

The cost of intangible assets is amortised over their estimated useful lives of three years using the straight-line method. Amortisation is calculated on a pro-rata basis for assets purchased/ disposed during the period.

c) Impairment of asset

Assets are reviewed at each reporting date to determine if there is any indication of impairment. For assets in respect of which any such indication exists, the asset's recoverable amount is estimated. An impairment loss is recognised if the carrying amount of an asset exceeds its recoverable amount.

Impairment losses are recognised in the Statement of Profit and Loss. If at the balance sheet date there is an indication that a previously assessed impairment loss no longer exists or has decreased, the assets is estimated. For assets other than goodwill, the impairment loss is reversed to the extent that the asset's carrying amount does not exceed the carrying amount that would have been determined, net of depreciation or amortisation, if no impairment loss had been recognised. Such a reversal is recognised in the Statement of Profit and Loss; however, in the case of revalued assets, the reversal is credited directly to revaluation surplus except to the extent that an impairment loss on the same revalued asset was previously recognised as an expense in the Statement of Profit and Loss.

d) Helicopter Maintenance expenditure

Aircraft repairs and maintenance includes additional accrual, beyond supplementary rentals, for the estimated future costs of engine maintenance checks. These accruals are based on past trends for costs incurred on such events, future expected utilization of engine, condition of the engine and expected maintenance interval and are recorded over the period of the next expected maintenance visit.

Aircraft maintenance covered by third party maintenance agreements, wherein the cost is charged to the statement of profit and loss at a contractual rate per hour in accordance with the terms of the agreements. The Company recognises aircraft repair and maintenance cost (other than major inspection costs) in the statement of profit and loss on accrued basis.

e) Other expenses

Expenses are accounted for on the accrual basis and provisions are made for all known losses and liabilities.

f) Inventories

Inventories comprising of consumables and spares supplies (other than those which meet the criteria of property, plant and equipment) , are valued at lower of cost and net realisable value (NRV). Cost of inventory comprises of all cost of purchase after deducting discount and other incidental cost incurred in bringing the inventories to their present location and condition. Cost are assigned to inventory on the First In First Out basis.

Net realisable value is the estimated selling price in the ordinary course of business less estimated cost of completion and selling expenses.

NRV for stores and spares used in rendering of services are not written down below cost except in cases where the price of such materials have declined and it is estimated that the cost of rendering of services will exceed their selling price.

Obsolete inventories are adequately provided for, wherever considered necessary.

g) Cash and cash equivalents

Cash comprises cash on hand and demand deposits with banks. Cash equivalents are short term deposits with an original maturity of three months or less, which are subject to an insignificant risk of changes in value.

h) Revenue recognition

Service income and reimbursement of expenses is recognised as and when services are rendered

in accordance with the terms of the specific contracts, net of all contractual deductions. Revenue is recognised net of all taxes and levies. Unbilled revenue included in 'other current financial assets' represents services rendered for which billing is pending at the end of the reporting period.

i) Other income

Interest income is recognized on a time proportion basis taking into account the amount outstanding and the rate applicable.

j) Leases

The Company assesses whether a contract is or contains a lease at the inception of a contract. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration. To assess whether a contract conveys the right to control the use of an identified asset, the Company assesses whether (i) the contract involves the use of identified asset; (ii) the Company has substantially all of the economic benefits from the use of the asset through the period of lease and (iii) the Company has right to direct the use of the asset.

As a lessee

The Company accounts for each lease component within the contract as a lease separately from non-lease components of the contract and allocates the consideration in the contract to each lease component on the basis of the relative stand-alone prices.

The Company recognizes a right-of-use asset and a lease liability at the lease commencement date. The right-of-use asset is initially measured at cost, which comprises of initial amount of the lease liability adjusted for any lease payments made at or before the commencement date, plus any initial direct costs incurred and an estimate of costs to dismantle and remove the underlying asset or to restore the site on which it is located, less any lease incentives received.

Certain lease arrangements include the option to extend or terminate the lease before the end of the contract end date. The right-of-use assets and lease liabilities include these options when it is reasonably certain that the option will be exercised.

The right-of-use asset is subsequently depreciated using the straight-line method from the commencement date to the earlier of the end of the useful life of the right-of-use asset or the end of the lease term. The estimated useful lives of right-of-use assets are determined on

the same basis as those of property, plant and equipment. In addition, the right-of-use asset is periodically reduced by impairment losses, if any, and adjusted for certain re-measurements of the lease liability.

The lease liability is initially measured at the present value of the lease payments that are not paid at the commencement date, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, the Company's incremental borrowing rate. Generally, the Company uses its incremental borrowing rate as the discount rate.

The Company determines its incremental borrowing rate by obtaining interest rates from various external financing sources and makes certain adjustments to reflect the terms of the lease and type of the asset leased.

Lease payments included in the measurement of the lease liability comprise the following:

- fixed payments, including in-substance fixed payments; and
- lease payments in an optional renewal period if the Company is reasonably certain to exercise an extension option

The lease liability is subsequently remeasured by increasing the carrying amount to reflect interest on the lease liability, reducing the carrying amount to reflect the lease payments made and remeasuring the carrying amount to reflect any reassessment or lease modifications or to reflect revised in-substance fixed lease payments.

Lease liability is further bifurcated into current and non-current portion; the right of use asset have been separately presented in the balance sheet and lease payments have been classified as financing activities in the statement of cash flow.

Short term leases and leases of low value assets

The Company has elected not to recognise right-of-use assets and lease liabilities for short term leases that have a lease term of less than or equal to 12 months with no purchase option and leases of low value assets. The Company recognises the lease payments associated with these leases as an expense in statement of profit and loss over the lease term. The related cash flows are classified as operating activities in the statement of cash flow.

Sale and leaseback transactions

The right-of-use asset arising from leaseback transaction which is retained by the company is initially measured at cost, which comprises of initial amount of the lease liability adjusted

for any lease payments made at or before the commencement date, plus any initial direct costs incurred and an estimate of costs to dismantle and remove the underlying asset or to restore the site on which it is located, less any lease incentives received.

Where sale proceeds received are judged to reflect the asset's fair value, any gain or loss arising on disposal is recognised in the Statement of Profit and Loss, to the extent that it relates to the rights that have been transferred. Gains and losses that relate to the rights that have been retained are included in the carrying amount of the right of use assets recognised at commencement of the lease. Where sale proceeds received are not at the asset's fair value, any below market terms are recognised as a prepayment of lease payments, and above market terms are recognised as additional financing provided by the lessor.

As a lessor

At inception or on modification of a contract that contains a lease component, the Company allocates the consideration in the contract to each lease component on the basis of their relative stand-alone selling prices. If the arrangement contains lease and non-lease components, then the Company applies Ind AS 115 to allocate the consideration in the contract.

When the Company acts as a lessor, it determines at lease inception whether each lease is a finance lease or an operating lease.

To classify each lease, the Company makes an overall assessment of whether the lease transfers substantially all of the risks and rewards incidental to ownership of the underlying asset. If this is the case, then the lease is a finance lease; if not, then it is an operating lease. As a part of this assessment, the Company considers certain indicators such as whether the lease is for the major part of the economic life of the asset.

Where the Company is an intermediate lessor, it accounts for its interests in the head lease and the sub-lease separately. It assesses the lease classification of a sub-lease with reference to the right-of-use asset arising from the head lease, not with reference to the underlying asset. If a head lease is a short-term lease to which the Company applies the exemption described above, then it classifies the sub-lease as an operating lease.

All assets given on finance lease are shown as lease receivables at an amount equal to net investment in the lease. Principal component of the lease receipts is adjusted against outstanding receivables and interest income is accounted by applying the interest rate implicit in the lease to the net investment.

The Company applies the derecognition and impairment to the net investments in the lease. The Company further regularly reviews estimated unguaranteed residual values used in calculating the gross investment in the lease.

Lease income from operating leases where the Company is a lessor is recognized in income on a straight-line basis over the lease term.

k) Foreign currency transactions and balances

i. Functional and presentation currency

Items included in the financial statements of the Company are measured using the currency of the primary economic environment in which the entity operates ('the functional currency'). The financial statements are presented in Indian Rupee (INR), which is the Company's functional and presentation currency.

ii. Foreign currency Transactions and Balances

Transactions denominated in foreign currency are recorded at the exchange rates prevailing on the last date of preceding month. Exchange differences arising on foreign exchange transactions settled during the year are recognised in the Statement of Profit and Loss for the year.

Monetary assets and liabilities denominated in foreign currencies as at the balance sheet date are translated into Indian rupees at the closing exchange rates on that date. The resultant exchange differences are recognised in the Statement of Profit and Loss except that exchange differences pertaining to long term foreign currency monetary items outstanding as on the transition date that are related to acquisition of depreciable assets are adjusted in the carrying amount of the related Property, Plant and Equipment and Right of Use assets.

Gains / (losses) arising on translation of certain lease liabilities which represents long-term foreign currency monetary loans taken before March 31, 2017 and used for acquisition of depreciable right of use assets, are adjusted in the cost of respective item of right of use assets. The treatment will continue till the repayment of the long-term foreign currency monetary loans

A foreign currency monetary item is classified as long term if the asset or liability is expressed in a foreign currency and it has an original maturity of one year or more.

I) Financial Instruments:

A financial instrument is any contract that gives rise to a financial asset of one entity and a financial liability or equity instrument of another entity. Financial instruments also include derivative contracts such as embedded derivatives.

I. Financial Assets:**Classification**

On initial recognition the Company classifies financial assets as subsequently measured at amortised cost, fair value through other comprehensive income or fair value through profit or loss on the basis of its business model for managing the financial assets and the contractual cash flow characteristics of the financial asset.

Initial recognition and measurement

All financial assets (not measured subsequently at fair value through profit or loss) are recognised initially at fair value plus transaction costs that are attributable to the acquisition of the financial asset. Purchases or sales of financial assets that require delivery of assets within a time frame established by regulation or convention in the market place (regular way trades) are recognised on the trade date, i.e., the date that the Company commits to purchase or sell the asset.

Subsequent measurement**i) Financial assets at amortised cost**

A 'financial asset' is measured at the amortised cost if both the following conditions are met:

- i) the asset is held within a business model whose objective is to hold assets for collecting contractual cash flows, and
- ii) contractual terms of the asset give rise on specified dates to cash flows that are solely payments of principal and interest (SPPI) on the principal amount outstanding.

After initial measurement, such financial assets are subsequently measured at amortised cost using the Effective Interest Rate (EIR) method. Amortised cost is calculated by taking into account any discount or premium and fees or costs that are an integral part of the EIR. The EIR amortisation is included in interest income in the Statement of Profit and Loss. The losses arising

from impairment are recognised in the Statement of Profit and Loss. This category generally applies to trade and other receivables.

ii) Financial assets at FVTPL:

Financial assets included within the Fair Value Through Profit and Loss (FVTPL) are measured at fair value with all changes recognised in the Statement of Profit and Loss.

iii) Financial assets at Fair Value through Other Comprehensive Income (OCI):

The assets are subsequently measured at fair value. Net gains or losses are recognised in other comprehensive income.

Derecognition

A financial asset (or, where applicable, a part of a financial asset or part of a company of similar financial assets) is primarily derecognised (i.e. removed from the Company's financial statements) when:

- The contractual rights to receive cash flows from the financial asset have expired, or
- It transfers the financial asset and the transfer qualifies for derecognition.

The company transfers a financial asset if either;

- i) It transfers its contractual rights to receive cashflows of the financial asset, or
- ii) It retains the contractual right to receive the cashflows of the financial asset, but assumes a contractual obligation to pay the cash flows to one or more recipients in an arrangement.

When the Company has transferred its rights to receive cash flows from an asset, it evaluates if and to what extent it has retained the risks and rewards of ownership. When it has neither transferred nor retained substantially all of the risks and rewards of the asset, nor transferred control of the asset, the Company, continues to recognise the transferred asset to the extent of the Company's continuing involvement. In that case, the Company also recognises an associated liability. The transferred

asset and the associated liability are measured on a basis that reflects the rights and obligations that the Company has retained. Continuing involvement that takes the form of a guarantee over the transferred asset is measured at the lower of the original carrying amount of the asset and the maximum amount of consideration that the Company could be required to repay.

Impairment of financial assets (Other than fair value)

In accordance with Ind AS 109, the Company applies Expected Credit Loss (ECL) model for measurement and recognition of impairment loss on the following financial assets and credit risk exposure:

- i) Financial assets that are debt instruments, and are measured at amortised cost e.g., loans, debt securities, deposits, and bank balance.
- ii) Trade receivables.

The Company recognises impairment loss allowance on trade receivables which do not contain a significant financing component.

The changes (incremental or reversal) in loss allowance computed using ECL model, are recognised as an impairment gain or loss in the Statement of Profit and Loss.

II. Financial Liabilities

Classification

The Company classifies all financial liabilities as subsequently measured at amortised cost, except for financial liabilities measured at fair value through profit or loss. Such liabilities, including derivatives that are liabilities, shall be subsequently measured at fair value with changes in fair value being recognised in the Statement of Profit and Loss.

Initial recognition and measurement

Financial liabilities are classified, at initial recognition, as financial liabilities at fair value through profit or loss or at amortised cost (loans and borrowings, and payables), or as derivatives designated as hedging instrument in an effective hedge, as appropriate.

All financial liabilities are recognised initially at fair value and, in the case of loans and borrowings and payables, net of directly attributable transaction costs.

The Company's financial liabilities include trade and other payables, loans and borrowings including bank overdrafts and derivative financial instruments.

Financial liabilities at fair value through profit or loss

Financial liabilities at fair value through profit or loss include financial liabilities held for trading and financial liabilities designated upon initial recognition as at fair value through profit or loss. Financial liabilities are classified as held for trading if they are incurred for the purpose of repurchasing in the near term.

Financial liabilities designated upon initial recognition at fair value through profit or loss are designated at the initial date of recognition, and only if the criterias in Ind AS 109 are satisfied. For liabilities designated as Fair value through Profit and loss (FVTPL), fair value gains/ losses attributable to changes in own credit risk are recognized in Other Comprehensive income (OCI).

Loans and borrowings

After initial recognition, interest-bearing loans and borrowings are subsequently measured at amortised cost using the EIR method. Gains and losses are recognised in Statement of Profit and Loss when the liabilities are derecognised.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the EIR. The EIR amortisation is included as finance costs in the Statement of Profit and Loss.

This category generally applies to interest-bearing loans and borrowings.

All other borrowing costs are charged to the Statement of Profit and Loss for the period for which they are incurred.

Derecognition

A financial liability is derecognised when the obligation under the liability is discharged or cancelled or expires. When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as the derecognition of the original liability and the recognition of a new liability. The difference in the respective carrying amounts is recognised in the Statement of Profit and Loss.

Embedded Derivatives

If the hybrid contract contains a host that is a financial asset within the scope Ind-AS 109, the Company does not separate embedded derivatives. Rather, it applies the classification requirements contained in Ind AS 109 to the entire hybrid contract. Derivatives embedded in all other host contracts are accounted for as separate derivatives and recorded at fair value if their economic characteristics and risks are not closely related to those of the host contracts and the host contracts are not held for trading or designated at fair value through profit or loss. These embedded derivatives are measured at fair value with changes in fair value recognised in profit or loss, unless designated as effective hedging instruments. Reassessment only occurs if there is either a change in the terms of the contract that significantly modifies the cash flows.

Offsetting of financial instruments

Financial assets and financial liabilities are offset and the net amount is reported in the balance sheet if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, to realise the assets and settle the liabilities simultaneously.

Hedge Accounting

The Company enters into USD and EUR sales contracts with Indian customers to hedge its risks associated with foreign currency fluctuations in USD and EUR on certain lease payments and payments on account of external commercial borrowings and maintenance expenses.

The Company treats such arrangements as embedded derivatives. The Company designates such contracts in a cash flow hedging relationship by applying the hedge accounting principles. These contracts are stated at fair value at each reporting date and a derivative asset or liability is recognised on the balance sheet.

Changes in the fair value of these contracts are designated and effective as cash flow hedges for the changes only on account of spot element of foreign exchange fluctuation risk on lease payments and external commercial borrowings for foreign currency fluctuations in USD and EUR respectively.

Further, the balance portion of the fair value of these embedded derivative contracts,

if not already designated in a hedge, are designated as a cash flow hedge of highly probable future cash flows on account of maintenance expenditure in respective foreign currencies.

The fair value of such hedged embedded derivative contracts are recognised directly in Other Comprehensive Income ('OCI') and accumulated in "Effective portion of cash flow hedges" under Other equity, net of applicable deferred income taxes. Any ineffective portion of changes in the fair value of the derivative is recognised immediately in profit or loss. The fair value of the remaining portion of the separated embedded derivative contracts that is not designated as hedges is recognised immediately in the Statement of Profit and Loss.

Amounts accumulated in the "Effective portion of cash flow hedges" are reclassified to the Statement of Profit and Loss to the extent of the spot revaluation of the lease liability and borrowings at the end of every reporting period end and in case of the hedge against future expenses, amounts are reclassified in the same period during which the forecasted transaction affects Statement of Profit and Loss.

Hedge accounting is discontinued when the hedging instrument expires or is sold, terminated, or exercised, or no longer qualifies for hedge accounting. When hedge accounting for cash flow hedges is discontinued, the amount that has been accumulated in the hedging reserve remains in equity and it is reclassified to the statement of profit and loss in the same period or periods as the hedged expected future cash flows affect the statement profit and loss. If the hedged future cash flows are no longer expected to occur, then the amounts that have been accumulated in other equity are immediately reclassified to profit or loss.

m) Fair value measurement

'Fair value' is the price that would be received on selling of an asset or paid to transfer a liability, in an orderly transaction between market participants at the measurement date in the principal market or, in its absence, the most advantageous market to which the Company has access to at that date.

A number of the Company's accounting policies and disclosures, require the measurement of fair values, for both financial and non-financial assets and liabilities. When one is available, the Company measures the fair value of an

instrument using the quoted price in an active market for that instrument. A market is regarded as active if transactions for the asset or liability take place with sufficient frequency and volume to provide pricing information on an ongoing basis. If there is no quoted price in an active market, then the Company uses valuation techniques that maximise the use of relevant observable inputs and minimise the use of unobservable inputs. The chosen valuation technique incorporates all of the factors that market participants would take into account in pricing a transaction.

The best evidence of the fair value of a financial instrument on initial recognition is normally the transaction price (i.e. the fair value of the consideration given or received).

If the inputs used to measure the fair value of an asset or a liability fall into different levels of the fair value hierarchy, then the fair value measurement is categorised in its entirety in the same level of the fair value hierarchy as the lowest level input that is significant to the entire measurement.

The Company recognizes transfers between levels of the fair value hierarchy at the end of the reporting period during which the change has occurred.

Fair values are categorised into different levels in a fair value hierarchy based on the inputs used in the valuation techniques as follows:

- Level 1: quoted prices (unadjusted) in active markets for identical assets or liabilities that the entity can assess at the measurement date..
- Level 2: inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly (i.e. as prices) or indirectly (i.e. derived from prices).
- Level 3: inputs for the asset or liability that are not based on observable market data (i.e. unobservable inputs).

n) Employee benefit

i. Short-term employee benefits

The short-term employee benefits expected to be paid in exchange for the services rendered by employees is recognised during the period when the employee renders the service. These benefits are expected to occur within twelve months after the end of the reporting period in which the employee renders the related services.

ii. Post-employment benefits

Defined Contribution Plan

Employee benefits in the form of Provident Fund, Employee State Insurance Fund contributions are considered as defined contribution plans and the contributions are charged to the Statement of Profit and Loss for the period when the contributions to the respective funds are due.

Defined Benefit Plan

The Company's net obligation in respect of gratuity is calculated by estimating the amount of future benefit that employees have earned in return for their service in the current and prior periods. That benefit is discounted to determine its present value, and the fair value of any plan assets is deducted. The present value of the obligation under such defined benefit plan is determined based on actuarial valuation by an independent actuary using the Projected Unit Credit Method, which recognizes each period of service as giving rise to additional unit of employee benefit entitlement and measures each unit separately to build up the final obligation. The obligation is measured at the present value of the estimated future cash flows. The discount rates used for determining the present value of the obligation under defined benefit plan are based on the market yields on Government securities as at the Balance Sheet date.

Remeasurement gains and losses arising from experience adjustments and changes in actuarial assumptions are recognised in the Balance Sheet with a corresponding debit or credit to retained earnings through Other Comprehensive Income in the period in which they occur. Remeasurements are not reclassified to profit or loss in subsequent periods

iii. Compensated absences

Provision for compensated absences cost has been made based on actuarial valuation using projected unit credit method by an independent actuary at Balance Sheet date.

The employees are entitled to compensated absences. The employees can carry-forward a portion of the unutilized accrued compensated absence and utilise it in future periods or receive cash compensation at termination of employment for the unutilised accrued compensated absence. The Company records an obligation for

compensated absences in the period in which the employee renders the services that increase this entitlement. The Company measures the expected cost of compensated absence as the additional amount that the Company expects to pay as a result of the unused entitlement that has accumulated at the balance sheet date.

iv. Other long term employee benefits

Provision for Other long term employee benefits are charged to statement of profit and loss determined on actuarial valuation using Projected Unit Credit Method.

Other long term employee benefits shall be payable to an employee after successful completion of specific period. The purpose of this type of incentive is to retain employees on long term basis.

o) Tax Expenses

Tax expense comprises of current tax and deferred tax. It is recognised in the Statement of Profit and Loss except to the extent that it relates to items recognised in other comprehensive income or directly in equity.

Current tax

Current tax is determined as the amount of tax payable or recoverable in respect of taxable income or loss for the year and any adjustment to the tax payable in respect of previous years. It is measured using tax rates that are enacted or substantively enacted at the reporting date.

Current tax assets and liabilities are offset only if there is a legally enforceable right to set off the recognised amounts, and it is intended to realise the asset and set off the liability on a net basis.

Deferred taxes

Deferred tax is recognised in respect of temporary differences between the carrying amounts of assets and liabilities for financial reporting purposes and the amounts used for taxation purposes.

Deferred tax assets are recognised to the extent that it is probable, that future taxable profits will be available against which they can be used. Therefore, in case of a history of recent losses, the Company recognises a deferred tax asset only to the extent it has sufficient taxable temporary differences or there is convincing other evidence that sufficient taxable profit will be available against which such deferred tax asset can be realised.

Unrecognised deferred tax assets are reassessed at each reporting date and recognised to the extent that it has become probable that future taxable profits will be available against which they can be used. Deferred tax is measured at the tax rates that are expected to be applied to deferred tax assets when they are realised or deferred tax liabilities when they are settled, using tax rates enacted or substantively enacted at the reporting date.

Deferred tax assets and liabilities are offset only if there is a legally enforceable right to offset current tax liabilities and current tax assets and the deferred tax assets and deferred tax liabilities relate to income taxes levied by the same tax authority on the Company and intend to settle on net basis.

p) Earnings per share ('EPS')

Basic and diluted earnings per share are computed by dividing the net profit attributable to equity shareholders for the year, by the weighted average number of equity shares outstanding during the year.

q) Provisions, contingent liabilities and contingent assets

Provisions are recognised when the Company has a present legal or constructive obligation as a result of past events, it is probable than not that an outflow of resources embodying economic benefits will be required to settle the obligation and a reliable estimate can be made of the amount of obligation

Provisions are reviewed at each balance sheet date and adjusted to reflect the current best estimate. If it is no longer probable that an outflow of resources would be required to settle the obligation, the provision is reversed.

Contingent liabilities are disclosed when there is a possible obligation arising from past events, the existence of which will be confirmed only by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the Company or a present obligation that arises from past events where it is either not probable that an outflow of resources will be required to settle the obligation or a reliable estimate of the amount cannot be made.

Contingent assets are possible assets that arises from past events and whose existence will be confirmed only by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the company.

Provisions, contingent liabilities and contingent assets are reviewed at each balance sheet

date. Contingent assets and related income are recognised when it is virtually certain that inflow of economic benefit will arise.

s) Exceptional items

Exceptional items refer to items of income or expense within the Statement of Profit and Loss from ordinary activities which are of such size, nature or incidence that their separate disclosure is considered necessary in the financial statements.

t) Segment reporting

Operating segments are reported in a manner consistent with the internal reporting provided to the Chief Operating Decision Maker (CODM). The CODM is considered to be the Board of Directors who is responsible for allocating resources, assessing performance of the operating segments and makes strategic decisions.

u) Recent pronouncements

Ministry of Corporate Affairs ("MCA") notifies new standards or amendments to the existing standards under Companies (Indian Accounting Standards) Rules as issued from time to time.

1. D. Risk management framework

The Company's business activities expose it to a variety of financial risks, namely market risk, credit risk and liquidity risk. Market risk comprises of currency risk and interest rate risk. The Company's primary risk management focus is to minimize potential adverse effects of market risk on its financial performance. The Company's risk management assessment and policies and processes are established to identify and analyze the risks faced by the Company, to set appropriate risk limits and controls, and to monitor such risks and compliance with the same. Risk assessment and management policies and processes are reviewed regularly to reflect changes in market conditions and the Company's activities. The Board of Directors and the Audit Committee is responsible for overseeing the Company's risk assessment and management policies and processes.

i. Credit Risk

Credit risk is the risk of financial loss to the Company if a customer or counterparty to a financial instrument fails to meet its contractual obligations. The company is exposed to credit risk from its operating activities (Trade receivables) and from its financing activities including deposits with banks and financial instruments.

Trade receivables

The Company's exposure to credit risk is influenced mainly by the individual characteristics of each customer. The demographics of the customer, including the default risk of the industry has an influence on credit risk assessment. Credit risk is managed through credit approvals, establishing credit limits and continuously monitoring the creditworthiness of customers to which the Company grants credit terms in the normal course of business.

iii. Market risk

Hedge accounting

The Company is exposed to the risk of foreign currency exchange fluctuation with respect to its foreign lease payments in USD and EUR. To mitigate this risk, the Company as a risk management strategy has hedged the risk in foreign currency exchange fluctuation by entering into Sales Contracts with its local Customers in USD and EUR. These contracts contain an embedded derivative which helps the Company to hedge its risk. The Company has designated the Embedded Derivatives as Cash Flow Hedges to mitigate the risk of foreign currency exposure on its future lease payments. With effect from July 1, 2024, the hedging relationship has been amended to mitigate the risk of foreign currency exposure against future External Commercial Borrowings repayments in USD and highly probable future maintenance, repairs and overhaul ('MRO') expenses in USD and EUR in addition to lease payments. These contracts have a maturity of more than 12 months from the reporting date.

The Company determines the existence of an economic relationship between the hedging instrument and hedged item based on the currency, amount and timing of its forecasted cash flows. Hedge effectiveness is determined at the inception of the hedge relationship, and through periodic prospective effectiveness assessments to ensure that an economic relationship exists between the hedged item and hedging instrument, including whether the hedging instrument is expected to offset changes in cash flows of hedged items.

If the hedge ratio for risk management purposes is no longer optimal but the risk management objective remains unchanged and the hedge continues to qualify for hedge accounting, the hedge relationship will be rebalanced by adjusting either the volume of the hedging instrument or the volume of the hedged item so that the hedge ratio aligns with the ratio used for risk management purposes. Any hedge ineffectiveness is calculated and accounted for in the Statement of Profit and Loss at the time of the hedge relationship rebalancing. The Company offsets a financial asset and a financial liability when it currently has a legally enforceable right to set off the recognised amounts and the Company intends either to settle on a net basis, or to realize the asset and settle the liability simultaneously.

Exceptional items

Exceptional items represent impact on account of New Labour Codes amounting to Rs. (156.39) lakhs

Effective 21 November 2025, The Government of India has consolidated multiple existing labour legislations into a unified framework comprising four Labour Codes (collectively referred to as the 'New Labour Codes'). These legislative changes have revised the definition of wages for the purpose of computation of employee benefits and expanded the scope and eligibility of certain employee related social security benefits.

Based on a detailed assessment carried out by the Company, information currently available and consistent with the FAQs on key accounting implications arising from the New Labour Codes issued by the Institute of Chartered Accountants of India, the Company has evaluated the incremental impact arising from the implementation of the New Labour Codes. Considering the materiality, regulatory driven and non-recurring nature of this impact, the Company has recognised impact of Rs. (156.39) lakhs (consisting of gratuity and compensated absences) as an exceptional item in the financial results for the quarter and year ended 31 March 2026.

Post the balance sheet date, while the Central Government has notified the final Rules on May 8, 2026, the relevant State Rules are yet to be notified. The Company will monitor the developments and update the estimates once the State Rules are notified.
