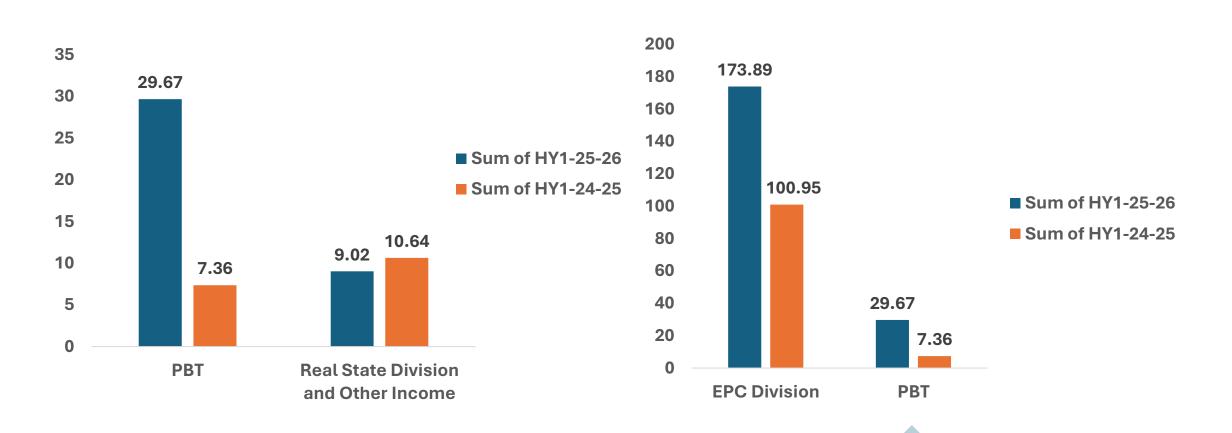

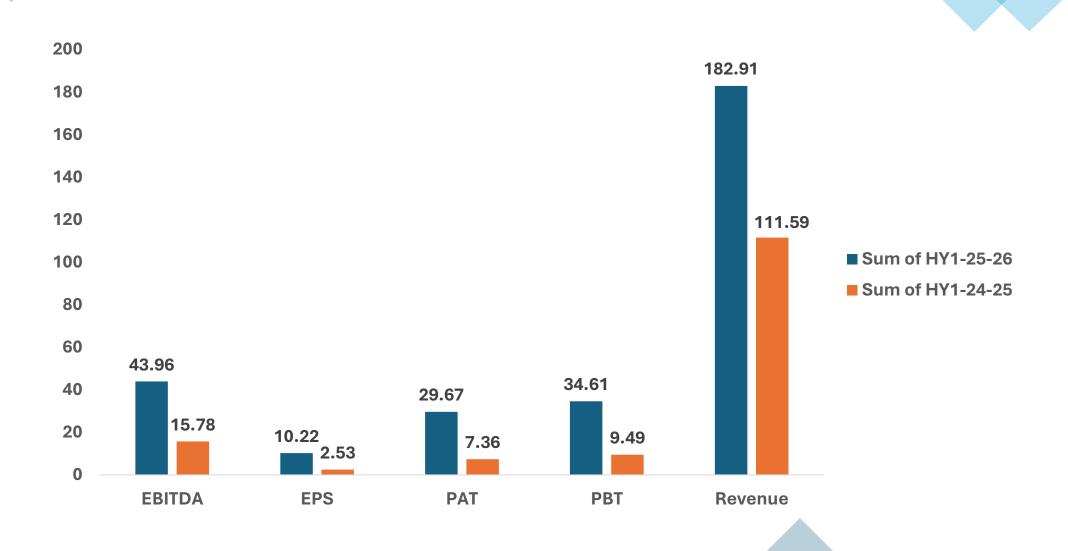

Segmental Revenue and PBT Break-Up



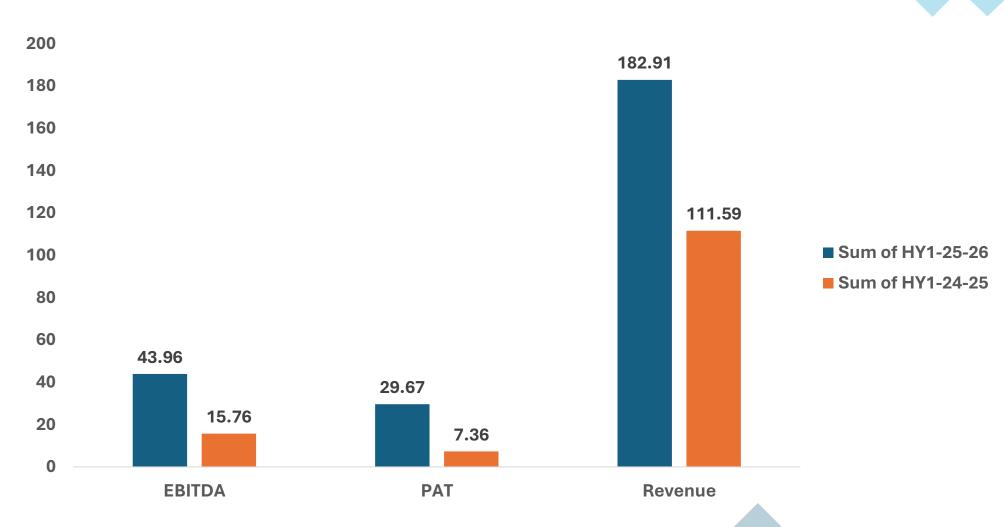
Growth from HY-1 24-25 to HY -1 25-26



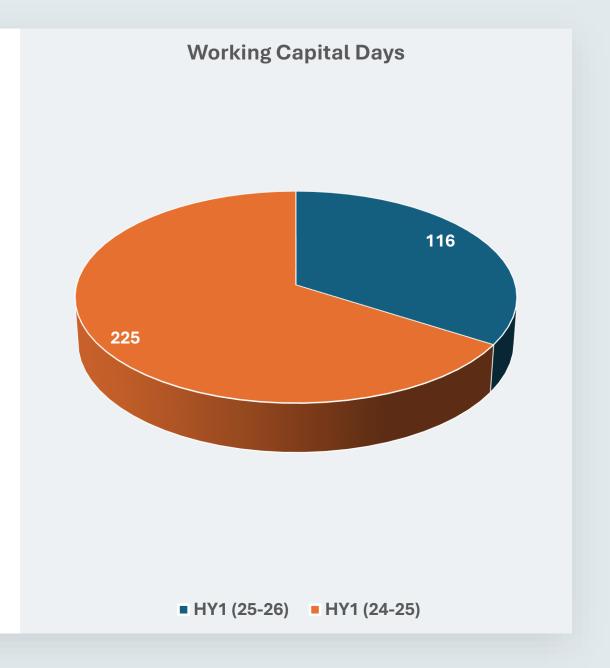

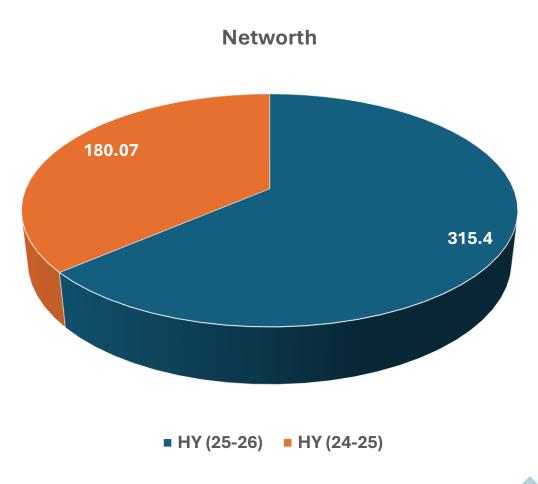




Net Working Capital Days – Standalone FY 2024-25 to FY 2025-26
