### Business Update – Q2 & H1FY25

**Kolkata, October 1, 2024:** Baazar Style Retail Limited (BSRL), reports its Business Update for the Quarter and Half Year ended September 30, 2024.

#### **Key Highlights:**

- Revenue growth of 65% YoY to Rs 3,109 Mn in Q2FY25, and 41% YoY to Rs 5,863 Mn in H1FY25.
- Sales Per Square Feet (PSF) stood at **Rs 708 per month** in Q2FY25
- Same Store Sales Growth (SSSG) stood at 41% in Q2FY25 and 21% in H1FY25
- Total No. of Stores stood at **184 stores** and the Total Rental area stood at **16.66 Lakh Sq Ft**, as of September 30, 2024. The Company opened a total of **21** new stores and closed **3** stores during the Q2FY25.
