

Industry and its Growth



Industry – **Infrastructure**

- India's Infrastructure forms an integral part of the country's economic ecosystem. There has been a significant shift in the industry that is leading to the development of world-class facilities across the country in the areas of roads, waterways, railways, airports, and ports, among others.
- The infrastructure sector has become the biggest focus area for the Government of India. India's GDP is expected to grow by 8%over the next three fiscal years.
- As per the Interim Budget 2023-24, a capital outlay of Rs. 2.55 lakh crore (US\$ 30.72 billion) has been made for the Railways, an increase of 5.8% over the previous year.
- India has the fifth-largest metro network in the world and will soon overtake Japan and South Korea to become the third-largest network.
- The US\$ 13 trillion national master plan for infrastructure, Gati Shakti, has been a forerunner to bring about systemic and effective reforms in the sector, and has already shown a significant headway.



In Interim Budget 2024-25, capital investment outlay for infrastructure has been increased by 111% to Rs. 11.11 lakh crore (US\$ 133.86 billion), which would be 3.4 %of GDP.

Industry and its Growth



Industry –Infrastructure Surveyor

- Capital Expenditure Growth: With a 37% increase in the current fiscal year, capital
 expenditures (CAPEX) are on the rise, which bolsters ongoing infrastructure
 development and fits with 2027 goals for India's economic growth to become a US\$ 5
 trillion economy.
- **Logistics Market Expansion :** India's logistics market is estimated to be US\$ 317.26 billion in 2024 and is expected to reach US\$ 484.43 billion by 2029, growing at a CAGR of 8.8%.
- **Robust Infrastructure CAPEX Projections:** From 2021 to 2026, infrastructure capital expenditure is projected to grow at a CAGR of 11.4%, driven by water, transport, and urban infrastructure.
- Multimodal Logistics Infrastructure Boost: A network of 35 Multimodal Logistics Parks is
 planned to be developed as part of Bharatmala Pariyojana, with a total investment of
 about Rs. 46,000 crore (US\$ 5.5 billion)
- **National Infrastructure Pipeline (NIP):** NIP currently consists of 9,142 projects across 34 sub-sectors, with nearly half in transportation and 3,906 in roads and bridges.
