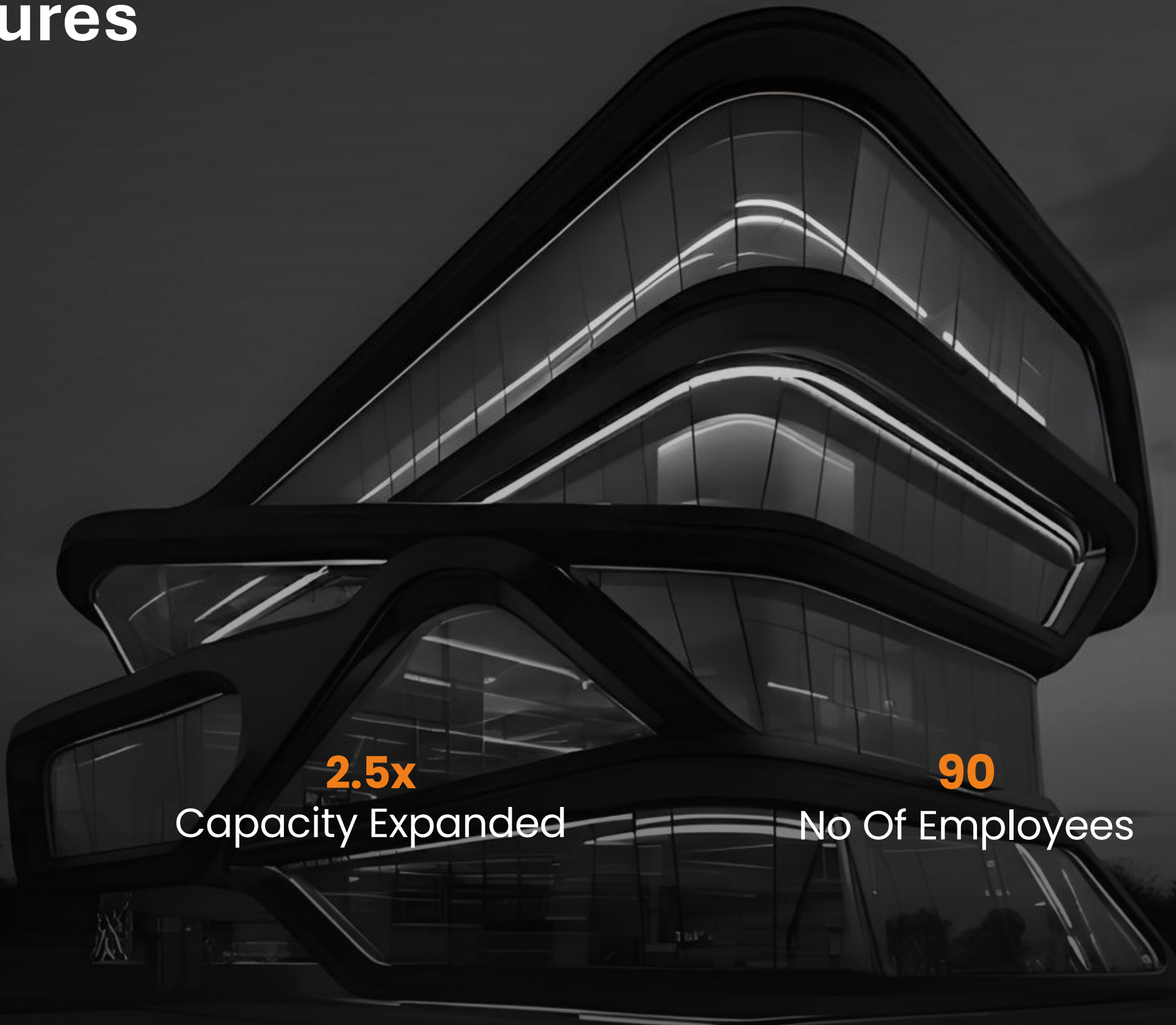


Established in 2012, **HRS Aluglaze Limited** is a Gujarat-based façade engineering and aluminium systems manufacturer company offering complete design-to-installation solutions for doors, windows, curtain walls, glazing, cladding, louvers, partitions, and UPVC systems. With fully integrated capabilities across design, engineering, fabrication, and installation.

The company operates a modern manufacturing facility at **Bavla, Ahmedabad**, spread across **11,176 sq. m.**, equipped with advanced CNC automation, in-house testing units. Its backward integration capabilities, supported by a dedicated **powder-coating unit** with a fully automated seven-tank coating system and a **422 KW rooftop solar plant** further improves cost efficiency and sustainability. To support future growth, HRS is expanding through the development of an **additional 13,714 sq. m.** of adjoining land, which will enhance production capabilities, improve execution timelines, and enable entry into new regions.

- Our Company implemented a green energy initiative by setting up a solar power plant at its newly established factory. This move aimed at promoting environmental sustainability, reducing dependency on conventional energy sources, and optimizing long-term operational efficiency through renewable energy utilization.
