Production commenced at the Alloy Wheel plant at AURIC Bidkin in Oct 2025, with 3.6 Mn wheels/annum capacity fully booked.

New plant being constructed to meet growing Aluminium Forging production.



Dual channel ABS under customer validation.

Setting up additional capacities for ABS in view of recent draft regulations. Also setting up additional Disc Brake capacities in Waluj and Chennai.



Commercial Production of our Adler technology Assist and Slip APTC Clutch commenced in Q2FY26.

Received first proprietary orders for PV-Foundation Brakes and Driveshaft.

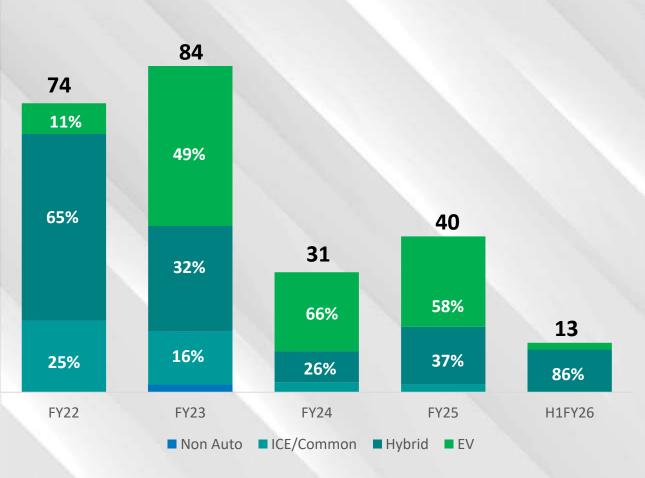

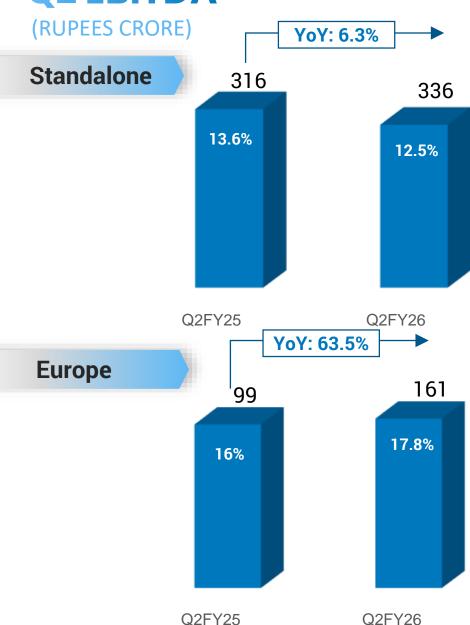

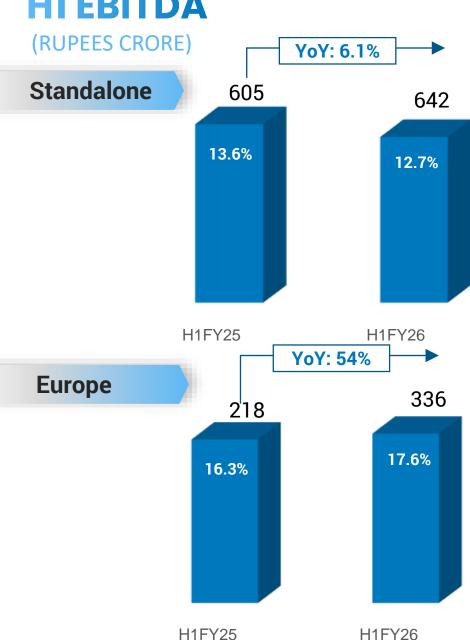

## H1 EBITDA (RUPEES CRORE)



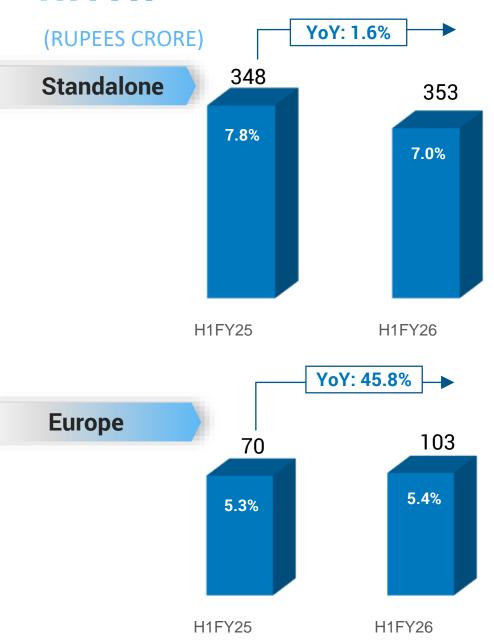


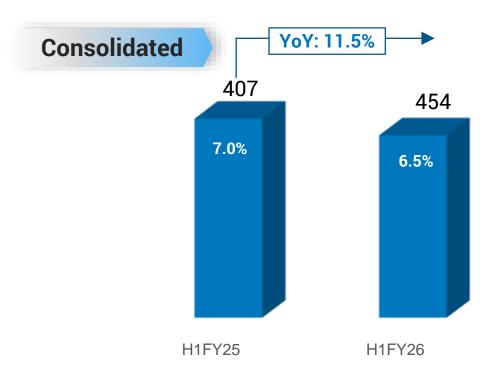

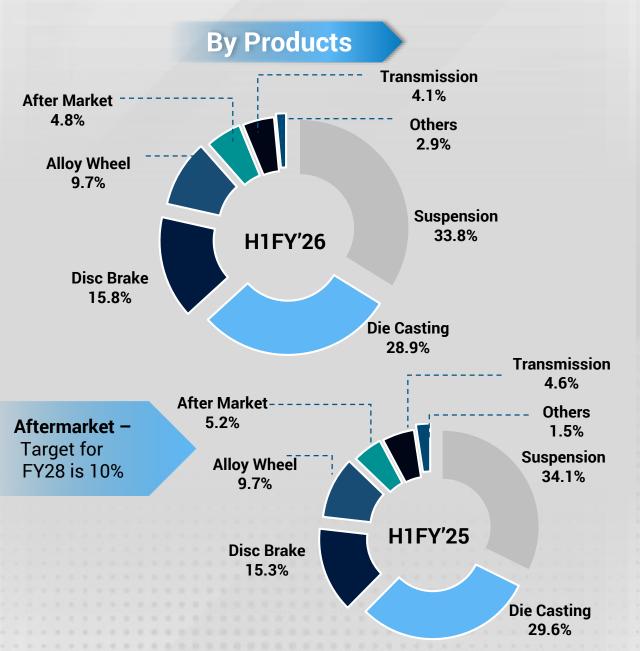




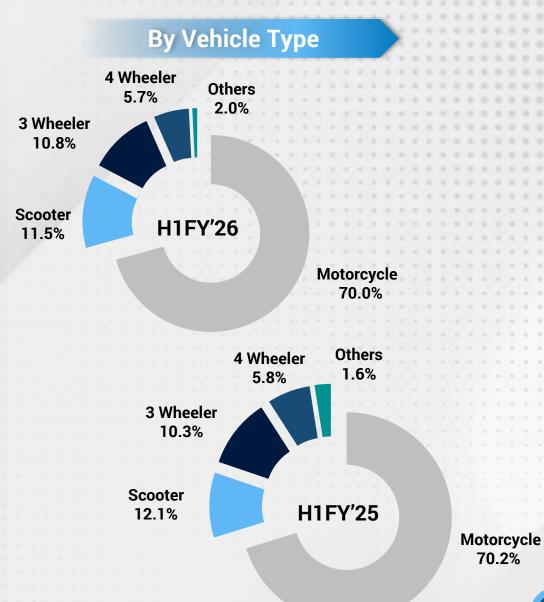




### STANDALONE TOTAL INCOME
