- Operating Revenue was Rs 2,794 million vs Rs 2,576 million, up by 8.5%
- Total Income was Rs 2,897 million vs Rs 2,604 million, up by 11.2%

Profit:

- Adjusted EBITDA stood at Rs 465 million vs Rs 436 million in Q3FY25
- Adjusted EBITDA margin of 16.6% in Q3FY26 as against 16.9% in Q3FY25
- PAT including OCI was at Rs 234 million with a margin at 8.1% vs Rs 193 million with a margin at 7.4% in Q3FY25
- PAT including OCI and excluding labour code was at Rs 401 million with a margin at 13.9% in Q3FY26 as compared to Rs 193 million with a margin at 7.4% in Q3FY25

- Adjusted EBITDA stood at Rs 1,279 million vs Rs 1,257 million in 9MFY25
- Adjusted EBITDA margin of 15.6% in 9MFY26 as against 16.3% in 9MFY25
- PAT including OCI was at Rs 912 million with a margin at 10.7% vs Rs 787 million with a margin at 10.1% in 9MFY25
