



Mrs. Bectors reports Q4 FY25 performance

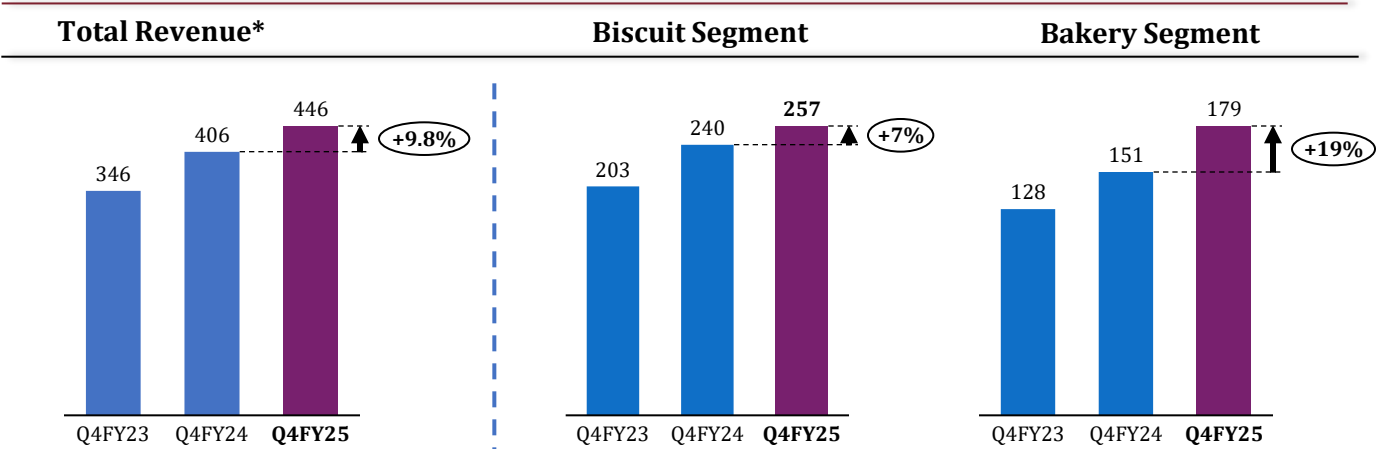

Operational/Financial Highlights for Q4 FY25

- ✓ **Biscuit segment revenue** stood at Rs. 257 crores against Rs. 240 crores in Q4 FY24, registering a growth of 7% compared to Q4 FY24 including domestic and export biscuit segment. The Biscuit segment has grown by 26% compared to Q4 FY23
- ✓ **Bakery segment revenue** stood at Rs. 179 crores against Rs. 151 crores in Q4 FY24, registering a growth of 19% compared to Q4 FY24 including retail bakery and institutional segment. The Bakery segment has grown by 40% compared to Q4 FY23



Commenting on the results, Mr. Anoop Bector, Managing Director said,

I'm pleased to share that our company maintained its steady growth trajectory for the full year and quarter, delivering 15.4% annual growth and 9.8% year-on-year revenue increase for the quarter. Amidst continued urban slowdown, further exacerbated by higher end prices to consumers due to sharp input costs being passed on has impacted the growth momentum. However, with the easing of interest rates and taxation relief provided by the Hon'ble Finance Minister in the budget, we are optimistic of gaining back momentum.

Additionally, we have commenced operations at our new, state-of-the-art production facility in Dhar, Madhya Pradesh, with an installed capacity of 21,000 metric tons per annum. This facility significantly strengthens our manufacturing footprint, enabling us to better serve diverse regions across the country.
