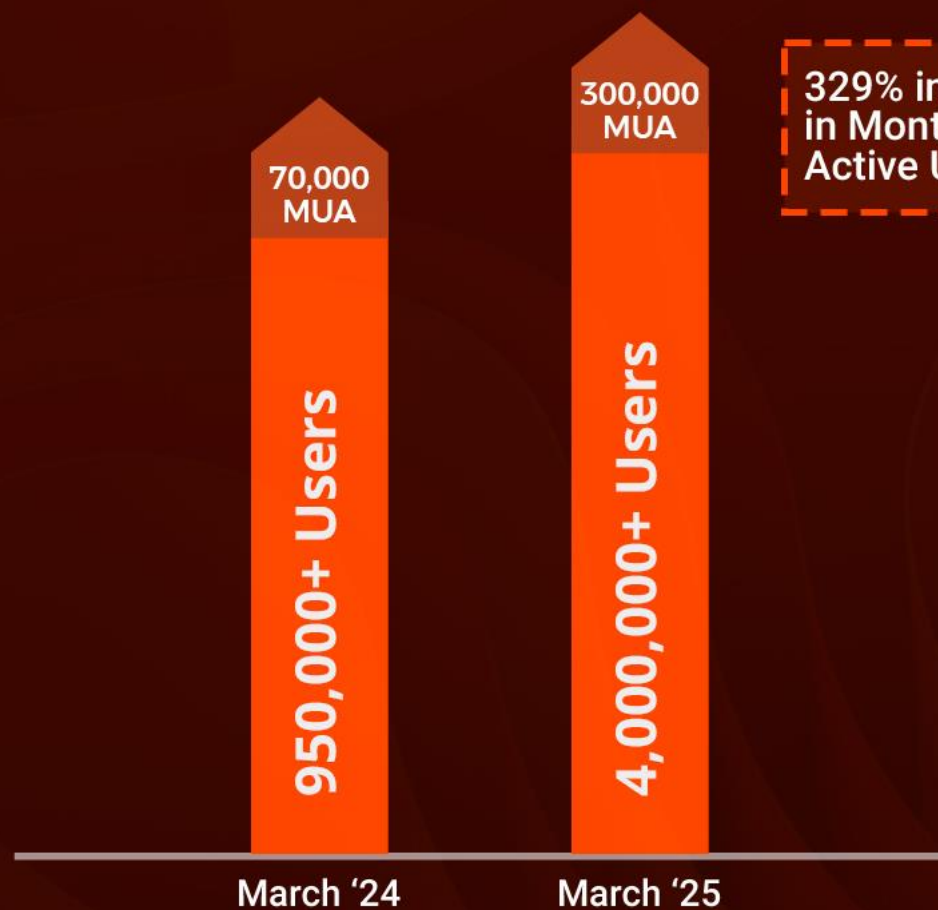

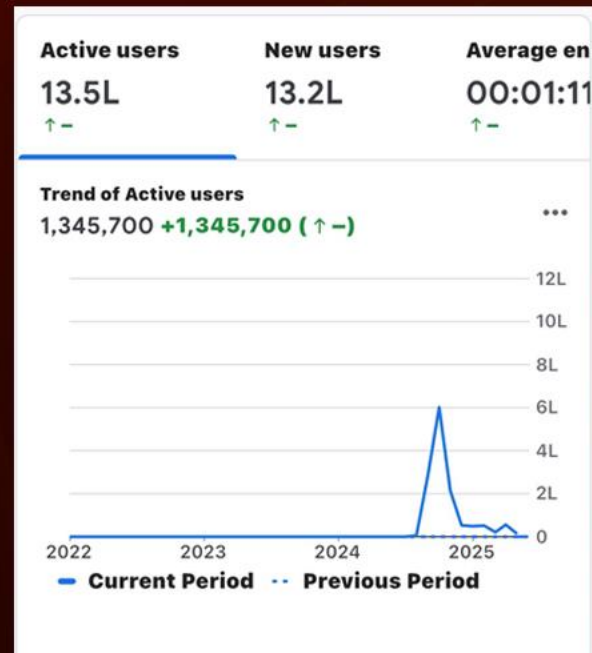

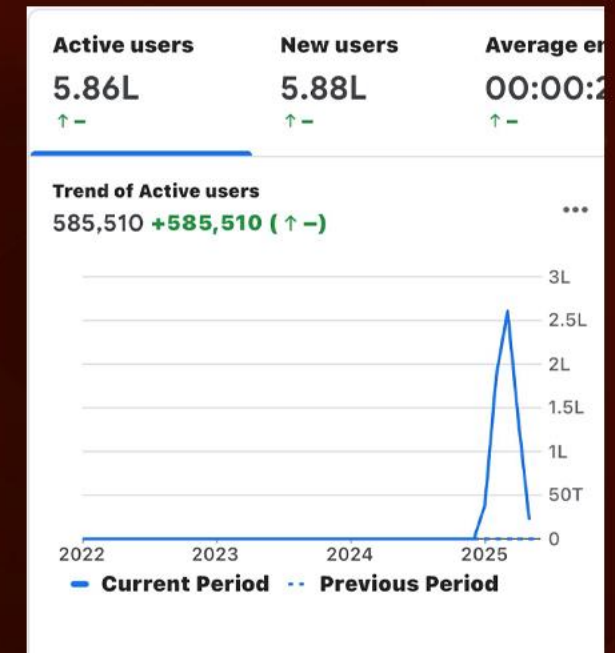

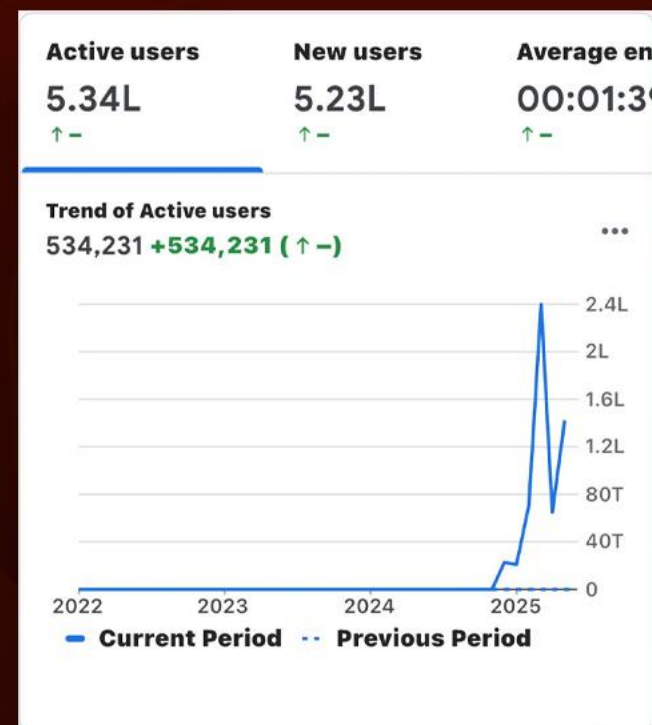

Why Now?

- Traditional financial infrastructure (Visa, Mastercard, banks) was not built for the internet.
- Bitcoin & Blockchain introduced the first digital-native financial infrastructure, built on **Distributed Ledger Technology (DLT)**.
- The digital asset market cap has crossed **\$3 Trillion**, with 10-20 major L1 blockchains (Solana, Ethereum, etc.) leading adoption.



Global Transition to On-Chain Infrastructure

- Institutions like **BlackRock, Fidelity, Franklin Templeton** are moving money market funds on-chain.
- Governments (e.g., Dubai) are exploring **on-chain real estate tokenization**.
- Shift from **"Trust-based systems"** to **"Truth-based systems"** — enabled by blockchain transparency.



Our Role: Infrastructure for the Next 100x

- Public blockchains must scale **100x to support this transition**.
- Validators are essential to **maintain decentralization** and process this explosion in transactions.
- String Metaverse is **investing \$50M to build validation nodes** across Solana, Ethereum, Sui, Base And more top L1 chains.

Strategic Implementation

- Deploying cloud data centers optimized for validator operations.
- Processing **millions of daily transactions** across major chains.
- Building a robust backbone for **decentralized finance, real-world asset tokenization, and digital fund flows**.



Integrated with HFT for Settlement

- We are also connecting our **High-Frequency Trading Engine** to all major centralized and **decentralized exchanges**: Binance, OKX, Deribit, Radium, Uniswap and more.
- Enables real-time transaction **processing, settlement, and liquidity** provisioning for digital assets and tokenized RWAs.

- Blockchain is becoming the **truth layer of the global financial system**.
- **Validators + HFT Infrastructure** = Core foundation of digital asset transformation.

ROAD AHEAD FOR STRING METaverse

HIGH-FREQUENCY TRADING – POWERING LIQUIDITY IN WEB3

String Metaverse operates a Low Latency HFT System that connects to both Centralized (CEXs) and Decentralized Exchanges (DEXs) to enable real-time, automated trading strategies with minimal delay and maximum efficiency.

Key Capabilities:

- Low-Latency Infrastructure: Millisecond-level trading systems to capture arbitrage and market-making opportunities.
- Cross-Exchange Connectivity: Integrated with major CEXs and DEXs across multiple chains to maximize reach and volume.
- Validator-Driven Execution: Trades are processed using our own blockchain validation nodes to ensure faster settlement and higher control.

HFT for Real World Asset (RWA) Liquidity:

- Instant Price Discovery: Our trading AI Agents will provide live bid-ask spreads on tokenized RWAs, improving market efficiency.
- On-Chain Liquidity Pools: Deploying algorithmic liquidity across AMMs and DEXs for tokenized real estate, commodities, and other RWAs.
- Yield Opportunities: Generate yield through continuous market-making and swap facilitation on tokenized RWA platforms.
