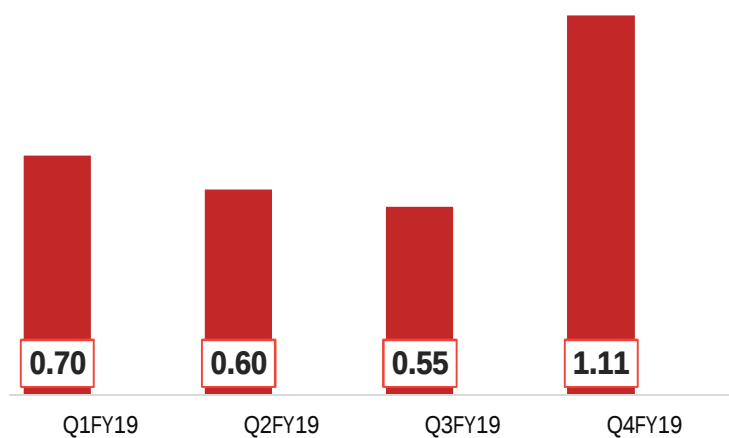

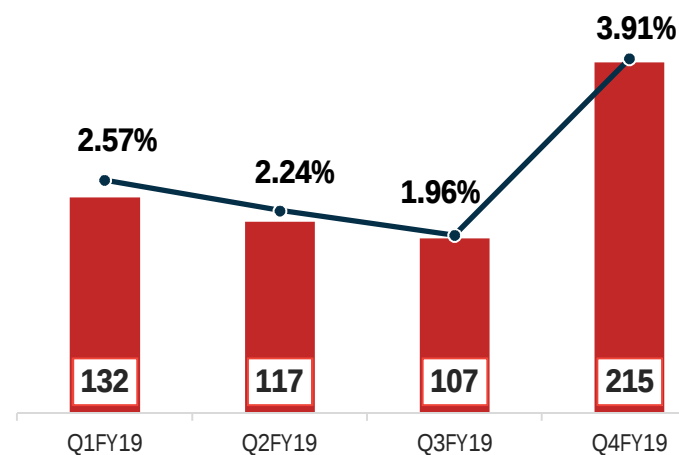

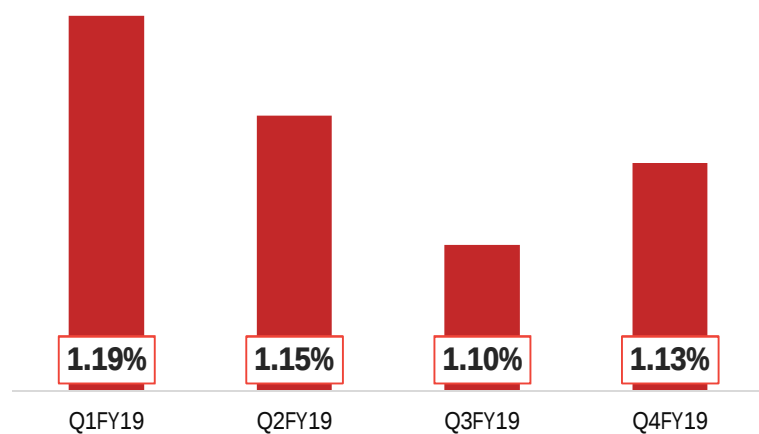
Basic EPS (in ₹ per share)



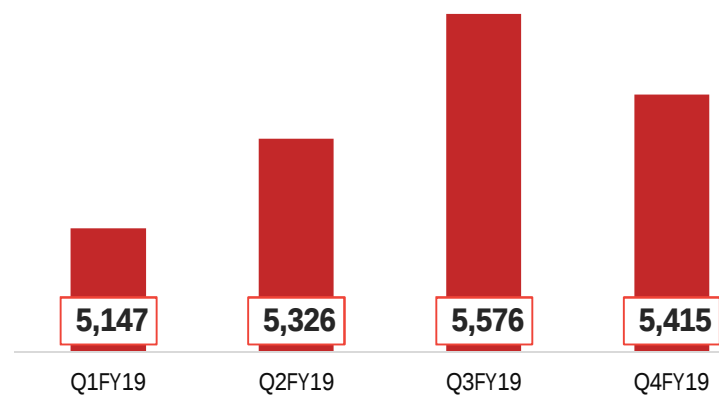
RoA & PAT (in ₹ Lacs)



GNPA (in ₹ Lacs)



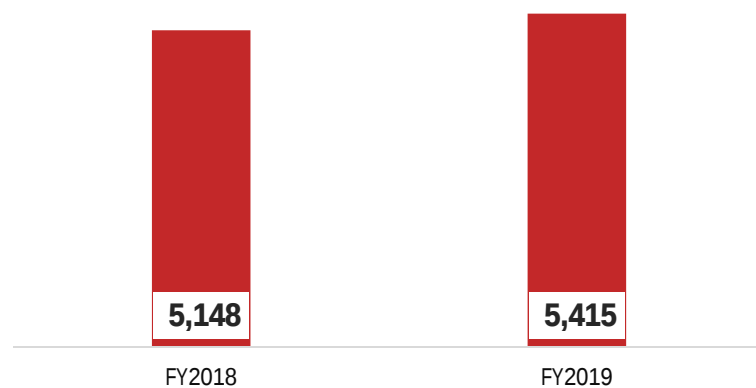
AUM (in ₹ Lacs)



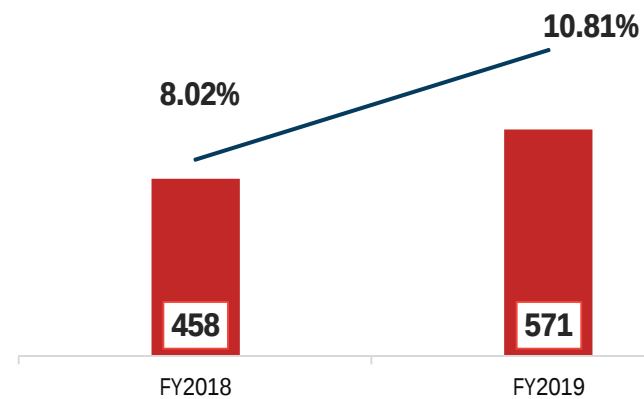

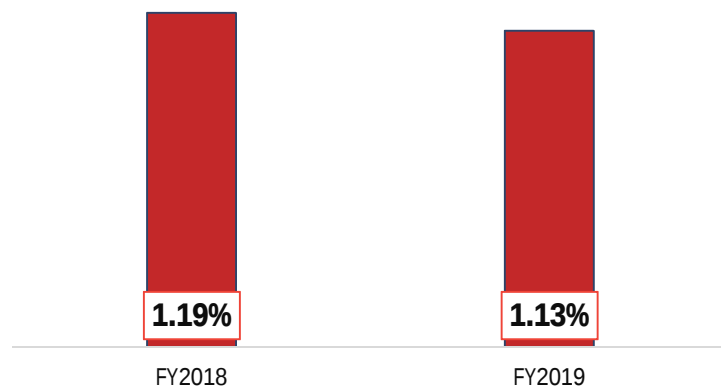

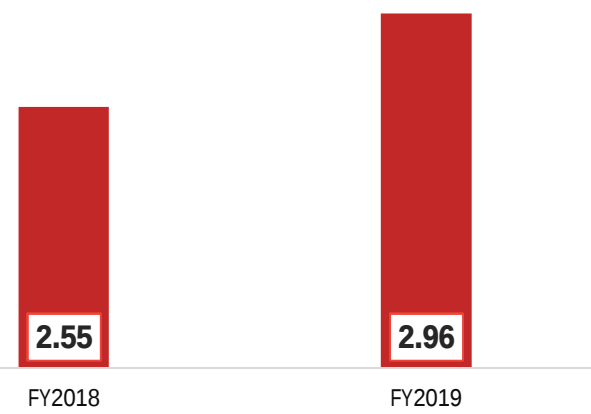

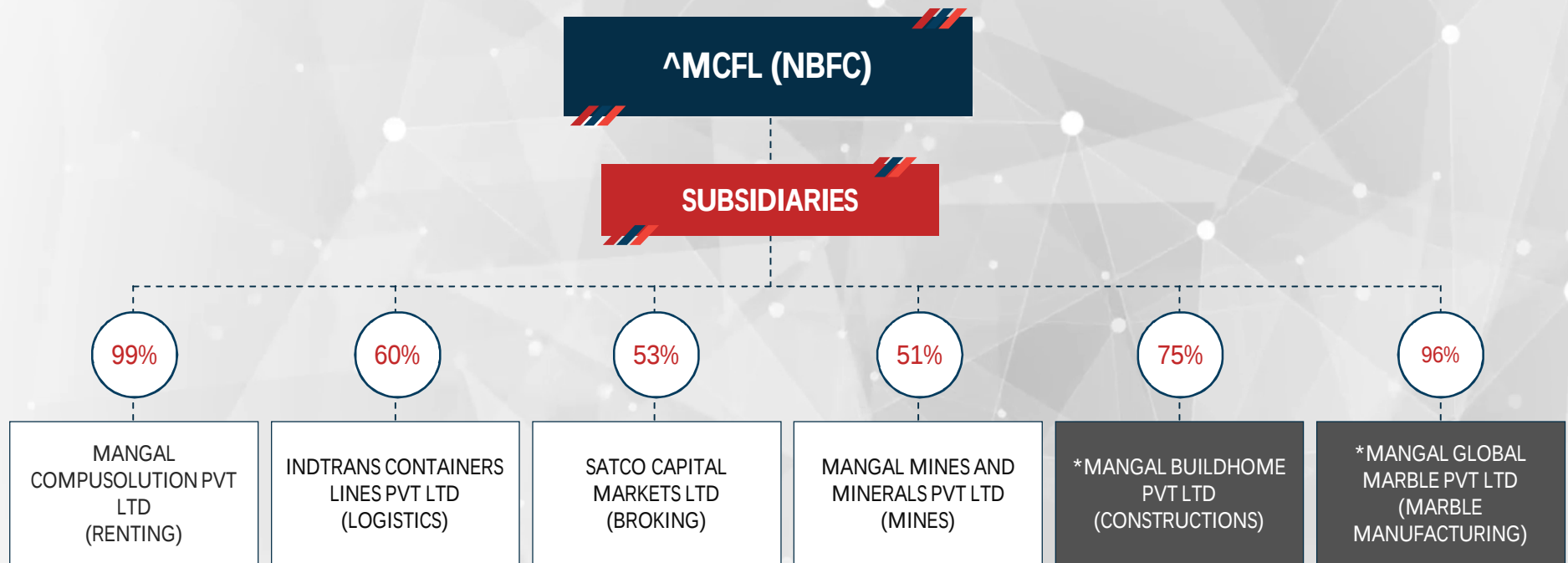

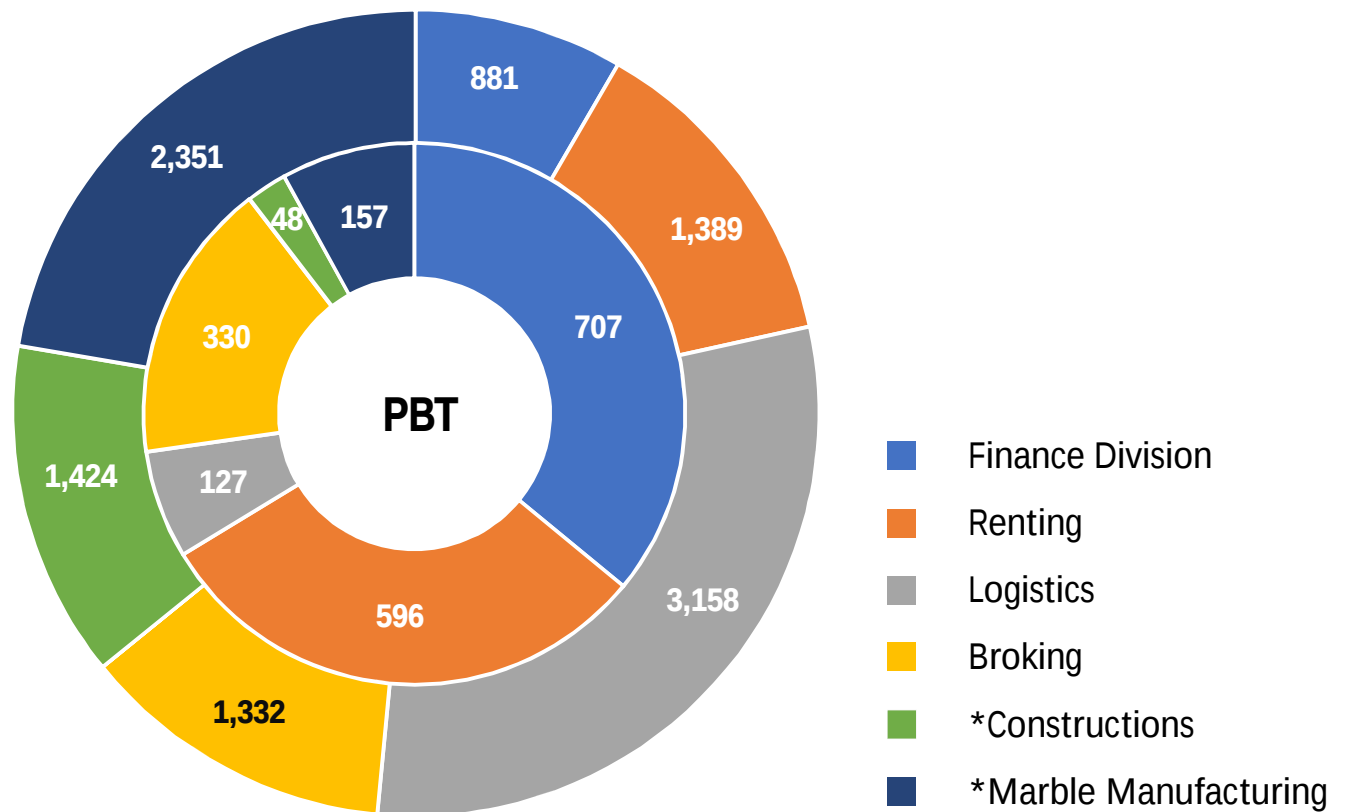
