## Aayush Wellness Reports Strong Q1 FY26 Performance with Robust Growth in Revenue and Profitability

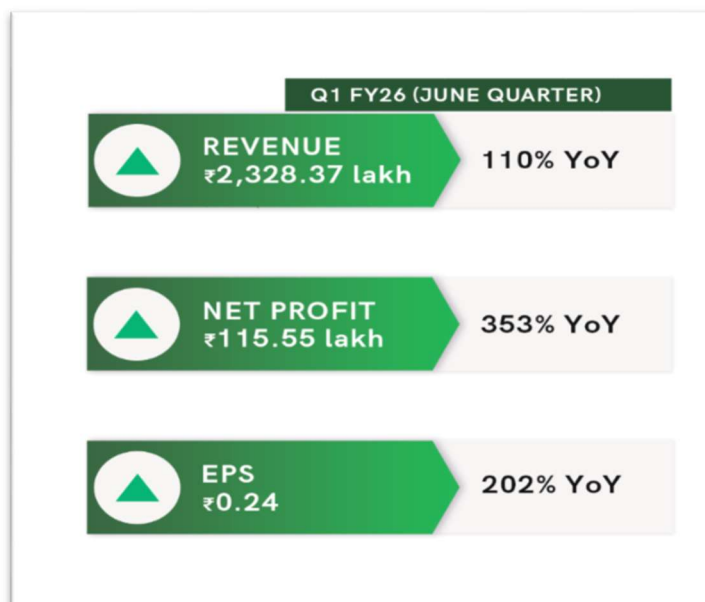
### Key Highlights – Q1 FY26 (June Quarter)
