Near term outlook is uncertain

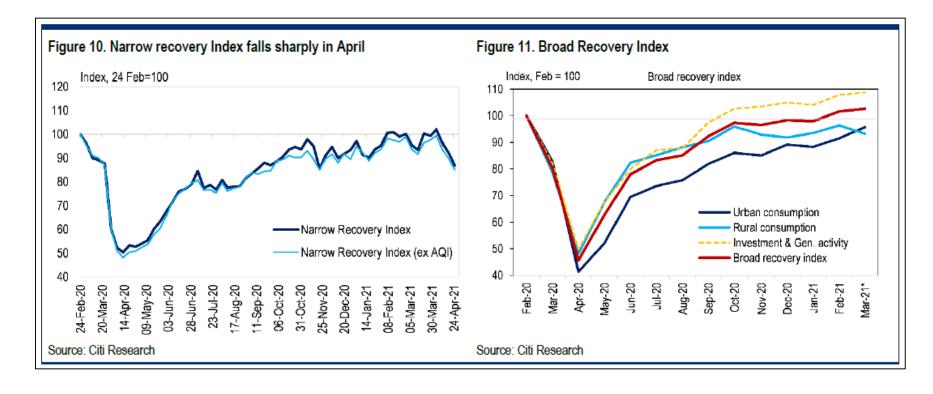
- Second Covid wave with significant rise in active cases across India
- Different forms of lockdown, stringent in states where we are present
- Will impact overall economic activity in Q2

Medium term to long term outlook remains positive

- Growth supportive Union budget with push on infra spends & Privatization
- Uneven rebound representing K shaped recovery; should favour GNO
- Lead Indicators strengthened in last few months: Record GST collection in April 2021, Growing toll collections
- Rebound in Private investments with improved pace of execution in Q1 21
- Higher auto sales with YoY growth since Sep 20
- PMI consolidating at higher level since Oct 20

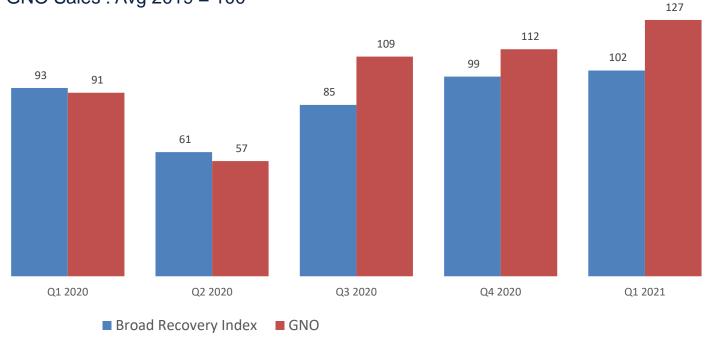




BROAD RECOVERY INDEX Vs GNO QUARTERLY SALES

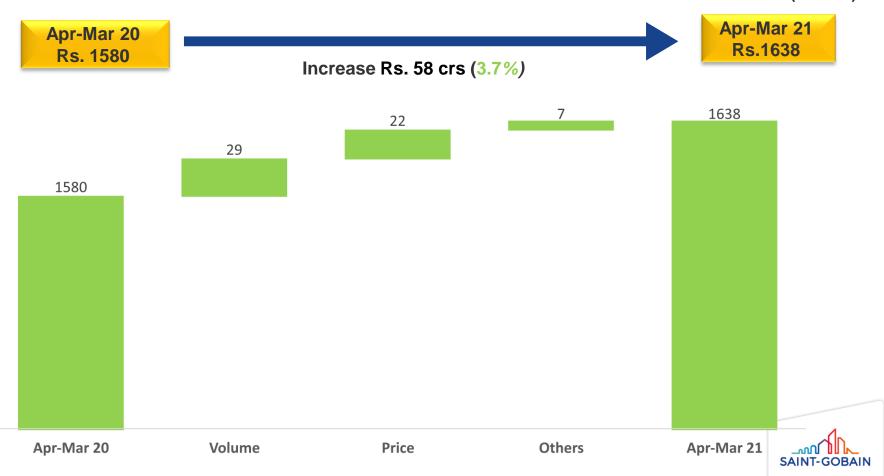


Revenue from Operations Bridge

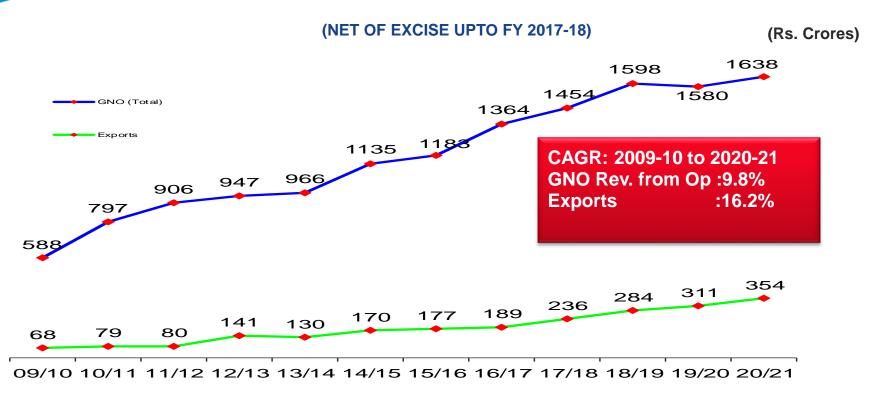

GNO: REVENUE FROM OPERATIONS & EXPORTS

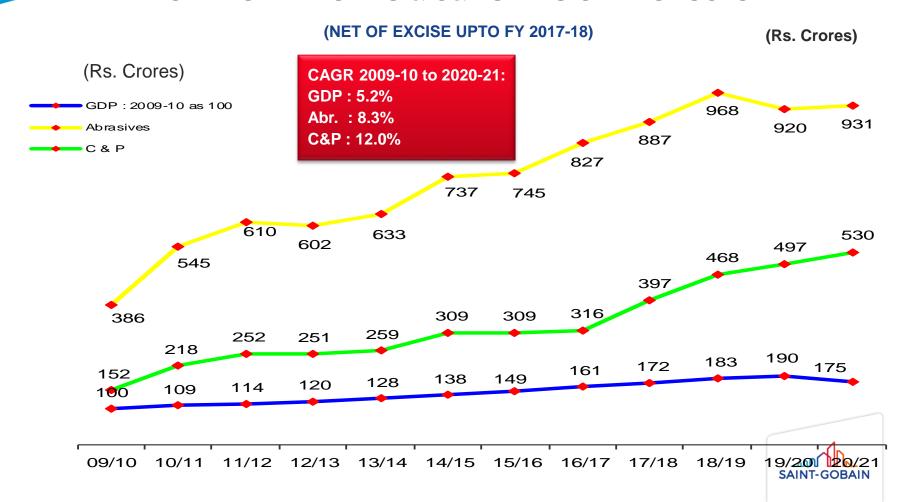

GDP VS ABRASIVES & C&P SALES OF PRODUCTS

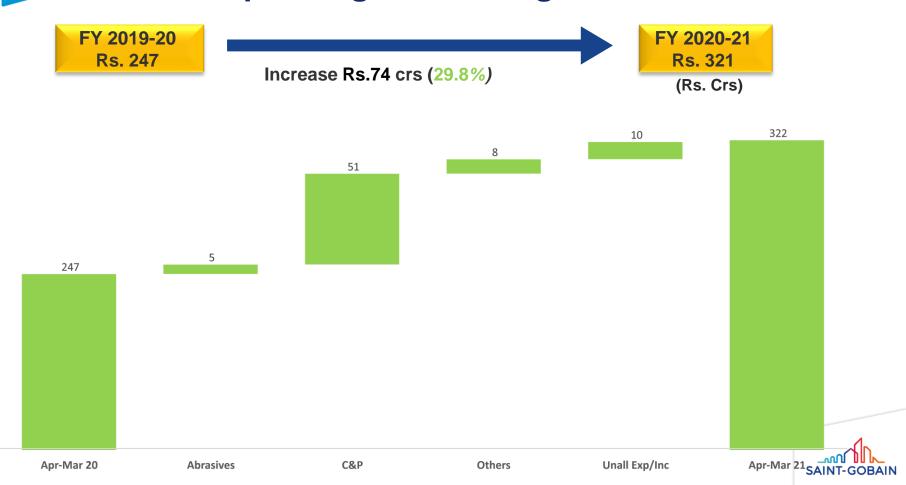


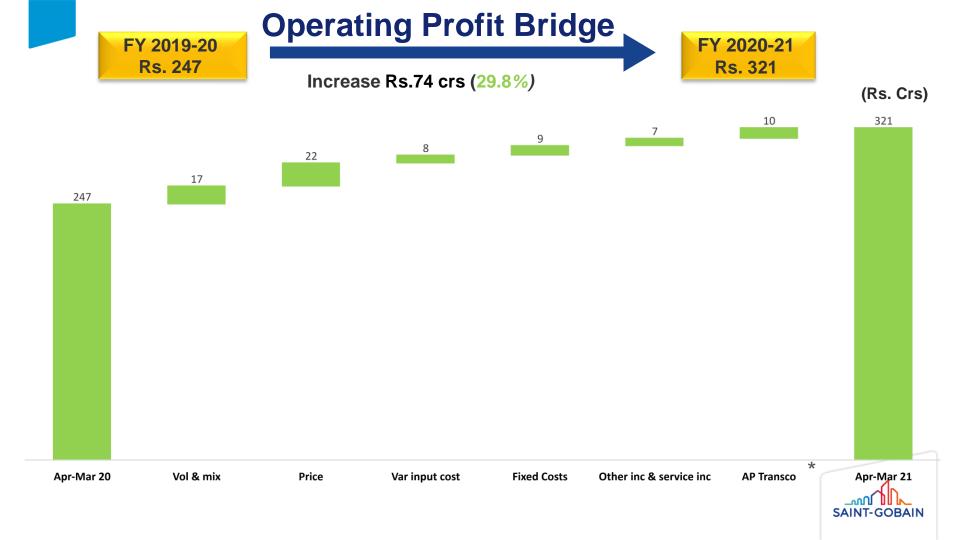

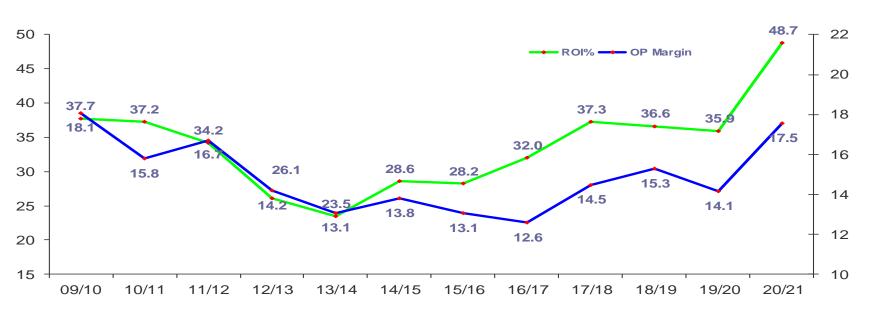

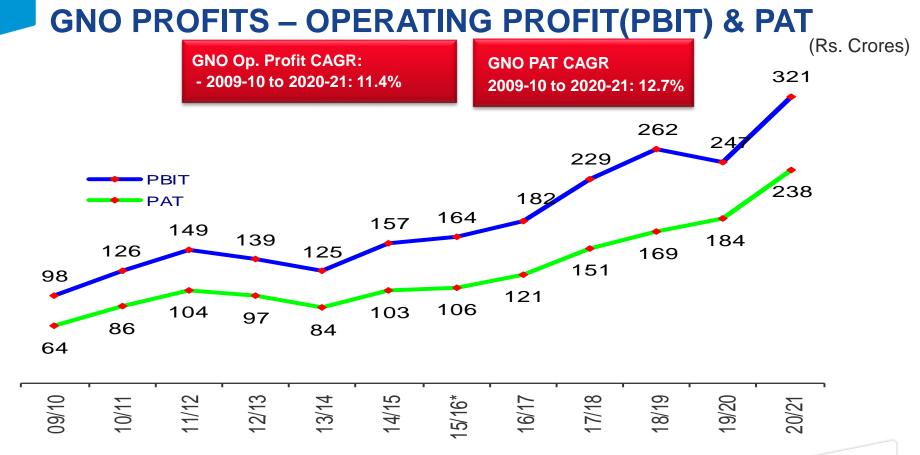


GNO PROFITABILITY – ROI & OP MARGIN (%)

ROI OP Margin





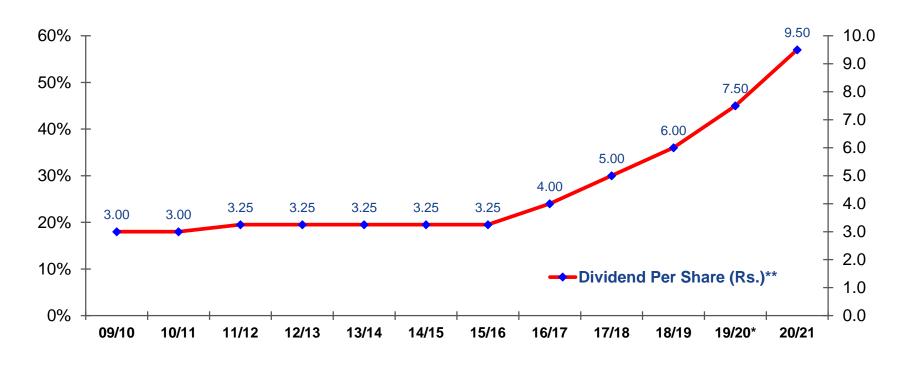
